

Melrose East Crime Prevention District Crime Report March 23 – March 30, 2014

On March 23, 2014, from 1700 to 2100 hours, Deputies patrolled the ME CPD. Deputies conducted traffic enforcement making seven stops of drivers for various violations. Deputies also checked the following businesses and apartments: Degas Manor, Bon Carre at Donmoor, Saia Park (BREC), Donmoor Food Mart, Monet Townhouses, Betty Arms, Redwood Apts, Monet Manor, Sandpiper, Court of Three Sisters, Pinewood, Monet Place, Johnson Grocery, Donmoor Village, Titian Arms, Amy Lynn, Bon Carre at Titian, Georgetown Apts., Johns Grocery, The Plaza, Melrose I, and Melrose II Peppermill. Deputies also continued an ongoing narcotics investigation by developing further information obtained from a confidential informant.

On March 24, 2014, from 1800 to 2200 hours, Deputies patrolled the ME CPD. Deputies conducted surveillance of a suspected drug sales location making five targeted stops of vehicles leaving the location in order to identify violators and confirm illegal activity. Deputies also checked the BREC park, Donmoor Food Mart, Johnson's Grocery, Chevron, Texas Club, Herff Jones, and Carrollton Self Storage.

On March 25, 2014, from 1600 to 2000 hours, Deputies patrolled the ME CPD. Deputies conducted surveillance of a suspected drug sales location making targeted stops of vehicles leaving the location.

On March 26, 2014, from 2030 to 0030 hours, Deputies patrolled the ME CPD. Deputies conducted traffic enforcement making 11 stops of drivers for various violations. Deputies further contacted 14 individuals in the ME area. Deputies also checked the following locations: Dali Place, Al's Flooring, Dollar Plus, Simply Sevante, John's Grocery, Victory Landscape, Eddie Brown Roofing, and Touch of Beauty Salon.

On March 27, 2014, from 2015 to 0015 hours, Deputies patrolled the ME CPD. Deputies conducted traffic enforcement making four stops of drivers for various violations. Deputies further contacted seven individuals in the ME area. Deputies also checked the following locations: Georgetown Apts., Melrose I, Bon Carre at Harry, Melrose II, Widsor Apts., Cabana Gardens, Shiloh, Degas Manor, Donmoor Village, Victory Landscaping, Johnsons Grocery, and Eddie Brown Roofing.

On March 28, 2014, from 0930 to 1330 hours, Deputies patrolled the ME CPD. Deputies conducted traffic enforcement making five stops of drivers for various violations resulting in the issuance of five citations. Deputies also conducted foot patrols of Dali Place, Monet Townhouses, and Cabana Gardens. Deputies further checked the Bon Carre Business Center, COX, Tim's Food Mart, Chevron, and B&G Food Mart.

On March 29, 2014, from 1700 to 2100 hours, Deputies patrolled the ME CPD. Deputies conducted further surveillance of a suspected drug sales location. During enforcement, Deputies were contacted in reference to a missing juvenile. Deputies located the juvenile, and the juvenile was returned to their parents. Deputies also checked the Donmoor Food Mart, Subway, and the BREC park.

On March 30, 2014, from 1730 to 2130 hours, Deputies patrolled the ME CPD. Deputies conducted traffic enforcement stopping eight drivers for various violations. One stop and investigation led to the arrest of an individual who was found to be in possession of marijuana. Deputies also checked the following locations: Villa Ashley, John's Grocery, Georgetown Apts, Beau Chateau, Cabana Gardens, Bon Carre at Donmoor, Donmoor Food Mart, Monet Townhouses, Monet Manor, Sandpiper Apts, Court of Three Sisters, Melrose II, Peppermill Apts, Hahn, LEWCO, Carrollton Self Storage, Tim's Food Mart, Charlestown Apts, The Plaza Apts, and Donmoor Village.
