Dear Mr. Brace:

This letter concerns the unauthorized placement of fill material into wetland areas contiguous with Elk Creek on your property at various locations both north and south of South Hill Road, Town of Waterford, Erie County, Pennsylvania.

On May 5, 1987, Mr. James Pabody of my Cleveland Projects office met with you at the project site to determine the extent of wetland filling that was initially reported to this office by the Pennsylvania Game Commission. The results of this investigation have shown that you had excavated a series of trenches through a wetland area and have connected these trenches into Elk Creek. The trenches were constructed in a manner in which the excavated material was sidecasted along their length into the surrounding wetland. During the May 5 meeting you stated to Mr. Pabody the purpose of your project was to restore the natural drainage to this area which had been disrupted by beaver dams. In addition, at a location separate from the trenching activity you have placed a considerable amount of waste and earthen fill material into a portion of this same wetland. No explanation was offered for

The placement of dredge or fill material into waters of the United States including wetlands requires a Department of the Army permit under Section 404 of the Clean Water Act. Since these activities were performed without first obtaining proper Department of the Army authorization you have violated Sections 301 and 404 of the Clean Water Act. A copy of the penalties associated with the violation of these provisions of the Clean Water Act is enclosed.

I hereby order you to cease all activities associated with this project until further notice.
