## PAVE THE WAY

The Touchet Educational Foundation is working hard at building a scholarship program Now we are also planning to build a permanent addition to the Touchet School.

Reserve your place in history by purchasing a personalized paver with your name or the name of your business. Give a paver in honor of a graduation, birth of a child, anniversary or birthday.

There are 322, 4" X 8" and 35, 8" X 8" pavers that will be placed at the main entrance to the school near the flag pole. Your inscription will be made on a bronze plaque that will be attached to the paver. There are also many logos to choose from, and custom logos can be priced upon request.

The response for the pavers has been great! Some families have ordered a single paver with everyone's name on it, for example, the Smiths; John, Mary, Tom and Sue. Some have ordered a paver for each person in their family that is a Touchet graduate -the paver has their name, year of graduation and a short message. Pavers can then be placed next to each other upon request. We also have received orders from current and former teachers, businesses, alumni, and several in honoring and in memory of a loved one. There is a large paver ordered commemorating each of the State Championship football teams of '98 and '99. A great idea would be to see a paver from a specific class, club or organization.

A dedication of the pavers will be October 1, 2004 after the pep rally (approximately 1:00pm). At that time you will have the opportunity to choose the location of your purchased paver. (First come, first served)

College costs vary and will depend on the kind of school you choose, the number of courses you take, and your lifestyle. The typical student will spend about \$9,774.00 on living expenses during the 2003-2004 school year.




