Exploring IRAs

This will be my last article for this tax season so I wanted to leave you with some investing advice. Actually, I am talking about investing in your future by putting money into an Individual Retirement Account, more commonly known as an IRA. An IRA is a wonderful tool for you if you have some cold cash.

There are two main types of IRAs that I want to cover. The first is the Traditional IRA. If you meet the requirements, you can save some tax dollars and maybe increase your refund. It's easy and you have until April 15 to set one up for the previous tax year. Just go to the bank or call your financial representative and tell them you want to set up a Traditional

If you are under 50, you can invest \$5,500 in the IRA and reduce your income by that amount. If you are 50 or over, you can invest \$6,500. Here are the requirements: You have to have earned at least that amount by working at a job or by being selfemployed; there are income limits if you and your spouse are covered by a retirement plan at work (I'll list them below); and you must be younger than 70-1/2.

Of course, this does not mean that you can save for retirement and not pay the tax man later. When you start taking distributions from your IRA, and once you reach 70-1/2, then the distribution will be taxable as ordinary income, but hopefully at a lower tax rate than when you first earned the money you invested in your IRA.

For example, if you are in the 10% tax bracket, you save \$100 for every \$1,000 you invest; in the 15% bracket, \$150; and in the 22% bracket, \$220. If you and your spouse both invest \$6,500 and you are in the 22% tax bracket, you can save \$2,860 in taxes.

Wouldn't it be nice to save money while you are in the 22% tax bracket and pay tax on that money when you are in the 10% tax bracket! And you can invest in an IRA every year. There is a 10% penalty if you take any money from your IRA before age 59-1/2, so be careful not to invest money you will need before you retire.

Let's talk about my favorite, the Roth IRA, named after the senator who first came up with this retirement plan. There is no age restriction and you also have until April 15 to set one up for the previous year. The Roth IRA gives you the tax

benefit later because all distributions are non-taxable if you have met the requirements, and you can leave the Roth IRA to your children or other beneficiaries and they will never have to pay tax on that inheritance.

This is a great benefit over the Traditional IRAs that are taxed as ordinary income to whoever takes the money. So you do not get a tax benefit immediately when you invest in a Roth, but the money can grow over the years and be completely tax free. You can convert a Traditional IRA to a Roth, but will pay tax on the money when you convert.

For the Roth to be tax free, you must be 59-1/2 or older when taking distribution unless distribution is made because of death or disability, and the Roth must have been established and held for at least 5 years by you or your beneficiary. The first contribution starts the holding period and any withdrawals prior to the five years is considered withdrawal of the initial investment. Any amounts over that are subject to being treated as ordinary income with a 10% penalty.

So the choice between IRAs is made by deciding whether you need the tax break now or later. Whatever you decide, remember that you are investing in your future and maybe in the future of your spouse, children or grandchildren. It's investment if you have the cash.

• Traditional IRA income limits (subject to yearly adjustments):

Covered by a plan at work: MFJ or QW \$101,000-\$121,000; Single or HOH \$63,000-\$73,000; MFS \$0-\$10,000. Not covered by a plan at work: MFJ or QW \$189,000-\$199,000: MFS \$0-\$10,000.

· Roth IRA income limits (subject to yearly adjustments): MFJ or QW \$189,000-\$199,000; Single or HOH \$120,000-\$135,000; MFS \$0-\$10,000.

What Can You Do With Your Tax Refund?

We've passed the tax-filing deadline. For many of us, this means it's that time of year when we get our biggest financial windfall – a tax refund. If you have recently received a refund, or are expecting to get one in the next few weeks, what should you do with it?

Of course, you could just spend the money on something you want, but if you'd like to maximize the financial benefits from your refund, you might want to consider other options, including the following:

- Invest the money. In 2018, the average tax refund was about \$2,700. For this year, it might be somewhat lower, due to changes in the tax laws and the failure of taxpayers to adjust their withholdings in response. However, if you were to receive in the neighborhood of \$2,700, you'd be almost halfway to the annual IRA contribution limit, which, in 2019, is \$6,000. (If you're 50 or older, you can put in up to \$7,000). If you have already "maxed out" on your IRA, you could use your refund to fill in gaps you may have in other parts of your investment portfolio.
- Pay insurance premiums. Let's face it – nobody really likes paying insurance premiums. Yet, if you have anyone depending on you, you will certainly need life insurance, and possibly disability insurance as well. And if you want to help protect your financial resources later in life from threats such as an extended - and hugely expensive – stay in a nursing home, you also may want to consider long-term care insurance. Your tax refund could help pay for some of these premiums, boosting your cash flow during the months you would normally be making these payments.
- Contribute to a college fund. It's never too soon to begin saving for college, which has grown increasingly expensive over the last several years. So, if you have young

What is Candida Auris?

According to the Centers for Disease Control, Candida auris (also called C. auris) is a fungus that causes serious infection. Patients with C. auris infection, their family members and other close contacts, public health officials, laboratory staff and healthcare workers can all stop this disease from spreading.

C. auris can cause bloodstream infection and even death, particularly in hospital and nursing home patients with serious other medical problems. More than one in three with invasive C. auris infection that affects the blood, heart or brain will die.

Candida auris is often resistant to medicine. Antifungal medicines commonly used to treat Candida infections often do not work for this disease process. Some C. auris infections have been resistant to all three types of antifungal medicines.

Discovered in 2009, it has spread quickly and has caused infections in more than a dozen countries. Because it is difficult to identify, C. auris can

children, you may want to think about investing some or all of your refund into a college-savings account, such as a tax-advantaged 529 plan.

- Pay off debts. You might be able to use your refund to pay down some debts – or perhaps even pay off some of your smaller ones. The lower your monthly debt load, the more money you will have available to invest for the future. Keep in mind, though, that you might not want to look at all debts in the same way. For example, putting extra money toward your mortgage might help you pay it off faster, but you'll also be funding an asset – namely, your house – that might not provide you with the same liquidity as you can get from investments such as stocks and bonds.
- Help build an emergency fund. By building an emergency fund containing six to 12 months' worth of living expenses, you can help yourself avoid dipping into your long-term investments to pay for large, unplanned-for bills, such as a major car repair or an expensive dental procedure.

Your tax refund could help build such a fund, with the money ideally being placed in low-risk, liquid vehicles.

Clearly, you can help yourself make progress toward a number of your financial goals with your tax refund – so put it to good use.

be misidentified as other types of fungi unless specialized laboratory technology is utilized.

Good hand hygiene (washing with soap, water and friction for at least 20 seconds) and good cleaning protocols are important since it can live on surfaces for several weeks.

Candida auris is still rare in the United States. The most common symptoms of invasive Candida infection are fever and chills that do not improve after antibiotic treatment for a suspected bacterial infection.

Since only a laboratory test can diagnose C. auris infection, it would be wise to discuss this with your healthcare provider or an infection disease specialist.




