Alderman Edwardes made several inquiries on the information contained in the report and they were discussed with the Water/Sewer Department personnel. There was no further discussion from the Board. A motion was made by Alderman Larsen, seconded by Alderman Robinson to approve the Resolutions with the appropriate changes in order to make the report accurate. The motion was carried by unanimous voice vote.

Public Comments:

Alderman Larsen inquired on the road construction down by Hwy 79 & 80 as to what was going on. Police Chief Shayne Gibson gave the information in regards to the repairs that he received from the DOTD

Alderman Edwardes had initiated a discussion about Property Standards and the proposed letter that is scheduled to go out to the town residents. Mr. Glen Mazier, Property Standards, gave a presentation of the "Good Neighbor Program" as well as a timeline to be implemented. After further discussion it was determined that 30 days after the notification to the residents is sent out, Property Standards will be more aggressively enforced and citations will be issued according to the Ordinance.

Town Clerk, Veronica Brown advised that FREE COVID Vaccines will be given out at Mt Olive Baptist Church on May 7^{th} from 10:00 AM -2:00 PM and also reminded the Council of the Special Meeting to be held on Monday, May 3^{rd}
