Available on a first come basis as long as the food offered is approved by committee. Food vendor price is 500.00. Paid with application and with a certified check or money order. **No payments arrangements are available.**

No refunds given.

TERMS OF CONTRACT FOR FOOD VENDORS

1. All proceeds from your sales belong to the vendor. No commissions will be assessed. Vendors are responsible for collecting and paying Georgia sales tax and reporting earnings to the IRS.
2. **Insurance**—Vendors are expected to carry their own insurance coverage to protect their merchandise from damage, loss or theft incurred while participating in our Fair. No insurance will be supplied by the Fair. You will need to provide insurance information (certificate) when you set up.
3. All food items made available for sale along with prices must be approved by the food committee prior to set up. These prices are to be properly displayed at all times.
4. No vendors or their representatives shall conduct themselves in an offensive manner to general standards of decency of good taste. Entrance to the Fair and parking will be only with approved passes. You will need to unload your items and move your vehicle to the lower parking lot. If you have employees coming later to work with you. They **MUST** park in lower parking lots.
5. No smoking or alcohol is allowed on fairgrounds. This is a county ordinance that must be observed by all vendors.
6. Please bring trash bags and clean up your area on a daily basis. When vacated, vendor spot must be left clear of all paper, packing materials, and other refuse.

DO NOT LEAVE A MESS FOR SOMEONE TO CLEAN UP. YOU WILL NOT BE INVITED BACK. TAKE TIME AND CLEAN YOUR MESS UP. All trash goes in the dumpsters.

7. You are responsible for contacting Habersham County Health Department a minimum of 30 working days prior to the opening date of the Fair. Any problems/questions should be directed to the Health Department. 706-776 7659
8. Set up dates are Tuesday, September 2, Wednesday 3, September 4, and Thursday, September 5. Please contact Judy Bryson at 706-499-0993 to schedule a set up time. She will arrange to be at the fairgrounds to meet with you. We will try to set up so that you will not have to be asked to move after set up so please work with us about the setup order. Location is not guaranteed. Do not ask. Do not expect to be in the same spot as previous year.
9. You must furnish your own hoses and power cords. It is your responsibility to make sure they are used properly and placed as to not be a hazard to fair attendees.
10. No ice is available for vendor use. Ice machine in kitchen is for use of Fair committee.
11. **NO Pets of any kind are to be on the property at any time during the Fair.**
12. **Breaking down early is not allowed.**
13. **You must have your booth open for business every day that the Fair is open.**

FAIR DATES THIS YEAR ARE SEPTEMBER 6- SEPTEMBER 14, 2019.

Food vendors only will be allowed inside the back gate at 4:00 pm on week days and 11:00 on Saturday and Sunday. If you need in earlier please let Brenda Kinsey know the night before at the Fair or call me at 706-768-6890.
