11. District Updates

Treasurer Birkenmaier reported the Lyons School Trustees requested to attend School District Board of Education meetings to provide updates on several Lyons TTO pending issues. The focus of the presentation will be to provide information on the value added to each district by the TTO; information on TTO generated interest earnings; TTO operations, capital and litigation costs: and to provide for an exchange of questions and comments on the TTO and district relationships. The Treasurer's Office has met with Western Springs School District #101, Indian Springs School District #109, Lyons Township High School #204 and Willow Springs School District #108. The Treasurer's Office has scheduled to meet with Lyons #103, Argo #217 and Summit #104's Board of Education. The remaining districts are currently being scheduled (102,105,106,107).

In addition LADSE's Director sent a resolution of withdrawal from the TTO. The Director is asking for a meeting to discuss the LADSE withdrawal. President Thiessen and the School Trustees discussed making a motion to approve their withdrawal effective December 1, 2016. Discussion followed.

Treasurer Birkenmaier will schedule a meeting with the Director of LADSE to discuss the details of their request of withdrawal and report back to the School Trustees.

MINUTES OF THE CLOSED MEETING OF THE LYONS TOWNSHIP TRUSTEES OF SCHOOLS November 28, 2016

1. Call to Order.

The Closed Session of the Lyons Township Trustees of Schools was called to order by President Michael Thiessen at the Township School Treasurer's Office, 22 Calendar Court, LaGrange, Illinois at 7:34 p.m.

2. Roll Call.

Taken by President Thiessen. Present were President Thiessen, Trustee Tobolski, Trustee Dickman, Treasurer Susan Birkenmaier, and attorney Emily Witt.

3. Discussion of the appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the public body. 5 ILCS 120/2(c)(1).

Treasurer Birkenmaier discussed her succession plan, as her contract expires June 30, 2017. The Board discussed the possibility of training a replacement for the Treasurer in house, personnel development, and how the staff would fare without Treasurer Birkenmaier.

4. Litigation, when an action against, affecting or on behalf of the particular public body has been filed and is pending before a court or administrative tribunal, or when a public body finds that an action is probable or imminent, in which case the basis for the finding shall be recorded and entered into the minutes of the closed meeting. 5 ILCS 120/2(c)(11).

The Board discussed the status of the litigation with School District 204. President Thiessen discussed that certain School District 204 board members approached him about a possible settlement agreement. Trustee Dickman provided an update on the recent depositions— how they went, what testimony was given, and whether to order the deposition transcripts. The Board then discussed how they would approach a possible settlement with School District 204 and the potential settlement amount. The Board discussed under what conditions and circumstances they would settle the case. The Board also discussed how a settlement would affect the TTO's relationship with the other school districts, especially those who are not paying all of their bills and those districts that no longer want to a part of the TTO. The Board also discussed the costs of going to trial. Additionally, the Board discussed how the litigation with School District 204 was affecting the TTO's relationship with the other school districts. The Board then discussed the next steps in the litigation and the upcoming depositions.

5. Discussion of the appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the public body. 5 ILCS 120/2(c)(1).

The Board again discussed the succession plan for Treasurer Birkenmaier and whether they could replace her from within the TTO or whether they would need to hire externally to replace her. The Board and Treasurer Birkenmaier discussed how much time they would need to train a new treasurer.

6. Adjournment.

Trustee Dickman moved to adjourn the Closed Session, seconded by Trustee Toboloski. A roll call vote was taken, with President Thiessen, Trustee Tobolski and Trustee Dickman voting aye. Closed session was adjourned at 8:54 p.m.
