RULES

1. Groups

- a. Continue to **observe social distancing rules and guidelines** when practicing and/or recording your virtual lip sync video.
- b. Groups must have at least 1 VPE Student. Groups can include family members or anyone with whom the student is regularly interacting.
- c. Virtual student groups are allowed for example, practice and perform with your group via zoom.
- d. Each VPE Student may only participate in one Lip Sync Group

2. Music Selection

- a. The duration of the song must be 3 minutes or less. We are recommending 2 minutes or less.
- b. Music must be appropriate for a school environment. Lip Sync Videos with music determined to be inappropriate will be omitted. The following are inappropriate for a school environment:
 - i. Profanity
 - ii. Reference to drugs or alcohol
 - iii. Adult content and/or innuendos

3. The "Performance"

- a. Record your Lip Sync Video and submit along with the following items on or before 5pm on Monday, June 1, 2020:
 - i. Email the completed Sign-Up Sheet (included on Page 3) and Song Lyrics to vpelipsync@gmail.com.
 - ii. Submit your video by sharing through google drive or emailing to vpelipsync@gmail.com
 - iii. Upon receipt of your Lip Sync Video, the music selection will be reviewed to confirm it is appropriate for a school environment. If it is deemed inappropriate you will be notified and given an opportunity to edit and re-submit.
 - iv. Upon receipt of your Lip Sync Video, **your video will be reviewed to confirm social distancing guidelines were followed** during the performance. If it is deemed that social distancing rules and guidelines were not followed, your group's performance may be omitted from the performance.
- b. All videos will be compiled and a link will be provided on Wednesday, June 10 for viewing the Virtual Lip Sync Performance.
