PET, STRAY, & FERAL COMMUNITY CATS

Like many Houston neighborhoods, WVTA has too many cats. There are a number of residents working to address this issue. According to the Citizens for Animal Protection (CAP) website, feral cats, also known as "wild or free-roaming" cats, are the largest cause of pet overpopulation in our area. CAP, and other animal advocate groups, are committed to solving this problem using **Trap-Neuter-Return (TNR)**. "Trapping and euthanizing feral cats only contributes to the population problem. Cats are territorial and when cats are removed and euthanized from a location, new cats will move in and the survivors will breed to capacity." TNR is a nonlethal strategy for reducing the number of

INSURANCE 101- ARE YOU COVERED?

Most people would answer that question with their Medical, Auto, Homeowners/Renter's or Life Insurance Policies in mind. Here are some other options you may want to consider based on home contents, personal liability, living expenses, as well as special and loss assessment coverage

1. **Flood** – This policy covers water damage your homeowners policy may not.

2. **Scheduled Personal Property (SPP)** - This is an optional add-on to your home insurance policy, and assigns specific value amounts to prized items like artwork, jewelry, expensive

handbags, designer clothing and furs (You will need to provide a receipt or hire a professional appraiser to assign a value to the items). Personal Property coverage with replacement cost is necessary since the Association's master policy does not cover an owner's personal property. 3. **Loss of Rents** - For owners who rent units, this coverage pays the owner rent(s) due should they not be able to collect in the event of an ensured loss.

4. Bodily Injury & Property Damage – Pays for bodily injuries to other people or damage to their property if you are liable resulting from unintentional acts committed by family members and pets. 5. Loss Assessment - In most cases, this coverage will pay for an assessment levied by the Association for each owners' share of the deductible for an insured loss. When purchasing a Loss Assessment Policy keep in mind this is personal coverage Homeowners purchase from their insurance company and has nothing to do with the Association's structure insurance policy with Brady, Chapman, Holland and Associates, Inc. Your current homeowners policy may include this coverage, but it could be limited to a minimal amount such as \$1,000. However for a negligible annual fee, coverage can be increased to \$10,000.

Understand what is and is not covered and ask your agent the right questions.
