#### Effective January 1, 2013:

To help resolve the confusion that has been occurred over the years with Excellent A and Excellent B classes, which are two distinctly different classes, we are renaming them to match the names of the titles that are earned from those two, different classes. The requirements to qualify are different in each of these classes as is the title earned when they complete the title requirements.

In an effort to eliminate this confusion, as of January 1, 2013 the name of the Excellent A class will change to "Excellent" and the name of the Excellent B class will change to "Master".

Please note, only the name is changing. The class themselves and the titles earned remain the same. The changes will be as follows:

**Excellent A will change to Excellent** 

Excellent A Preferred will change to Excellent Preferred

Excellent B will change to Master

Excellent B Preferred will change to Master Preferred

#### **DOGS ELIGIBLE TO ENTER**

This Agility trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds.
