Attending a Woodwind Lakes Board Meeting Hybrid ZOOM session

It will be Board policy to hold in-person Board meetings but to also stream meetings via Zoom, so that they may be viewed by association members that are not in attendance.

In recognition of the fact that Board members are frequently required to travel and in accordance with the Texas Code, the Board will endeavor to permit absentee Board members to attend and participate in Board meetings via Zoom.

All other association members will be able to live stream meetings via Zoom but must attend the meeting in person if they wish to speak.

The Board lacks the equipment and personnel capabilities to permit the Board to conduct a full hybrid Zoom meeting. For this reason, people who participate from home will have the ability to listen and view but not participate in the meeting. "Chat" and "Text" functions will not be enabled.
