The Marine Corps League Distinguished Citizen Gold Award presented to Harvey Harris and Bryson Allen for exceptional Marine Corps League contributions.

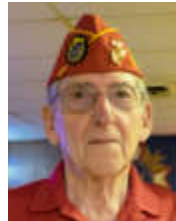
