Presentation – Bill Duvenek, KB3KYH, ARRL Delaware Section Manager.

Topic: ARRL Update

There are 811,193 ham and club licenses in the USA. More than 50% are Technician class. Many Technicians stall at that level and never go on the air.

Ham radio is growing. We need to figure out ways to get Techs on the air and upgraded.

Delaware has 2,000 licensed hams. 734 of them are in Sussex County. HamData and QRZ.com are sources for populations of radio amateurs.

Delaware is 50th of the FCC entities and is rare territory.

The hobby of amateur radio has two facets:

- 1. Fun
- 2. Public Service

There is a lot of volunteerism in Delaware. 4,372 volunteer hours (109 person weeks) were contributed by Delaware hams. This information is good to know.

ARRL Atlantic Division Data: Delaware has a slight membership loss which is less than others in the division. This may be attributed to the ARRL dues increase.

ARRL governance is incorporated in CT. It has an elected leadership with 15 Directors and 71 Section Managers, all with 2 year terms, elected by the membership.
