<p>There will be a warmup area containing boxes with the odors to be used. Competitors are not allowed to bring their own odors or practice boxes. If a Competitor brings in their own odors or practice boxes then this will result in be excused from the trial.</p>	
<p>Trial will be indoors in the TNT Annex attached to the agility building. We may also be using the pool building, outdoors, upstairs mezzanine or any other structure on grounds. This trial will be running with our CPE agility trial, therefore crating will be set in the same areas as the agility. No need to move your crates.</p>	

**NOTICE TO EXHIBITORS**

\*The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

\*Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

\*It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.

\*Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

**Directions to the Site.**

**From the South:** take US 23 to I-75 north. West US-10 to Stark road exit (119). Turn right (north) and go over overpass less than one mile to Stark Road. Turn right (west) onto Wackerly. (There is a TNT sign with an arrow) Go approximately ½ mile. TNT is the blue building (look for storage units) on the right (north) side of the road. If you come to Saginaw Road you have gone too far. CAUTION: some GPS units send to the corner of Wackerly and Stark.

**From the West:** take US 20 to M-30 to US 10. Take US 10 East toward Midland to Stark road exit. Turn right (north) and almost immediately turn right (west) onto Wackerly. (There is a TNT sign with an arrow) Go approximately ½ mile. TNT is the blue building (look for storage units) on the right (north) side of the road. If you come to Saginaw Road you have gone too far. CAUTION: some GPS units send to the corner of Wackerly and Stark

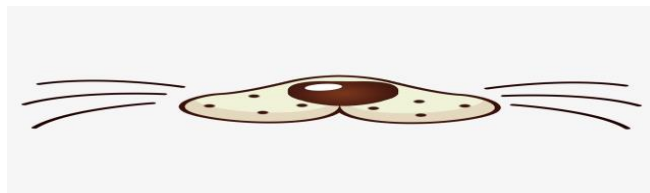
