MEMBERSHIP APPLICATION & AGREEMENT

Please Check Preferred RMYC Membership. (All fees subject to GST) (Fees will be invoiced)

- **Full Membership:** Gives access to a seasonal boat mooring space at Club docks, access to winter storage of your boat in Club yard; access to the fuel and pump out dock; access to Clubhouse facilities including washrooms, showers, sauna, restaurant, bar, banquet hall, and email notices of Club news and social events. \$500 per year
- **Associate Membership:** Access to seasonal overnight mooring space at Club docks not available, however access to storage of your boat in the Club yard is, as are access to Clubhouse facilities and notices of Club news and social events. Free launches of your boat at the Club ramp are included. \$150 per year.
- **Clubhouse Membership:** No seasonal overnight dock space or seasonal yard storage. Gives access to Clubhouse facilities and notices of Club news and social events. \$100 per year.

Important Notice: Membership Fees do not include seasonal overnight mooring fees or yard storage fees, which are invoiced separately and are based on the measured total length of your boat including all attachments to the bow or stern. Membership fees also do not include the dock electrical service fee for seasonally moored boats, tickets for special Club events, other optional or special services provided by Club, or general assessments for special projects, all as approved by the Club's Executive Board. For details see the Club's General Fee Schedule. Membership Fees and other applicable fees including taxes are due 30 days after being invoiced by the Club.

Owners of boats to be stored must also complete a separate storage contract before storage services are provided or continued.

MEMBERSHIP TERMS AND CONDITIONS:

1. The applicant here by request the Executive Committee of the Royal Manitoba Yacht Club Inc. ("the Club") to consider his/her application for membership contained herein for the services, and at the rates, as set out above.
2. If the Applicant is not already a member of the Club, he/she acknowledges that this application must be approved by the Executive Committee of the Club prior to the Applicant being entitled to any of the benefits of membership in the club.
3. This agreement shall become binding upon the Applicant and upon execution hereof by the Applicant. If approval of the Executive Committee of the Club is required, this agreement shall become binding on the Club only when such approval is given. If Executive Committee approval is not required pursuant to the terms hereof, this agreement shall become binding upon the Club upon execution hereof by the Applicant.
4. The Applicant represents and warrants to the Club that he/she is the legal and beneficial owner of the Boat described above. For seasonally moored boats proof of liability insurance is required.
5. The Applicant agrees to pay all monies owed by the Applicant to the Club (including, but not limited, to all membership dues, storage fees, dockage fees, utility charges, and applicable taxes), within 30 days of receipt of an invoice for the same.
6. Interest will be charged on all past due amounts owed to the Club by the Applicant at the rate of 2% per month.
7. In addition to any rights of the Club pursuant to the By-Laws of the Club, as they exist from time to time, the Club shall be relieved of any further obligation to provide the services contemplated by this agreement upon default by the Applicant under any of the terms of this agreement, and at any time after the default.
8. The Applicant hereby grants a security interest to the Club in the Boat and all proceeds there from. The security interest granted hereby is intended to be general and continuing security for the payment of all obligations, indebtedness and liabilities of the Applicant to the Club, whether incurred prior to, at the time of, or after the execution hereof. The Applicant warrants and acknowledges that it intends the security interest created herein to attach upon execution hereof by the Applicant.
9. If any monies owed by this Applicant to the Club are past due, the Club shall be entitled to seize the Boat and hold same until all amounts owed by the Applicant to the Club, including the costs of seizure and any costs incidental thereto, have been paid in full. In addition, the Club shall be entitled to all further rights of seizure and sale as may be permitted by law.
10. Applicant agrees to pay all costs and expenses (including legal fees on a solicitor and his/her own client basis) of the Club incurred with respect to any proceedings taken for the enforcing of the rights and remedies of the Club.
11. No delay or omissions by the Club in exercising any right or remedy shall operate as a waiver of them, or any other right or remedy. All rights and remedies of the Club pursuant to this agreement or the By-Laws of the Club as they exist from time to time, may be exercised at any time and from time to time independently or in combination.
12. The Club shall not be liable to the Applicant for any damage caused to the Boat while on any premises operated by the Club, unless caused by the gross negligence or willful neglect of the Club, or its employees.
13. The Applicant shall indemnify and save the Club harmless from all claims, actions, damages, demands, fines and expenses of any kind for which the Club may become liable for which the Club may suffer, wholly or in part, due to any wrongful act, neglect or default of the Applicant, the Applicant's spouse/partner, any guest of the Applicant or any person operating the Boat. If the Club is made a party to litigation instituted by or against the Applicant, the Applicant's spouse/partner, any guest of the Applicant, or any other person because of any such aforesaid wrongful act, neglect or default, then the Applicant shall indemnify and save the Club harmless against and shall pay all costs expenses and legal fees (on a solicitor and client basis) incurred or paid by the Club in connection with that litigation.
14. The Applicant agrees to abide by all Royal Manitoba Yacht Club By-Laws, Regulations, and Standing Rules.
