## Social-Emotional Factors in Speech Sound Disorders

Successful speech sound treatment takes into account numerous factors: a child's sound inventory, overall intelligibility, and the impact of the disorder on daily interactions with peers and adults. One important factor has received increased attention in the research literature in the last decade: the social and emotional ramifications of speech sound disorders. This conference will focus on findings that inform assessment and treatment of this critical factor. It will also cover indirect vs. direct treatment approaches, multiple intelligences, how to utilize a child's strengths and interests to address speech intelligibility, and counseling techniques regarding speech production for the child and his/her family.

This unique conference will alternate providing research-based principles with intensive small group projects throughout the day. All completed projects will be shared with the entire group after the conference to support the application of best practices.

### ***After completing this program, participants will be able to:***

1. Describe direct and indirect approaches to addressing speech sound production.
2. Discuss the impact of speech sound disorders on children's activities and participation.
3. Utilize evidence-based techniques to counsel children and their families regarding social and emotional factors in speech sound disorders.
4. Develop speech sound activities that cater to an individual's strengths and interests.
