1. In case of an emergency, I hereby authorize my child to be treated by Certified emergency Personnel (EMT, First Responder, E.R., Physician, etc.)
2. The risk of injury to my child from the activities involved in these programs is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce the risk of serious injury does exist and I, for myself, Spouse, and Child, I knowingly and freely assume all such risks, both known and unknown, even if arising from negligence of the releases or others, assume full responsibility for my child's participation and, I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in the the program itself, I will remove my child from the participation and bring such attention of the nearest official immediately and I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns personal representatives and next of kin, hereby release the other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees") with respect to any and all injury, disability, death, or loss or damage to person or property incident to my child's involvement or participation in these programs, whether arising from the negligence of the releases or otherwise to the fullest extent permitted by law.
