## NAVHDA Tests

All tests will begin at 8:00 am sharp every day. All handlers and their dog should be on the grounds and ready for pre-test instructions at 7:30 am.

All test entries must be submitted through the new NAVHDA member portal. To get there go to NAVHDA.ORG and log in. Then open the Menu and click the Member Portal Link. Here is a [Link](#) to the NAVHDA site. Once you are in the Member Portal, click the hyperlink to your dog that you would like to register for a test. Then work through the test registration process.

You currently cannot pay on-line when registering through the member portal, however, you can scan one of the QR codes below (Venmo or PayPal) to send your test fee. You may also mail a check payable to "MWTS-NAVHDA" to the address below. Your spot on the test is not confirmed until your fee has been received.

**Eligibility:** All dogs entered in NAVHDA tests must be NAVDHA registered. Partial registration is available for dogs that cannot provide a recognized three-generation pedigree in the time of the test. If your dog is not currently registered with NAVHDA, please contact the international office at (847) 253-6488 or <http://www.navhda.org> to register. Dogs are eligible for Natural Ability testing up to and including the day they reach 16 months of age. Dogs over 16 months may be run for evaluation and only if space is available. No prize classification can be awarded a dog run for evaluation regardless of the score attained.

**Entries:** Test entries are limited and will be taken on a first-come, first served basis, subject to the rules stated above. A test entry is a completed Test Entry on the NAVHDA Member Portal and payment of test entry fee through one of the methods listed above. A handler may enter and run a maximum of two dogs per testing day. The policy is in effect up to 10 days prior to the test date. At that time, the handler may enter and run any number of dog's subject to availability of test openings.

**Refunds:** Full refunds will be given up until 60 days from the first day of the test series. 100% of the test entry fee will be refunded if within the 60 days for medical reasons only. A request must be submitted, in writing, to the Test Secretary, accompanied by a verifying letter from a physician or veterinarian stating that the handler or dog should not participate in the test for medical reasons. Under no other circumstances will any refunds be given.
