#### **RULES & REGULATIONS**

The Chantarelle Rules Committee met as directed by the board to look at our Rules and perhaps clarify some questions about our neighborhood. We referenced as our guidelines the CC&Rs and Rules and Regulations, both of which can be found at Chantarelle.org. These documents clearly speak about a number of topics that will, when adhered to, continue to keep our community attractive and our home values competitive.

In general, it is clear that all homes need to be clean and free of dirt, mildew and debris and the paint in good condition. This includes any items that are on display on the front of our houses. These items should be in good working order and not

rusted, dirty, worn, broken, frayed, faded or in otherwise poor condition. Pots, planters, figurines, and other decorative objects should not look neglected or inappropriate. If there are any questions that you are unsure of or that you would like to have considered for review, the ACC (Architectural Control Committee) should be consulted and the proper paperwork and application should be filled out by the occupant of the home and submitted for review. It is important that the records of your request be kept on file. Please note that just because you may see particular variances on another home, it DOES NOT AUTOMATICALLY mean that your request will be approved for your home. Approval by the ACC is not guaranteed and many factors go into the approval process. Seasonal items such as wreaths, decorative flags, and such should comply with the Rules and not be put up more than 30 days in advance and should be taken down no later than 15 days after the holiday. The community standard (CC&Rs 7.7) for banners is 15 square feet, or 3x5 feet in the case of a flag, and only one flag at a time can be flown. American and California State flags must meet size requirements but do not otherwise require HOA approval.

All items that could possibly obstruct or interfere with mowing, trimming, watering, fertilizing or any other landscaping duties should be

removed from the front yards and flower beds. Please note that the fronts of our homes are maintained by the HOA landscapers and must be kept clear of any and all objects that could cause problems for the landscapers or other work persons.

In conclusion, the Rules Committee found that almost all residents living in Chantarelle are in compliance and have not abused the spirit of the CC&Rs and Rules and Regulations. Our homes are attractive, not overtly decorated on the exterior and have tasteful and pleasant decorations. We hope that by working to keep things beautiful in our neighborhood. all of us can look forward to continuing rising property values and good relationships with our neighbors.
