- x👤 Check-in from 2:30-3:00 PM only. Exhibitors must set up by 3:45 PM
- x👤 Vehicle space is FREE. Event is FREE to the public
- x👤 You are responsible for cleanup of your space
- x👤 Teardown must occur between 8 and 8:45pm - due to safety concerns, vehicles will not be allowed to leave until the event is over. No Exceptions.
- x👤 No smoking or open flames allowed
- x👤 No alcoholic beverages
- x👤 **Vendors:** NV State Tax Collection, reporting and payment of tax is solely the responsibility of the vendor. Packets will be provided at check-in & must be returned to Vendor Coordinator by 8:45pm- \$25.00 deposit required, refundable upon arrival at event.
- x👤 Electricity is not provided but lighting is encouraged.
- x👤 Only individually wrapped candy can be passed out. No homemade food items
- x👤 All candy is subject to inspection for safety reasons.
- x👤 **Trunks:** Bring enough candy for 2000 children
- x👤 All vehicles will provide their own volunteers. The individuals or groups will provide a child appropriate prize and/or candy in exchange for participation of attendees.
- x👤 There will be prizes for best vehicle
- x👤 No vehicles allowed to participate unless registered by Oct. 24th

There are four ways to participate:

- x Trunks- Decorate a trunk and handout treats,
- x Sponsors- donate funds, treat bags, or treats to support this event; in return your name will be displayed on all event marketing
- x Vendor- Sell foods or other items- **To ensure participation, a \$25 refundable deposit is required**
- x Activity- Create an activity such as a spook-walk, movie, game, pumpkin carving, photo booth, bouncy house, DJ booth etc.
