



## Stay Sharp (answers on last page)

- 1. Davis starts the game as the player/DH, pitching and occupying the 3rd spot in the batting order. In the second inning, Johnson enters the defensive role as pitcher and Davis shifts solely to the DH spot. In the third inning, Davis returns to the mound. In the fourth inning, Keller bats for Davis. In the next half inning, Davis goes to the mound to pitch.
  - a. Legal. Davis still has onetime re-entry rights.
  - b. Illegal. Davis has already used his re-entry rights

- 2. With R3 on third and one out, B1 flies to deep left field. The third base coach grabs R3 and pulls him back to third to tag up. The ball falls in and B1 ends up at second.
  - a. R3 is out and B1 remains at second.
  - b. R3 is out and B1 is returned to first.
  - c. Both R3 and B1 are out.
  - d. The ball is dead immediately upon the coach assisting the runner.
- 3. The bases are loaded and one out when B1 hits a pop fly near first base in fair territory. An infield fly is called. R1 is several feet off the bag and tracking the fly ball instead of locating F3, who is about to make the catch. R1 unintentionally runs into F3, who still manages to make the catch in foul territory.
  - a. Only B1 is called out.
  - b. Only R1 is called out.
  - c. B1 and R1 are called out.

I begin this portion of the newsletter with a HUGE thank you to all those that helped cover assignments in October. For the first time in many vears, we had dame assignments for umpires in the fall, these assignments came in the form of assisting another association with a baseball tournament and then being asked to cover 2 softball games from another league which lead to being asked to cover a Halloween Tournament in Marlton which we did with an offer to cover their league next spring.

This morning, I arranged a meeting with the Athletic Director at Burlington Township High School to discuss the Joe McDyre Freshman Baseball Tournament. This meeting will be held on December 3. As they say, the ball is in motion. This is a long time in the making, but I can see the runner coming

I will be putting out game assignments last week in February. This will include scrimmages and the first month of the regular season, the NJSIAA has put out a list of dates for warnings of not completing all requirements for game eligibility. The secretary has posted those dates. Please update your availability for the season, this will include Saturday and Sundays' as we do have some Saturday games and also, we are looking at assisting with some independent tournaments as we did this fall.

In the December 2024 Referee magazine, there is an article titled "YOU'VE GOT A JOB TO DO, UMPIRES CAN'T BE AFRAID OF TAKE CARE OF BUSINESS" To summarize the article, it references a few incidents

were umpires backed down from making the correct calls, only to have their partner intervene. Since we all know I like to call Balks, the following is directly from the article. "In a College World Series game, an umpire sent a team home by calling a balk on a pitcher who spun on his heel instead of stepping toward first on a pickoff move. Since there was a runner on third base, it scored what proved to be the winning run. Afterward, the coach was interviewed and. instead of blasting the umpire. said the pitcher had gotten away with it all year. But when you get to Omaha you get better umpires, and they'll call things right. That shows the level of respect most coaches have when we do the right thing even if it hurts their team. If we don't take of business, we hurt umpires who do."
