- A. If an existing structure: Customer's connection must be done by a licensed plumber, with a Town of Eclectic business license. The customer or plumber must contact McDonald Wastewater Services and let them know the date the connection will be done, so they can complete the State required inspection before the work is completed and/or the connection site is covered.
- B. If a remodeling or new construction: Customer must also contact the Eclectic Building Inspector, Charles Owenby @ 334.300.1818 to have any required inspections done. Failure to obtain any required permits, licenses or inspections could result in fine or other problems.
