Council reviewed the consent agenda which consisted of minutes of 10/18/2021, October 2021 listing of bills to be paid, October 2021 Treasurer's Report, Rodney Meyer Building Permit and Council-Municipal Leadership Academy Classes for current and incoming council to attend Thursday, December 2 | Atlantic, Saturday, December 4 | Mason City (moved from Clear Lake), Thursday, December 9 | Cherokee, Saturday, December 11 | Cedar Rapids, Thursday, December 16 | Virtual (via Zoom), Saturday, December 18 | Ankeny. Motion by Marugg, seconded by Lueck to approve the consent agenda. Ayes: all, carried.

CITIZEN CONCERNS: Manternach advised she received a complaint about water from toilet spraying onto wall from sewer jetting being done previous week.

PUBLIC WORKS: Council briefly discussed pursual of bids for Main Street Rehab and 2nd St. NE mill and overlay. Motion by Lueck, seconded by Leuchs to table until January 2022. Ayes: all, carried. Council discussed a state grant program to replace traffic control signage. Motion by Leuchs, seconded by Marugg to pursue grant program. Ayes: all, carried.

PUBLIC HEARING: Motion by Smock, seconded by Lueck to open public hearing at 6:54PM to review bids on parcels 1231127001 and 1231126004. Langel opened first and only bid from Nick Kamp. Kamp bid \$5,000 for both parcels with the desire to fill property to DNR requirements with the intent to park vehicles on property and potentially build in the future. Kamp's bid stated it was not subject to an easement. Motion by Smock, seconded by Lueck to accept Kamp bid without being subject to an easement. Langel called for roll call. Ayes: Smock, Lueck, Marugg, Engler, Leuchs. Carried. Motion by Leuchs, seconded by Marugg to closed public hearing at 7:12PM. Ayes: all, carried.

MEMORIAL HALL: Council reviewed Not Quite Brothers agreement. Smock inquired on security for door and Manternach advised NQB was not willing to reimburse city for security. Motion by Marugg, seconded by Leuchs to approve Not Quite Brothers agreement. Ayes: all, carried.

GENERAL BUSINESS: Council reviewed costs for movie screen and set up through Lyle Theisen for a Movie in the Park. Langel stated he thought it would be a good idea to do this on the ball diamond so people could utilize the snack stand. Council suggested it would be best to try to book after ball season. Council reviewed proposed CD from sewer fund with Fidelity Bank. Motion by Marugg, seconded by Leuchs to proceed with moving \$40,000 of sewer fund cash to 24-month CD. Ayes: all, carried. Council reviewed City Clerk positing and made suggested changes. Motion by Smock, seconded by Lueck to post City Clerk position in paper. Ayes: Lueck, Smock, Marugg, Leuchs. Engler abstain. Carried. Motion by Leuchs, seconded by Lueck to approve the following hiring committee: Lueck, Smock, L. Smock, Langel, and Manternach. Ayes: Leuchs, Lueck, Smock, Marugg. Engler abstain. Carried. Council reviewed Fire Department Agreement and revised Lease Agreement. Leuchs advised to make date changes on Lease agreement. Motion by Marugg, seconded by Smock to approve Fire Department Agreement and corrected Lease Agreement. Ayes: all, carried.
