## Waco And Beyond

The conflagration at Waco is over but it is far from forgotten (holocaust is a better word but it is now private property)! God in all of His infinite wisdom created the eco- systems of the earth to heal the scars caused by storms, volcanos, earthquakes and fire. The ashes and dust of the Branch Davidian Church at Waco, Texas are being washed into the earth by the rains and blown away by the winds. The 77 acres of prime Texas farmland, which is strategically located in a known oil- producing field, will now be confiscated and quietly transferred to a more "privileged and worthy" owner.

But the hearts of good, Christian Americans will forever remember the siege at Waco in a manner similar to another siege in Texas in another era. Just a couple of hundred miles away in San Antonio is the Alamo. Fewer than 200 Texas Volunteers withstood the siege of over 4,000 Mexican troops under General Santa Ana. They were able to hold out for 12 days (Feb. 23-March 6, 1836). The life of every Texan, surrounded there in that small church called the Alamo, was lost.

It was 157 years later, nearly to the day, that roughly half as many Christian Americans were placed under siege simply because their brand of Christianity was not "politically correct," not only to the government, but to many "approved" Christians and to the Antichrists as well. The Branch Davidian Church held the siege for 51 days (Feb. 28-April 19, 1993). They were under attack by a far fewer number of "foreign" troops but by far more sophisticated weapons than Santa Ana had at his disposal. Yes, the attacking force was foreign, a great part by a foreign purpose to the American way of life but there was also a segment of the force that was foreign by nationality and we will address this later.

The massacre of 200 Texas Volunteers was avenged by General Sam Houston a short six weeks later when he rallied his troops with the historic cry "Remember the Alamo." He secured Texas independence from Mexico with the victory of San Jacinto.

The massacre at Waco cannot be avenged under the present circumstances in such a straightforward and simple manner. However, according to the massive backlash we are learning about among millions of Americans, the blood at Waco will be avenged. The sleeping giant is awakening and we will also address this later.

[The March-April issue](#) of The Intelligence Newsletter was sent to the printer on the day of the fire; consequently, nothing was discussed regarding the conflagration. In this issue we will present additional information regarding the seige itself obtained during the

intervening time period. Then we will discuss the circumstances surrounding the fire. There is much that we have learned from many sources during this time frame, a pattern of intent and action, not only by the United States Government but by the United Nations as well. Yes, the United Nations was involved in the Waco incident with monitoring teams! Additionally, more is being learned about the world-wide surveillance network of the [Anti Defamation League](#) (ADL) and the [World Jewish Congress](#) (WJC), which distributes misinformation and disinformation for their own political purposes.

The May, 1993 issue of the newsletter *The Balance*, published by the Cause Foundation, 1101 Post Oak Blvd., Suite 9497, Houston, TX 77056; reported that "Mr. David Jones, a brother-in-law of David Koresh and a rural mail carrier, stopped at a local convenience store where he met a journalist who had been invited to cover the BATF raid. The journalist told Jones that he had `better get out of here quick because all hell's going to break loose at that church down the road.' Jones went directly to the Davidian Church and told David Koresh about the coming raid."

"David Jones found Koresh talking to Robert Gonzales, the BATF confidential informant whose information led to the raid. Koresh told Gonzales `well, I guess its decision time for you, Robert.' Gonzales immediately fled the church and, after entering his car, sounded an alarm which informed the BATF that he was clear of the church."

So Koresh knew that Robert Gonzales was an informant. It is simply not logical that the Davidians would have opened their doors to a known informant if they had anything to hide such as illegal weapons, child abuse or anything else illegal.

Continuing with the May, 1993 issue of *The Balance*: "As our readers may have seen on nationwide television, the BATF agents scaled a ladder to the roof, broke through a window and entered the church building. However, what you may not have seen because the original tape was confiscated by the government and the media given an edited version, was the BATF agents hurling concussion hand grenades through the window."

"Since the Branch Davidians had advance knowledge of the coming fire-storm, they had sent their women and children upstairs to the bedrooms, which is where the BATF agents broke into the church. When the hand grenades went off upstairs and the women and children started screaming, the Davidians took up arms and assaulted upstairs, capturing four BATF agents and killing two others (the other BATF agents were killed outside). One Davidian entered the room where the feds had penetrated and a point-blank firefight erupted. One BATF agent was killed, one mortally wounded, and the Davidian was severely wounded in the arm. When the close-range exchange occurred, some of the 9mm automatic fire from the wounded BATF agent missed the Davidian, penetrated the exterior wall, hitting a BATF agent on the roof. Hearing the agent fall on the roof, some Davidians vaulted into the living room and began firing upward through the roof."

"A federal armed helicopter swept over the church buildings and began strafing through the roof with indiscriminate automatic fire, resulting in the deaths of four elderly Davidians still in their beds. Peter Ghent, 19, an Australian citizen, was scrubbing the inside of an empty water tank when the shooting started. He climbed to the top of the tank and peered over when he was struck in the head and neck by government gunfire. Falling inside, he lay there terribly wounded."

"Wayne Martin, a Davidian and Harvard-educated Black attorney, called 911 and told the operator `God help us.. all hells' breaking loose, please help us!' The 911 operator finally put Martin in touch with the regional director of the BATF, Earl Dunagan, and a cease-fire was arranged. Koresh and the Davidians released the four captured agents and allowed them to remove the BATF dead and wounded. However, when the Davidians

requested to go to the aid of Peter Ghent, still in the water tank, they were refused. Ghent bled to death."

The source of information found in the May, 1993 issue of *The Balance* is the battery of nationally known attorneys who have consented to represent the Davidians. Many of these attorneys have been interviewed on national TV. Their intimate knowledge of what happened during that initial siege is a result of the countless interviews with surviving Branch Davidians, the information received during the interviews with Koresh and Schneider when the Feds allowed attorney Dick DeGuerin into the complex, and from discussions with and admissions from the federal officers themselves.

We have also learned that troops from other countries along with foreign equipment, was used during the siege at Waco. From an article in the *Sunday Times* of London, England, it was stated that British members of the British Special Air Service Regiment (SAS), which is a paratroop commando force, was present at Waco. There was also a British made Pilatus Britten-Norman BN-2T aircraft, which carried a Thorn EMI radar system. The FBI requested that the special surveillance aircraft be flown to Waco for use. Special forward-looking infra-red radar was used to determine where the people inside were. The plane also carried a special low-light television camera.

In addition to this, according to the *Sunday Times*, probes were driven through the walls of the complex, which contained fibre-optic cameras and miniature listening devices. One of the British SAS veterans stated that the FBI needed to know exactly who was in which room, what morale was like, what they were saying to each other and where the guards were. The London-based *Sunday Times* also indicated that other foreign nations may have had observers at Waco.

We know, without question, that the ATF fired first. We know that military helicopters fired with automatic weapons down throughout the roof and killed several Davidians in the upper rooms. The [Posse Comitatus Act](#) disallows the use of military in civil operations. The government told the Governor of Texas that they were certain that illegal drugs were being manufactured within the complex; thus, Congress allowed the use of military equipment for that purpose. We know that the government used hand grenades in the assault but accused the Davidians of using them. We know that the government was agreeable to a cease-fire to remove their dead and wouldn't agree to the removing of the badly wounded Davidian Peter Ghent. From these known facts simple reasoning tells us that we do not have a government "Of the people, by the people, and for the people."

The ATF wanted desperately for the attack on the Branch Davidian Church to be a success. The organization had been receiving poor publicity because of bad judgment in its mission of attacking survivalists, separatists and other so-called right-wing organizations and individuals for supposed gun violations. The raid on the Davidians was thoroughly coordinated and the international media was invited so that the world's population could see, not only the prowess of the ATF but to put fear in the hearts of all those who possess more weapons than considered proper.

In Idaho the following was stated in the *Coeur D'Alene Press*, in an article written by staff writer David Bond and published in their May 9th issue, "The agency responsible for the siege at the Waco, Texas, Branch Davidian compound may have violated federal firearms laws in gathering information about David Koresh's gun part purchases from an Olympia, Wash., manufacturer last year. The Bureau of Alcohol, Tobacco and Firearms' chief spokesman said this week the agency now routinely conducts background checks of private citizens purchasing certain types of guns-even though no crime is suspected-and said he views such checks as legal. But a spokesman for Sen. Larry Craig, R-Idaho, while stopping

short of calling those traces illegal, said Friday his office is looking into the matter...Targeted may be not only so-called cults like the one in Waco, but even North Idahoans (the paper is directed to residents of North Idaho-ed.) who buy one or two semi-automatic rifles for hunting or target shooting, the BATF said."

The article continued by stating that the ATF investigated the Olympic Arms Inc., a well known firearms and parts manufacturer, in 1992, ostensibly to check for tax payments by the company. The article stated, "What BATF did at Olympic between March and mid-July of 1992, and how it used the information gathered on the Branch Davidians from what was supposed to be a tax and paperwork compliance audit of Olympic, was clear to Olympic. 'Each and every day, two of them would come here, they'd spend hours going through stuff, making copies of every single invoice, and walking out a whole lot heavier than when they came in the morning,' said Darryl Jones, a sales representative for Olympic."

"Jones said, the tax compliance part of the audit appeared to be completed in just a few days, but agents kept coming back, copying records and packing tens of thousands of them out of the small factory. The profiling of private citizens by virtue of the type of firearms they purchase, then continuing on with the conduct of a background investigation based on this, would appear to be a gross invasion of individual privacy."

The ATF was given pure disinformation, by a meddling, unofficial and un-American organization that the Davidians were a debauched cult that was an enemy of society and society must destroy them. The ATF went to Olympic Arms, and elsewhere, to gather information and, based on that information, added two and two and got five!

The Davidians were in several different enterprises to earn money for their subsistence. They painted cars, repaired cars, repaired homes and they repaired and rebuilt firearms for resale. Paul Fatta, a Davidian, was a part of their firearm repairing facility. He had left the complex several hours before the initial raid to go on a buying expedition at an Austin gun show. These, gun shows all over the country, provided the source of many of the weapons that their shop would repair.

When Paul Fatta heard about the assault on the radio he telephoned the government, told them who he was and asked if he was wanted for anything. They told him that he wasn't wanted. But obviously Fatta couldn't return to the complex! So he simply traveled and stayed out of the way, waiting until the entire affair was over. However, while he was traveling in the Northwest, he read a wanted poster in a local Post Office. He was now a wanted man! Paul Fatta is a very gentle and kind man so this information devastated him!

He was put in contact with David Bond of the *Coeur D'Alene Press*. After much discussion with the appropriate attorneys it was decided that Mr. Bond would take Paul Fatta back to Texas and turn him over to the Texas Rangers. Neither Paul Fatta nor David Bond trusted turning him over to the federal officers because of fear of retaliation. Paul is now in jail waiting trial.

This information has been given to add to the information given in the [March-April issue](#) of The Intelligence Newsletter in order to make us all cognizant of more of the circumstances surrounding the cause and execution of the initial raid. Now for the conflagration, that totally consumed 81 people-men, women and children.

During the later days of the 51 day siege, the spokesmen for the government repeatedly, on a daily basis, gave the impression that David Koresh would be allowed to finish his works on the seals of the book of Revelation. To the Davidians this was most important. It doesn't make any difference what the rest of the world believes. David Koresh believed that the government was going to allow him to finish his writings. Public opinion

was already strongly against the government because of the manner in which they conducted themselves in the case. They repeatedly tried to improve the public's opinion by using selective polls but that wasn't working. The best thing for the Department of Justice to do at that time was to walk away from the scene and let the local sheriff settle the entire matter. But, alas, it is a nation of law. Disregard justice!

In the [March-April issue](#) we stated that the Branch Davidians were "of the Seventh Day Adventist Church." This was a definite error for which we apologize. David Koresh and the Branch Davidians apparently came out of that church years ago but were in no way a part of it now. Information is rather scanty on this issue. The Seventh Day Adventists do not claim his group. Again, we apologize for the error.

Plans were being made by the federal government to end the siege and end it violently. Although Attorney General Janet Reno assumed office after the Waco affair had been set in motion, she did not hesitate in agreeing with the program. Even after the siege ended so violently and abruptly with the fire, she still assumed the responsibility for the government's actions. It is thought that she was doing this simply to insulate her boss, President Clinton, who gave the approval to end the siege on April 19. The American people will undoubtedly remain steadfast in their opinion that the two of them must remain accountable for their actions.

The [Cult Awareness Network](#) (CAN), associated with the [Anti Defamation League](#) (ADL), the [B'Nai-B'Rith](#), and the [World Jewish Congress](#) went into action as the "experts" on cults. Their influence on official government offices is now very well known and the American people must maintain vigilance on investigating and reporting how and why these unofficial and private organizations have so much influence in the United States Government.



**Janet Reno**

Attorney General Janet Reno was, later asked by Representative Hughes of New Jersey at the so-called Congressional hearings, if she had talked to CAN regarding the Feds' actions on April 19. She said she had not. However, she had talked to individuals on the payroll of the government who had been in continual contact with CAN.

The FBI has several psychiatrists and psychologists who are consultants for the Hostage Rescue Team (HRT) based at Quantico, VA. Dr. Park Elliot Dietz and Dr. Murray Miron were both involved in the decision to do what was accomplished on that fateful day.

The FBI sent Dietz to Waco to assess the situation. It was he who told the Feds that child abuse was still going on at the complex. He said that every day that went by increased the risk to the children. That false information resulted from the free exchange of information between CAN and Dietz. Dr. Dietz consulted with Janet Reno and these false reports of child abuse induced her to approve the FBI plan for the April 19 assault. The state of Texas had investigated these child abuse claims by CAN and found them to be false. Yet Dr. Park Dietz of the FBI Hostage Rescue Team passed them on to the Attorney General and the children died a horrible death, to save them from child abuse!

Dr. Murray Miron, a psycho-linguist at Syracuse University, and also on the federal payroll, told the FBI that Koresh was a psychopath and that society must use force to enforce the rule of law. He assured the FBI that their plan for April 19 was the most benign!

Another man, already infamous for his indiscretions against American citizens under the color of law, is Department of Justice official Mark Richard. It was Mark Richard who briefed

Janet Reno on a continual basis regarding the Waco siege and the FBI plan for the April 19th attack.

Mr. Mark Richard is also the DOJ official who, while in contact with the Mossad and the KGB, assisted in the setting up of the Office of Special Investigations (OSI) within the Department of Justice. It was the OSI that forced, under armed guards, the extradition of John Demjanjuk to Israel for trial as Ivan the Terrible, all the while knowing that it was a case of mistaken identity. Karl Linas was sent to his death in Moscow for similar reasons and again he was innocent. The elderly and bedfast Artukovic was sent back to the then Soviet Union strapped to a stretcher on similar charges where he also died.

These are the "experts" and "specialists" who conducted the "psychological profiles" on David Koresh and the other Davidians at Waco. These men already had extensive relationships with the [Cult Awareness Network](#) and the [Anti Defamation League](#) but certain men in Congress want an even closer relationship. We will discuss this point in more detail later.

These men work for the Hostage Rescue Team (HRT) and it was the Hostage Rescue Team unit at Quantico that conducted the psychological profile on the Weaver family. They found Vicki Weaver to have the proper profile to be shot in the head while holding her ten-months-old baby in her arms!

At 6 A.M., the morning of April 19, Parkland Hospital in Dallas, as well as other major hospitals in that part of Texas, received telephone calls with the question of how many trauma beds they had available. This would have included burn victims. Fire fighting equipment was not made available for the plan with the explanation that there was no water available. They did not, or would not, consider laying proper fire hoses along the road's borrow ditches as close as they could and have pumpers standing by at the large bodies of waters in the area. They knew their plan was hazardous. They knew a very strong wind was blowing that day and even if there were no other circumstances to consider that was reason enough to know that even a small fire would soon get out of hand.

They removed all of the vehicles parked close to the buildings in order to observe any people trying to exit the building. They laid concertina wire around the perimeter of the building, again to keep any exiting people from getting past that barricade. It is reported that the on-site [Cult Awareness Network](#) psychiatrists made these suggestions to the federal officers in charge. However, because of what they then did, they didn't need to be concerned with Davidians coming out and trying to escape.

All thinking people of the world, by now, know that the government utilized Combat Engineer Vehicles (CEV) to pump into the complex buildings what was described by the FBI agents as a very mild form of tear gas. The spokesmen for the Feds used an extraordinary amount of time to explain that the gas was non-flammable and was perfectly safe for even the babies within the complex. It was simply a mild gas that would cause the members of the church to want to surrender. They used such terms as "a mother's instincts" to bring out her baby.

Giving the agents-in-charge in the field the benefit of doubt, no one will probably ever know if they knew what was really being pumped into the complex. But officials in Washington knew. According to an excellent report given in the May 1993 issue of the newsletter *Criminal Politics*, P.O. Box 37812, Cincinnati, OH 45222, the following information is extracted regarding the "very mild tear gas."

"Gen. Carl Steiner of the U.S. Special Operations Command confirmed that the FBI consulted with military commanders on the use of CS...and knew full well it would incapacitate the victims and cause them unbelievable agony!"

Quoting from the *Washington Times*, the newsletter *Criminal Politics* continues, "The Times interviewed a chemical warfare expert, Benjamin C. Garrett, executive director of the Chemical and Biological Arms Control Institute of Alexandria, Virginia, outside the nation's capital. This chemical expert said, `It would have panicked the children. Their eyes would have involuntarily shut. Their skin would have crawled and burned. They would have been gasping for air and would have been coughing wildly."

"Eventually, said Mr. Garrett, they would have been overcome with vomiting and a final hell. Gas masks would have been of no use because powder clogs up any gas mask now in use. The Branch Davidians would have been unable to run and attempt to gather up children and leave the building. They would have been instantly incapacitated."

A spokesman for the Center for Constitutional Rights, located in New York City, obtained a copy of the manual published by the manufacturer of this chemical named CS. The manual specifically states that the "chemical can kill people in a closed room in eight minutes." The manufacturer of the CS chemical (it is technically a chemical and not a gas) is Federal Laboratories, a subsidiary of Transtechnology, Inc.

Federal Laboratories had been selling the chemical to the government of Israel. During the first part of 1988 there were 40 Palestinians killed by the CS powder. The Center for Constitutional Rights initiated a lawsuit against the manufacturer of the chemical on behalf of the Palestinian families.

Because of the deaths of the 40 Palestinians, and as a result of other tests, the CS chemical WAS BANNED FOR USE IN WARFARE! This came as a result of an international treaty in January 1993! The ink on the signatures on this treaty was not even dry yet when it was used against women and children in Waco, Texas. It was used against children who were being "rescued" from an unproven charge of child abuse.

Doesn't it seem a dichotomy when we Americans are told that an international treaty takes precedence over even the Constitution when it relates to the "New World Order" but when it applies to what is loosely called "law enforcement," the same international treaties are ignored? Does it make sense to say that "we are a nation of law" except as it applies to "law enforcement?"

In a White House Press Conference on April 22, 1993, Mr. Stephanopoulos was asked the question by a reporter, "How can the CS chemical be used in law enforcement when it is unacceptable in war? What is the rationale for having it in one and not the other?" Stephanopoulos answered by saying, "It's just that there are certain kinds of gases that are appropriate for law enforcement. This was just a general treaty that bans it for international incidents."

So the White House knew of the treaty and the type of chemical that was being used. They had been forewarned of its dangers by gas warfare experts and the information was ignored.

Amnesty International has picked up on this misuse of raw, totalitarian power displayed at Waco. Again, from the newsletter *Criminal Politics* we read, "On April 28th, the Gannett News- Service did reveal that Amnesty International would be investigating federal government activity for human rights violations. After taking over the presidency of the organization, Pierre Sane, the new United States Secretary General of Amnesty

International, said he had asked Attorney General Janet Reno for detailed information about the government's actions that led to the destruction and death of April 19th. Mr. Sane met Monday, April 26th, with Undersecretary of State Timothy Wirth to inquire into the matter. Wholehearted U.S. cooperation would help pull down a veil of silence over abuses worldwide."

Mr. Pierre Sane, in referring to "abuses worldwide" was referring to incidents such as burying Iraqi soldiers alive with bulldozers, intentionally killing thousands of Iraqi citizens, the feeding of starving women and children in Somalia and then killing them with helicopter fire in retaliation for the deaths of 27 UN troops. The news media was alive with such statements as, "We must teach them the rules of law."

Is the United States Government concerned about these accusations by, not only the American news media but by such international organizations as Amnesty International? There are indications that at least certain members of Congress want to increase, not decrease, the relationship of CAN, ADL and WJC with the Department of Justice.

All freedom and liberty-loving Americans were hoping and praying that the announced House Judiciary Committee hearing to review the Civil Rights aspects of the Waco debacle would finally get Congress to understand what is happening in modern America. However, at the hearings held on April 28 it was obvious to us all that a massive cover-up was being made. There was no intention of Congress to redress the Department of Justice and the President for their actions.

The only positive action that came from that one-day hearing is that the ATF is under attack and its director Stephen Higgins will probably be fired. In other words, one man is being made the scapegoat. Congress and the Executive Branch will be like Pontius Pilate and wash their hands of the affair, which of course, is quoted in the Bible. However, he was ridiculing the Jews because the saying originally came from the Talmud.

Instead of decreasing the use of these outside organizations, with their own agenda to pursue, it is now being suggested that the FBI and DOJ make more use of them. Rep. William Hughes (D-N.J.) stressed the need for a closer relationship with CAN, its parent organization, the American Family Foundation and the ADL. He asked Janet Reno if she had talked to CAN. When she said no, he reminded her that these organizations have developed a great deal of expertise on cults. He then went on to state that he knew that the CIA had earlier done some studies on mind control but "we have done very little." He must believe, from that statement that the CIA is not a part of the United States Government!

Mr. Hughes continued by stating that he recognized that there were some very serious First Amendment questions involved but that we need to have a lot more information on these cults in order for us to deal with them. What he apparently said is that Congress and DOJ does not need to concern themselves with the First Amendment. Hughes went on to comment that he had been in close contact with CAN for many months and he hoped that "we can learn from their expertise."

Rep. Hughes then questioned the FBI. He asked them if they had used any experts on mind control and cults. The FBI responded by saying they rely heavily on their own experts and that the FBI cannot gather information on individuals or groups unless someone makes accusations of a crime having been committed.

Somewhere between these hearings and other discussions with the FBI regarding the agency's knowledge of cults, there appears to have been a situation where the left hand didn't know what the right hand was doing. During the hearing itself, Special Agent Jeff Jamar responded to Rep. Hughes questioning regarding the FBI gathering data on cults. Mr.

Jamar stated that the FBI's "behavioral scientist consultants" have done extensive studies on cults and they have prepared a "White Paper" on cults and have profiled "psychopathic cult leaders." It is this writer's opinion that they have done exactly that and in all probability, the list of those profiled will be very extensive. Pastor Robert McCurry of Heritage Baptist Church, Sharpsburg, Georgia asked the FBI for a copy of that "White Paper" and was told that no such paper existed!

It has become very obvious, not only to this writer, but to many of the analysts across the nation that the culprits behind all of this misuse of government power are the organizations associated with the Anti Defamation League (and its parent organizations) along with the occultic, mind controlling organizations within the Eastern Establishment and England.

Associated with those organizations and apparently playing a big part in this attack on First Amendment rights are the local Ministerial Alliances and the various Interfaith Counsels, along with some Campus Ministries. The Cult Awareness Network advertised that anyone could telephone their Chicago office to determine if a person's own church is being studied by CAN. A telephone call was placed asking the Chicago office of CAN if the LaPorte Church of Christ was listed. The woman there responded in the affirmative and said to make contact with the Religious Movement Resource Center, located in Fort Collins, Colo. The organization is sponsored by the Interfaith Counsel and the United Campus Ministry!

The purpose of the Religious Movement Resource Center is to provide workshops on new religious and political movements, a library and literature from the movements with a sociological and critical commentary and counseling with individuals and families because of involvement with the subject religious movements. The Fort Collins Religious Movement Resource Center very obviously is a part of the networking with the Cult Awareness Network and the ADL. If this is the case in Fort Collins, then it is highly probable that the same situation is occurring across the nation.

The [Cult Awareness Network](#) itself has had so-called Christian ministers as head of their organization. It is reported that in October, 1990, Rev. Michael Rokos, who was then president of CAN, resigned after he was arrested in Baltimore for soliciting sex with a vice squad officer posing as a minor.

Just what kind of people are these that Rep. Hughes (D-N.J.) wants to commingle with the Department of Justice personnel so that the government has a better knowledge of what they term cults and a psychological profile on their leaders?

According to Edward Spannaus, one of the more knowledgeable men in America on the Cult Awareness Network, the Washington D.C. radio station WAMU-FM interviewed Cynthia Kisser, the executive director of CAN. During the interview she made it quite clear that the federal government must create a centralized computer file on all so-called cults and their members and leaders. She went as far as to say that the government should arrest what they would term violence-prone leaders.

The news media is carrying out their part of this mass psychology. They are constantly interviewing such men as Galen Kelley and Rick Ross, whom CAN describes as their most effective deprogrammers. Rick Ross was the principal CAN operative on site at Waco and he was an advisor to the FBI. Mr. Rick Ross is wanted for kidnapping in the Northwest and he is a convicted jewel thief and pled guilty to charges of conspiracy to commit grand theft. A convicted thief is being used as advisor to the FBI on organizations that are not politically correct!

Mr. Spannaus also reported that Galen Kelly, the other "expert" that Rep. Hughes wants to be closely aligned with the FBI, was indicted on Feb. 28 in Alexandria, Virginia on felony charges of kidnapping the wrong person on one of CAN's kidnapping, deprogramming and reprogramming escapades. Mr. Kelly very narrowly escaped conviction in 1992 for another kidnapping in Alexandria.

When we analyze what they are trying to do, we see the age old system of Hegelian Dialectics as modified by Carl Marx's Dialectical Materialism. A group of ordinary low class criminal hoodlums have been selected because of their expertise in a form of hypnotism and charisma. The charge of Dialectical Materialism is being used because of the background surrounding Jim Jones, the infamous cult leader who caused the death of hundreds of followers at his camp in Guyana, South America.

From data supplied by Edward Spannaus, we learn that Rabbi Maurice Davis, who is or was a member of the Cult Awareness Network advisory board, worked with and sponsored Galen Kelly. He also arranged for the well known Jim Jones to use an empty synagogue in Indianapolis for his early activities. Jim Jones then moved to San Francisco and his church became known as the People's Temple. We know Jim Jones by his activities in Guyana. Rabbi Maurice Davis was also associated with the CIA MK-Ultra program that was discussed briefly in the [March-April issue](#). The Rabbi worked closely with a Dr. Harris Isbell in the Lexington, Kentucky federal prison. The CIA MK-Ultra program included the intentional administering of LSD to federal prisoners to evaluate the drug's use in mind control and modification.

The [March-April issue](#) also discussed the members of the Cult Awareness Network and the American Family Foundation. Please refer to that issue to review the work of these individuals. It is important for us to realize that all of these individuals network together and with the [Anti Defamation League](#) of the [B'Nai-B'Rith](#) and the World Jewish Congress.

The ADL has been operating an intelligence network since their inception in 1917. Every few years one of their agents becomes a little careless and some alert newspaper investigative reporter writes an article regarding this illegal activity. The local District Attorney, perhaps not realizing the full ramifications of his actions, orders an investigation. Pressure from the public, especially people who love their country for what it is supposed to stand for, causes even officials of the federal government to make their usual statement, "It wasn't me, it was him!"

That is exactly what happened in the San Francisco and Los Angeles areas this year. On April 8th, while the ADL associated Cult Awareness Network was doing its ugly deeds at Waco, The FBI raided the San Francisco and Los Angeles offices of the ADL. They had warrants to seize documents that would prove to be evidence of their illegal spy operations. The San Francisco District Attorney, Arlo Smith, stated that already there is sufficient evidence to prove that the intelligence network is nation-wide and that the investigation is to probe into illegal possession of government data, tax evasion, solicitation of violence and foreign espionage. The initial evaluation of the data removed from the San Francisco ADL office alone shows that files on over 12,000 American citizens was being kept. It was stated that when, or if, they investigate all ADL offices, they will undoubtedly find files on millions of Americans.

The files reveal that the ADL kept information on organizations and individuals from all parts of the political spectrum, from the radical left to the radical right. The central issue in their investigations seems to be whether the group or individual was a political enemy of world-wide Jewry.

This is not the first time that the ADL has come under scrutiny and been caught for illegal spying. In every case, they mount a vigorous counterattack by first claiming "antisemitism." This charge, made violently and loudly, has always worked in the past. Abe Foxman, ADL executive director, said, "I see antisemitism. For me, this fight isn't over yet. The legal issue has not yet been determined. But when that's over, I think the Jewish community must send a very strong message that there's a legitimacy to what we're doing and a price to pay for those who think they can destroy our ability to stand up to do what we believe is our constitutional right." That appears to me to be a rather straightforward threat of retaliation.

In all probability, it will be Judeo-Christian organizations like the Interfaith Counsel and the Religious Movement Resource Center discussed earlier that will help the ADL in this time of trouble for them. But we must not let this happen. We must keep the pressure on by demanding that the government at all levels stop exchanging data with these organizations. We must impress upon them that the government itself is the one at fault for cases such as the Jonathan Pollard spy scandal. We must impress upon them that they wouldn't have done what they did in the Gordon Kahl case, the Arthur Kirk case, The Randy Weaver case, the Waco case, and the hundreds of others if they hadn't listened to these organizations with their un-American political agenda.

God has given us a window of opportunity. He, in all of His infinite wisdom, has caused the wheels to start falling off of their chariots. God has caused the mistakes to be made by the government in all of these cases. How else can we understand it? The government agents are trained to a much higher degree than their actions have displayed in these cases.

We are figuratively up against the Red Sea. We have nowhere to go but God will fight for us if we will let him. *"And Moses said unto the people, Fear ye not, stand still, and see the salvation of the Lord, which he will shew to you today: for the Egyptians whom ye have seen to day, ye shall see them again no more forever. The Lord shall fight for you and ye shall hold your peace. And the Lord said unto Moses, Wherefore criest thou unto me? Speak unto the children of Israel, that they go forward:"* ([Ex 14:13-15](#))
