### **For Immediate Release:**

**On April 10 at approximately 4:45 PM, P.O. Kaitlyn Maglione was dispatched to a local medical office to take a report of theft. The office manager reported that she received a call from the Hawthorne Police Department advising that they had detained a female who was in possession of two blank prescriptions from the office. The subsequent investigation conducted by Detective Sergeant Kevin Kasak resulted in the arrest of Yazmera Colvin, Paterson NJ, age; 25. On April 23, he signed a criminal complaint against Colvin charging her with two counts of theft. She is scheduled to appear in court.**

**On April 14 at approximately 3:00 PM, P.O. Kenneth Marcoux received a report from a local gas station about a theft that occurred in the past. The attendant stated that approximately one week earlier, a customer asked for \$20.00 of gasoline and a pack of cigarettes. She advised the attendant that she did not have the money but provided her name and phone number along with a promise to return and make payment. The matter was referred to the Detective Bureau for further investigation. On April 22, Det. Sgt. Kevin Kasak signed a criminal complaint against Jan Cappelli, East Rutherford NJ, age; 60. She was charged with one count of theft and is scheduled to appear in court.**

**On April 21 at approximately 9:15 PM, P.O. Michael Flim was patrolling on Franklin Avenue. He observed that the operator of a gray Toyota SUV was having difficulty maintaining a lane of travel. The vehicle was stopped and the subsequent investigation resulted in the arrest of Algis Setikas, Wyckoff NJ, age; 49. He was transported into headquarters and charged on motor vehicle summonses with driving while intoxicated, refusal to consent to breath tests, reckless driving, failure to maintain a lane, driving while**

**under the influence in a school zone, and unclear plates. He was released to the custody of a family member. His vehicle was impounded and held for 12 hours under John's Law.**

**On May 8 at approximately 2:00 PM, P.O. Robert Schlossberg observed a blue Hyundai travelling on Route 208 North. He noted that the driver appeared to be having difficulty maintaining a lane of travel. The vehicle was stopped and the subsequent investigation resulted in the arrests of Jason Russio, Montvale NJ, age; 29 and Matthew Kramer, Nyack NY, age; 30. Russio was charged with three counts of possession of a controlled dangerous substance, possession of narcotics paraphernalia, and possession of hypodermic needles. He was processed and turned over to the custody of the Bergen County Sheriff's Office. Kramer was charged with four counts of possession of a controlled dangerous substance, possession of narcotics paraphernalia, and possession of hypodermic needles. He was also issued motor vehicle summonses for failure to maintain a lane and possession of a controlled dangerous substance in a motor vehicle. He was released pending a court date.**

**On May 10 at approximately 10:00 PM, P.O. Kyle Ferreira observed a black Hyundai travelling on Route 208 North in excess of the posted speed limit. The vehicle was stopped and the subsequent investigation resulted in the arrest of Lauryn Altman, Elmwood Park, NJ, age; 19. She was charged with possession of marijuana under 50 grams and released from custody pending a court date.**

**On May 15 at approximately 6:30 AM, Sgt. Daniel Kellogg and P.O. Michael Flim were dispatched to Patton Place on a report of a pedestrian struck by a motor vehicle. A 34 year old Wyckoff woman was jogging when she was struck by a vehicle being driven by a 42 year old Wyckoff man. The jogger sustained non-life threatening injuries and was transported to a local hospital by the Wyckoff Ambulance Corps. No summonses were issued and the matter was forwarded to the traffic bureau for further investigation.**

***The Wyckoff Police Department would like to point out that the above individuals have been charged with a crime, offense, and or motor vehicle violations. However, they are presumed innocent unless and until they are found guilty in a court of law.***
