

## **When Parents Lose Control of the Development of Their Children's Moral Compass**

The condition of the society is plunging deeper and deeper into an abyss of ungodliness. "The Rocklin Academy School (in Rocklin, CA) board is facing tough questions from parents concerned over a controversial incident involving transgender discussions inside a kindergarten class." Concerning the teacher involved, she said, "I'm so proud of my students, it was never my intent to harm any students but to help them through a difficult situation. The teacher defended her actions to read two children's books about transgenderism including one titled "I am Jazz." She says the books were given to her by a transgender child going through a transition." There are so many things wrong with that last statement!
