In any way they see fit for promotion, coverage or benefit of the event, without compensation to any of them, so long as the use neither jeopardizes amateur status nor endorses a specific product or service and to invasion of privacy, right of publicity or to misappropriations; and 5. Agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk or serious injury or death and by participating they expressly assume any and all risks of injury or loss and they agree to indemnify and hold the competition and their officials, directors, employees and agents harmless from and against all claims including for any injury or loss suffered during or in connection with the competition whether or not such claim, injury or loss resulted directly from the negligent acts or indirectly from the negligent acts or omission of said officials, directors, employees or agents of competition.*
