VOTING OPTIONS AND INSTRUCTIONS FOR THE BALLOT

VOTE BY MAILING BALLOT: Mark your ballot for five (5) nominees. Insert only the **ballot portion (below)** in your own envelope addressed to LBVCA Ballots, 12477 Lodge Drive, Garfield, AR 72732, **place your name and return address on the envelope**, and mail it **to be received by** no later than Wednesday, March 11, 2015.

VOTE IN PERSON: Mark your ballot as described above; insert only the **ballot portion** in your own envelope, **place your name and return address on the envelope** and **DEPOSIT IT IN THE BALLOT BOX** in the Community Association office **before 12:00 noon, Wednesday, March 11, 2015.**

DO NOT ENCLOSE MAINTENANCE ASSESSMENT CHECKS IN WITH YOUR BALLOT AS THE **BALLOTS WILL NOT BE OPENED UNTIL MARCH 11, 2015. ANNUAL MAINTENANCE ASSESSMENTS, IF NOT PAID BY FEBRUARY 15, 2015, BECOME DELINQUENT ACCOUNTS.**
