### RULE CHANGES: (PREVIOUSLY FROM JANUARY)

<u>UPDATE</u>: Player/Coach Communication Equipment (1-6-1; 1-6-2) Should the head coach designate an assistant coach to communicate with the catcher while on defense, this would be legal. The assistant coach must be in the dugout area while communicating with the catcher.

<u>UPDATE:</u> Non-electronic communication devices worn by the pitcher must be a solid color (not gray or white) and worn on the non-pitching arm. Should the "wristband device" have a white paper background, the device must have a flap or cover to hide the white paper background.

Remember, our Association meeting on March 27, 2024 will be our Rules Interpretation meeting. You must attend this mandatory meeting to officiate high school games.

<u>Cadet Class</u>: Training classes continue and (15) cadets are attending and will most likely become umpires with our Association.

NJSIAA Exam: The baseball exam is now open until June 1, 2024; however, you must pass the exam with a minimum score of 80 before April 1, 2024 to be eligible to officiate high school games! If you miss passing the test the first time, you will be allowed to re-test.

Please don't hesitate to provide any recommendations you feel would be beneficial. Good luck and best wishes to all for a successful baseball season!

# Assignor's Korner:

By the time you read this, the Crew Chiefs have met and drafted who they wanted as crew members. Hopefully, you have heard something from your chief by now.

The focus for the chiefs and assistant chiefs is to help you attain the next level of umpiring. As the assignor, I ask that you keep an open mind when being critiqued by your chief or assistant. The goal is to make you think and make you better. Listen to what they have to say.

If you end up working games as a single umpire it is expected that you move out from behind the plate to the proper calling positions on the field. This requires some hustle to get those positions. More than likely, you may not get to the proper position, so angle over distance.

Remember, to call "Time" after the play is over and are moving back to the plate. There is nothing more embarrassing than turning your back and someone makes a play which you did not see. Remember, to keep your attention focused on the ball. Nothing can happen without the ball.

Once "Time" is called, move to the plate. When everyone is ready, put the ball in play. A point or a beckoning motion to the pitcher is sufficient. You can also verbalize with the point. Sometimes, people forget to put the ball in play; that happens. It is generally accepted that when the batter is in the box, the catcher is in position to receive the pitch and the pitcher is on the rubber, the ball is in play. To avoid any confusion, put the ball in play.

Final note, please keep your availability updated. I am assigning now. If you try to block a date and you are having issues, more than likely you have been assigned and I just have not released the games. Remember to register with the state.
