#### A. Consider and Discuss Resolution No. 2020-04-27

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CISCO, TEXAS, FINDING THAT AEP TEXAS INC.'S APPLICATION TO AMEND ITS DISTRIBUTION COST RECOVERY FACTORS TO INCREASE DISTRIBUTION RATES WITHIN THE CITY SHOULD BE DENIED; AUTHORIZING PARTICIPATION WITH THE CITIES SERVED BY AEP TEXAS; AUTHORIZING HIRING OF LEGAL COUNSEL; FINDING THAT THE CITY'S REASONABLE RATE CASE EXPENSES SHALL BE REIMBURSED BY THE COMPANY; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; REQUIRING NOTICE OF THIS RESOLUTION TO THE COMPANY AND LEGAL COUNSEL.

#### B. Consider and Discuss New Lake Lot Leases for City Owned Properties.

Mr. Archer outlined the changes made from the old lease including a firm due date for delinquent payments, that lake lot are not for commercial purposes, and a change to the elevation for building. He went on to suggest a couple of amendments including a change on the tall grass and weeds provision to match with the city ordinance, and to require a city burn permit for any brush burning. Councilmember Forester asked if this revised lease would be only for new lessees to which Mr. Archer answered affirmative, stating that at some time in the future all lessees may be asked to move to the new lease for continuity purposes, but as for now, just new lessees.
