### **8:00-11:00 Skill Building Series: Contact Proofing and Front Cross/Blind Cross Techniques**

This workshop series will focus on teaching and applying skills needed for a complete agility toolbox to rely on in all competition settings. For this month, we will look at proofing contacts and discussing the finer details of efficient front and blind crosses. Special requests are taken into consideration for monthly topics!

### **11:30-2:30 Handling Foundations Series: Beginning to Sequence**

This workshop series features independent workshops (jump in with us at any time!) that will focus on building a strong handling foundation for the young dog. This month's workshop will focus on beginning to put obstacles together. How to carefully build number of obstacles while keeping enthusiasm, speed and accuracy will be discussed. The workshop is appropriate for dogs 8 months and older.

### **3:00-6:00 Mastering the Course**

This workshop will focus on the best overall strategies for each dog/handler team to maximize strengths and efficiency on course. We will explore which handling choices/dog paths are faster and look for the best possible ways for team to navigate through the course.
