Shades of Gray March 5—April 24

Open to all original work created entirely in black, white, and gray. Photographs, paintings, etchings, or drawings created in black, white, and gray are eligible, including (but not limited to) graphite, charcoal, pastel, chalk, colored pencil, pen-and-ink, mixed media, ballpoint pen, scratchboard. Work must be exclusively in black, white, and gray; entries on white/black/gray paper are allowed. Work involving other colors or on other tones of paper are not permitted.

Jury Fee: The non-refundable jury fee is \$35 for TNPS members, \$50 for non-members. Each fee allows you to submit up to three (3) entries per show.

Acceptance and Exhibiting. Artists accepted will receive information pertinent to drop off, pick up dates and times, opening dates, etc. Only accepted work is allowed for exhibition. All work is to remain on exhibit for the duration of the show. TNPS reserves the right to refuse any work damaged or deemed too fragile for exhibition.

Specifications: Maximum dimensions - 48"H x 48"W. Weight limit: 40 lbs.

Framing: Wired and ready for hanging. No other types of hangers are allowed. All other work must be ready to install. TNPS reserves the right to install accepted works in a manner deemed necessary for exhibit or security reasons. Please attach the following information to the back of your work: your name, title, medium, and sale price.

Submissions: Images of work may be submitted by email or regular mail. All images must be labeled clearly in whatever format chosen.

Online: Images must be in JPG format. The entry form may be scanned or the information emailed to nps@grics.net. Payment may be made online via PayPal to nps@grics.net.

Mail: Send application, payment and materials to The Next Picture Show,113 West First Street, Dixon, IL 61021.

Sales: Exhibited works will be considered for sale at the price indicated during the submission process. Works not for sale must be designated "NFS". We recommend a 25% donation of the retail price for any artwork sold.

Insurance and Liability: Artists are responsible for insuring their work in transit to and from TNPS. TNPS provides minimal insurance for work while on TNPS premises.

Publicity: TNPS reserves the right to photograph all exhibited work for publicity purposes.

Jurying: Only entries postmarked by indicated deadlines will be considered. All CDs and pictures will be retained until the show closes.

Awards: Best of Show, 1st, 2nd, 3rd, and Honorable Mention (may be more than one).
