LA PAZ FAITH



Rental of the premises: The property municipally known and numbered as 1201 N. Piedras St. El Paso, TX 79930 and more fully described as **La Paz Faith**.

Cancellation: In the event of cancellation all parties agree that the deposit and any donation made to date, is non-refundable.

Final Payment: Payment in full must be made 15 days prior to the event. Failure to do so is considered an automatic cancelation of your event. Checks should be made payable to La Paz Faith Center.

Acceptable Methods of Payment: debit/credit or check!

No smoking or pets: Smoking is not permitted inside or within 500 ft. of any entry way. Any animals must be approved by management prior to being brought in.
