

## HUNTINGTON TOWNSHIP TRUSTEES 45955 STATE ROUTE 162 WELLINGTON OHIO 44090

Minutes of December 30, 2017

The Huntington Township Trustees met in special session at 10:00 AM at the Township Hall. The meeting was called to order with the pledge of Allegiance by Walter Rollin. Also present were: Jed Lamb, Robert Holmes, Dennis Finkel, Frances Rollin, Dimitri Szynal and Sheila Lanning.

*Motion* by Lamb with a second by Holmes to approve the minutes of the December 18, 2017 regular scheduled meeting as written. Roll call: 3 yeas. Warrants (8084-8103) and charges totaling \$15,074.91 were examined and approved for payment.

Rollin reported: none

**Jed reported:** Took Oath of Office at Lorain County Township Association meeting. Copy to Lanning to provide to OTARMA insurance.

**Holmes reported:** Consortium looking at going out to bids for curbside pickup. Happy with Rumpke but some people want to go out to bid. If Consortium breaks up the money would be given back to the member Communities. Lamb stated that if the Consortium breaks up the money should go back to the member Communities. No one came forward to purchase the older International Truck.

**Fiscal Officer reported:** Mileage reimbursement for 2018 is \$.545 per mile. Settled dispute with Lorain County Solid Waste over the receipts and invoices provided for the Incentive Grant. Resolution 2017-44 sent to Budget Commission and Certificate received. October and November Landfill monitoring reports sent to Sabo/Ohio EPA and Katrina Snyder. Holmes suggested a copy of EPA letter indicating a depression/hole on Landfill property be sent to Sabo. Safety Grant for \$500.00 submitted to OTARMA. Rumpke mailer sent for review by Trustees. Cost of Living set at 2%, Maximum Social Security earnings for 2018 \$128,400.00. Sent spreadsheet to Trustees to review in preparation of first meeting of year pay reviews. UAN end of year update installed. Closing Melway purchase order, still showing balance of \$3,246.90. Contract was \$101,886.00 OPWC paid \$84,550.00 Township paid \$14,089.10. Will work on Gratis plates for new International truck.

**Road Foreman reported:** Would like to file for Storm Water Grant for replacing culvert pipe on Baker Road. *Motion* by Lamb with a second by Rollin to authorize filing for Grant from Storm Water District of \$11,900.00 for culvert pipe replacement. Roll call: 3 yeas. Checked into the cost of replacement cutting edges at Judco. *Motion* by Rollin with a second by Holmes to authorize the purchase of cutting edges. Roll call: 3 yeas.

**Public comments:** Frances Rollin said the Church as a food and clothing bank, if anyone knows of someone in need.

*Motion* by Holmes with a second by Lamb to adjourn. All favorable, meeting adjourned at 10:32 AM.
