2024 WINTER CLOSING AGREEMENT

- Winterizing the Pool:** **\$395.00**
This includes lowering water level 2 to 3 inches below skimmer (depending on the cover type) and/or, removing drain plugs from equipment, blowing all lines with air compressor, and then inserting a winter plug. Filter and pool parts will be left clean and ready for storage. It is the customers responsibility for storing away filter and pool parts. Price does not include plugs, blocks, OR ANY CHEMICALS THAT MAY NEED TO BE ADDED TO THE POOL. Price does not include any fresh water lines. Pool is not vacuumed unless requested.

Please leave winterization plugs by the filter equipment. If plugs are unavailable, new ones will be supplied at additional cost. If Oasis technician feels plugs will not hold through the winter, new ones will be provided and charged accordingly **NO EXCEPTIONS.*

*Additional charge for pools with attached spas, Anthony Caretaker Systems, or other water fixtures such as water falls, vanishing edges, extra pumps... **\$55.00 EA.**

- Custom Mesh** **\$110.00**
We will raise pop-ups and position cover in place. Price does not include any repairs or replacements of pop-ups.
