NEWS YOU SHOULDN'T MISS

<u>Our SCHOLARSHIP process</u> is underway with the selection of three students from Stephen Decatur High School. After personal interviews with each of these students, one will receive a certificate for the \$1000.00 Scholarship, that our Chapter 1917 presents to a deserving student.

<u>DRUG DISPOSAL PROCESS</u> – of old or outdated medicines should be accomplished in the following manner. PLEASE DO NOT FLUSH SOLID DRUGS INTO TOILETS OR SINKS!

INSTEAD,

1) Remove your drugs from their containers and place into a sealed kitchen baggie. Dispose of the empty pill bottles or containers in your trash, after you have blacked out the personal information (name) on the label with a marking pen or soak in hot water and peel off.

The <u>Ocean City Police Department at 65th Street</u> has a white drop box (similar to a mail box) immediately inside the front door. You may drop your bagged and solid pills or gelcaps into this container. You do not need to identify why you are there, as the drug box is well labeled.

2) Put unused or outdated drugs in cat litter and add water or place pills in coffee grounds to destroy.

This manner of waste disposal avoids many drugs from entering ground water and run off systems to overmedicate our water supply and endanger our fish and fauna.

INFORMATIONAL SPEAKERS

March Speakers Dr. David Voxmonsky and Ms. Shannon Jones from Rite Aid, visited AARP in March, lending valuable information relating to safe medication, especially prescription drug use. Much has changed over the past several years enabling many pharmacies to provide convenient access on demand for many routine immunizations and vaccines for flu, pneumonia and other high risk diseases.

Pharmacists recommend a series of safe medication rules for seniors who may be at higher risk for the side effects or adverse effects of prescription and over the counter drugs.

Dr. David and Ms. Sharon encouraged the following:

- 1) Be aware of what you are taking and what it is for, related to your health
- 2) Follow directions on the bottle when taking the medication
- 3) Ask questions of your pharmacist about the medications, if you are unclear
- 4) Talk honestly to your doctor about why he is prescribing your medication
- 5) Make sure your physician knows <u>all the drugs you are taking</u>. Include any over the counter medications, vitamins and other supplements.
- 6) Make sure your spouse or family knows what you are taking and what it is for
- 7) Know that your pharmacy keeps comprehensive records of all drugs you are prescribed
- 8) Your pharmacist can help you understand the value of a certain medication
- Write down questions you have for your physician so you don't forget to ask at your visit

Report any side effects of a new medication to your physician immediately



GRANDKID or FRIEND SCAM ALERT

You get a call: "Grandma, I need money for bail" (or bus/plane home, or a medical bill), or some other kind of trouble. The caller says it's urgent – and tells you to keep it a secret.

But is the caller who you think it is? Scammers are good at pretending to be someone they are not. They can be convincing sometimes using information from social networking sites, or hacking into your loved one's email account, to make it seem more real. And they'll pressure you to send money before you have time to think.

Here's what to do:

- 1). Stop. Check it out. Look up your grandkid's phone number yourself, or call another family member.
- 2). Pass this information on to a friend. You may not have gotten one of these calls, but chances are you know someone who will get one, if they haven't already.

If you spot a scam, REPORT IT TO THE FEDERAL TRADE COMMISSION.
