At 4:00 Bill called the meeting to order.

At 4:05 John made a motion to go into non-public meeting under RSA 91-A. Second by Ed. All in favor.

At 4:20 Ed made a motion to return to Selectmen's meeting. Second by John. All in favor.

Capt. Wilson said that there will be a credit coming back to the Town for an overpayment of \$805.22. He also discussed the yearly contract with the Town for coverage at a rate of \$45,776 per year.

Capt. Wilson reviewed the monthly log. The Board handed him the letter from resident, Autumn Wheelden who requested more speed patrolling on North Shore Road. Capt. Wilson said that he may put up the radar trailer there. Harold will also order more 30 mph speed limit signs.

Holly stated that she is having some problems with Avitar and working with the current assessor assigned to the town. The Board is looking into the matter. The Selectmen suggested that if Holly sees anything that needs to be changed in the Avitar system to please notify the Selectmen and they will contact Avitar to correct the data.

Harold said that the gas pump at the garage is running and there are keys issued to the Fire Department, Parks and Rec. and one for the Ford F250.

Bill and Harold met with Lionel Shute of the Sullivan County Farm and Mr. Shute will put in writing how they would like to take care of their timber.

John made a motion to approve the Minutes of June 18, 2018 as amended. Second by Ed. All in favor.

John reviewed several items that should be under Unfinished Business for the next Selectmen's Meeting such as safety panels for the town offices, generator, white board for Selectmen's conference room.

Ed made a motion to approve Harold's vacation request for July 2, 3, 5, 6, 2018. Second by John. All in favor.

Ed made a motion to sign the tax exemption form for Patriot Trucks. Second by John. All in favor.

John made a motion to sign the PA-28 form for NH DRA. Second by Ed. All in favor.

John made a motion to approve the Intent to Cut for UVLT. Second by Ed. All in favor.

Ed made a motion to have the Chairman sign the MS 60-A for the NH DRA. Second by John. All in favor.

John made a motion to approve and sign the MS-535. Second by Ed. All in favor.

Josh Stevens said that he spoke with Simino Logging company and his price was around \$40,000 for cutting the trees on Center road. Josh suggested just getting truckloads of cord wood to bring down to the abutters whose trees are being taken and replace them with the wood. He received quotes from CCM and North Woodlands. He will do a recalculation on the extra this process.

John said that he is meeting with Patrick Dombroski on Friday to discuss South Koski and Morgan Road. He also suggested doing a Preamble with another town and splitting the cost.

John said that he would like the checklist posted in a public place going forward and he will speak with the Supervisors and or Rosemary again about this.
