A RESOLUTION

Authorizing the honorary naming of Stadium Drive east of Town Street as “Micah Hyde Drive”.

WHEREAS, Fostoria native Micah Hyde finished a very successful athletic and academic high school career graduating from Fostoria City Schools in 2009 after receiving All Ohio Honors for his outstanding high school football career; and

WHEREAS, Micah received a scholarship from the University of Iowa and played football for the university, where he finished a successful academic and athletic career graduating in 2013; and

WHEREAS, Micah was drafted in the fifth round by the Green Bay Packers in 2013 and had a very successful rookie season playing defensive back and returning punts for the Packers, with a memorable 93 yard punt return for a touchdown against the Minnesota Vikings; and

WHEREAS, Micah has since continued his NFL career, signing a contract with the Buffalo Bills in 2017.

WHEREAS, As a proud Fostorian, Micah continues to return to his hometown community to share in his success and give his time to the community working with projects such as the Therapy for All project at Good Shepherd Home; and

WHEREAS, He also started a nonprofit organization, ‘Imagine for Youth,’ committed to supporting youth in athletics and ensuring that lack of equipment is not an impediment to involvement.

WHEREAS, the Mayor and City Council of the City of Fostoria wish to acknowledge and recognize Micah Hyde’s contributions and inspiration for the youth of his hometown.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fostoria, Seneca, Hancock, and Wood Counties, Ohio:

SECTION 1. The Fostoria City Council hereby assigns the honorary name “Micah Hyde Drive” to the segment of Stadium Drive east of Town Street.

SECTION 2. This honorary street naming shall comply with design specifications determined by the Safety Service Director in compliance with the City of Fostoria Codified Ordinances.

SECTION 3. The street sign shall be placed on the signpost at North Town Street and Stadium Drive.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.

SECTION 5. This resolution is necessary to preserve the public health, safety and welfare of the City of Fostoria and its inhabitants.

THEREFORE, upon the affirmative vote of two-thirds (2/3) of all members elected to Council, and signature by the Mayor, this resolution shall go into immediate force and effect.
