Suitable fire extinguishing media:

Specific hazards arising from the chemical:

Flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of subsequent explosion. Transfer contaminated absorbent, soil and other materials to containers for disposal.
