The Pork Board has changed the certification requirements for Pork Quality Assurance. Producers will need to be re-certified under the new protocol. Dr. Coffey held a training for PQA trainer certification in April. Since the certification involves expanded testing and information on site visits, producers should start certification early.

The UK and Kentucky Sheep and Goat Development Office is conducting The Small Ruminant Profit School again this fall. This is a good course for new producers to learn the animal care and business aspects of small ruminant production.

The Sheep and Goat Development Office will also be sponsoring an online breeding stock sale this fall. All animals to be sold will be inspected by a representative of the

Development office. Producers can apply to sell animals, or get more information at kysheepandgoat.org.
