**<u>Roadmaster Report</u>** Roadmaster Borger stated that the road crew been cleaning drains and cutting brush along the shoulders.

# Ordinance 2012-1 An Ordinance Amending the Eldred Township Zoning Ordinance by Deleting Certain Subparagraphs of the Term "Lot Area" From the Definition Section and Deleting Article 704's Application to Lot Joinder/Annexation Applications

Solicitor Kaspszyk stated that the proposed ordinances were both advertised and that a hearing was held on December 7, 2011. The Monroe County Planning Commission and the Township Engineer Brien Kocher had reviewed the ordinances and sent their comments to the township. However, since the Eldred Township Planning Commission was unable to review the proposed ordinances before the hearing, the possible adoption of the ordinances was postponed until this meeting. This amendment would change the **definition of lot size in the Zoning Ordinance**. The Eldred Township Planning Commission recommended that the Board of Supervisors adopt this amendment, which deletes subparagraphs F, G and H from Article III, Section 303; as well as enables the **joining of two parcels into a single parcel**, as long as there is no new development proposed. On motion by Sharon Solt and with a second by Gretchen Gannon Pettit, it was voted to adopt this ordinance as **Ordinance 2012-1.** (3-0)

### Ordinance 2012-2 An Ordinance Amending the Eldred Township Zoning Ordinance by Amending the Provisions Addressing Private Stables

This is the second amendment that was properly advertised and a hearing was held on December 7, 2011. This amendment would **lower the minimum lot size from 5 acres to 2 acres**, in regard to **private stables** on a parcel. Additionally, there are a 50 foot distance from wetlands and a maximum slope of 15% provisions in this amendment. Solicitor Kaspszyk stated that the Zoning Hearing Board has allowed a downsizing of acres needed for private stables at previous zoning board hearings, and said that those actions set a legal precedence. It was noted that the Eldred Township Planning Commission recommended that the Board of Supervisors do not adopt this amendment. There was discussion concerning all aspects. On motion by Gretchen Gannon Pettit and with a second by Sharon Solt, it was voted to adopt this ordinance as **Ordinance 2012-2**. (3-0)

**Other** Solicitor Kaspszyk reported that: 1) There has been a January 17, 2012 hearing scheduled with Magisterial District Justice Jolana Krawitz concerning a notice of violation issued by the township zoning officer. 2) He received a letter from the Attorney General's office stating they are in receipt of a document regarding a case two years ago.

In regard to PEMA's funding of flood related storm damage, the township needs to designate an agent for the township. On motion by Gretchen Gannon Pettit and with a second by Clair Borger, it was voted to adopt **Resolution 2012-1** appointing Sharon Solt to be the designated agent to meet with PEMA relating to the flood damage. (3-0)

Gretchen Gannon Pettit reported that the township has been notified by **DCNR** that they have been awarded a **\$40,000 grant** to begin construction of the **Walter Mock Park**.

**Public Comments** Richard Zilmer commented that he is opposed to the creation of the Walter **Mock Park** on the lot to the east of his house, along with the parking area on the lot to the north of his house. He cited several reasons why he felt that having a park on a property that adjoins his house is unacceptable to him. Solicitor Kaspszyk explained that in the creation of the master site plan all proper procedures were followed, including the Pennsylvania Municipalities Planning Code, the Eldred Township SALDO and the Eldred Township Zoning Ordinance. Solicitor Kaspszyk stated that the township actually sent all surrounding property owners notification letters, which was not mandated by the MPC. Arthur Bender also voiced his concerns since the parking lot property lies to the south of his property. Reiner Jaeckle commented that while he is in favor of the park, he thought another location for the access to the property is needed. Tom Byrne asked that the speed limit be lowered to accommodate cars entering and leaving the park. Archie Craig stated that adjacent to his property on Silver Spring Boulevard there is a large truck facility that came in years after Mr. Craig built his house, but that one has to accept changes. The township Board of Supervisors will take all comments into consideration, however it was noted that changing the access to the park would involve considerable financial cost to the township budget.

There being no further business, Sharon Solt made a motion, with a second by Gretchen Gannon-Pettit, to adjourn the reorganizational meeting at 8:50 p.m.

**<u>Roadmaster Report</u>** Roadmaster Borger stated that the road crew been working around the shop, cleaning and repairing equipment.

**Resolution 2012-1** A Resolution of the Governing Body of Eldred Township, Monroe County, Pennsylvania, Authorizing, Empowering and Directing the Proper Officers of the Governing Board to Appoint a Liaison Between It and Berkheimer, the Duly Appointed Tax Collector of Earned Income and Local Services Tax for the District, for the Express Purpose of Sharing Confidential Tax Information With the District for Official Purposes.

Solicitor Kaspszyk stated that this resolution was needed to appoint a liaison between Berkheimer and the township in reference to gathering information concerning the earned income tax. On motion by Gretchen Gannon Pettit and with a second by Sharon Solt, it was voted to approve Resolution 2012-1 for the appointment of the position of **Secretary** as the liaison between Berkheimer and the township. (3-0)

**Resolution 2012-2** A Resolution Closing Out Community Conservation Partnerships – Grant Project BRC-TAG-14-201 This resolution was requested by Pennsylvania Department of Natural Resources to close out the grant account for the Master Site Plan for the Walter Mock Park. On motion by Sharon Solt and with a second by Gretchen Gannon Pettit, it was voted to adopt Resolution 2012-2 to close out the DCNR grant for the Master Site Plan for the Walter Mock Park. (3-0)

<u>**Court of Common Pleas Rule to Show cause Order No. 11247**</u> Solicitor Kaspszyk explained that a few township properties have been placed up for sale, and this order was to notify the township of the upcoming sale; the properties when sold would be placed back on the tax rolls.

**Auditor's letter dated January 31, 2012 establishing rates for working supervisors**. The board received a letter from the elected auditors, notifying the board that the auditors have set the working supervisors rates at the same rate as 2011; Clair Borger \$20.00, Sharon Solt - \$17.81 and Gretchen Gannon Pettit – \$13.77.

**Extension Request for Lands of Vernon Frable Subdivision Plan** Mr. Frable's surveyor George Fetch submitted a 90 day extension request for the minor subdivision to run until April 30, 2012. On motion by Sharon Solt and with a second by Gretchen Gannon Pettit, it was voted to approve the 90 day extension until April 30, 2012 for the Lands of Vernon Frable Minor Subdivision. (3-0)

**Other** Solicitor Kaspszyk reported that the January 17, 2012 default hearing with Magisterial District Justice Jolana Krawitz concerning a notice of violation issued by the township zoning officer has been continued to February 15, 2012 at 10:00 a.m.

#### Supervisor's Meeting February 1, 2012... page 3 of 3

Sharon Solt explained that the storage room needs shelving and that she has obtained prices from Grainger in the amount of \$650.00 plus \$154.98 shipping. On motion by Sharon Solt and with a second by Gretchen Gannon Pettit, it was voted to approve the purchase of six shelving units at a cost of \$805.08. (3-0)

Gretchen Gannon Pettit reported that the hike at the Walter Mock Park was a great success; they had about 35 people and had to turn away about 15 people.

**Public Comments** Richard Zilmer commented that he is opposed to the creation of the **Walter Mock Park** on the lot to the east of his house, along with the parking area on the lot to the north of his house. He asked if anyone on the board or the solicitor contacted Mrs. Mock about the request to move the parking lot. Solicitor Kaspszyk stated that he talked with Mrs. Mock and she confirmed that she does not wish to allow any more acreage on the portion by the tot lot, to be use for a parking lot. Additionally, in order to move the parking lot, there would be additional engineering costs for the township. Gretchen Gannon Pettit stated that the board felt that moving the parking lot behind the fence row could create vandalism since the lot could not be seen by cars passing by on Church Road. Solicitor Kaspszyk said that in order to change what is in place now, the entire agreement of sale would have to be changed.

Mr. Zilmer said he feels his property value will go down when the park is created. He asked what kind of trees will be planted; the board responded that there is a list, and that they are most likely arborvitae, a fast growing tree used in instances like this. The question of a gate arose; the board responded that the township has been researching on the internet to find various types of gates. The question of who to call if there are trespassers arose; the board said that 9-1-1 or the state police are called for issues such as was suggested. The question of nighttime lighting arose; the board responded that there would be no night time activities, but if lighting were to become an issue the lighting would be of a type that would only light the parking lot, not the surrounding properties. The board suggested that looking at the park with a positive attitude, not a negative attitude, would be of benefit to all surrounding property owners. Mr. Zilmer stated he is still opposed to the park.

Archie Craig said that he has noticed there have been advertisements hanging on various residents' doorknobs and asked if the township had any knowledge of it. The board had not; but another resident said they probably want to sell water purification systems.

### <u>Resolution 2012-4</u> A Resolution Of The Township Of Eldred, Monroe County, Commonwealth Of Pennsylvania Urging The Pennsylvania Assembly To Eliminate Or Amend The State Prevailing Wage Act (Act 442 of 1961)

Clair Borger stated that whenever a project goes over the estimated cost of \$25,000, the state's Prevailing Wage Act (Act 442 of 1961) is activated and the wages that are set by the Secretary of Labor and Industry must be used to determine what wages are paid to employees or contractors. This creates an additional burden on the township and the taxpayers as costs are generally escalated. The Pennsylvania State Association of Township Supervisors has asked townships to adopt a resolution urging the state General Assembly to support and pass House Bills 1329 and 1685, giving relief to the taxpayers by increasing the threshold to \$185,000. On motion by Sharon Solt and with a second by Gretchen Gannon Pettit, it was voted to approve the adoption of Resolution 2012-4 urging the Pennsylvania Assembly to **eliminate or amend the State Prevailing Wage Act** (Act 442 of 1961). (3-0)

Ordinance 2012-3 An Ordinance Of The Township Of Eldred, Monroe County, Pennsylvania, Electing To Amend Its Municipal Pension Plan Administered By The Pennsylvania Municipal Retirement System Pursuant To Article IV Of The Pennsylvania Municipal Retirement Law: Agreeing To Be Bound By All The Provisions Of The Law As Amended And As Applicable To Member Municipalities Clair Borger stated that the township employees participate in the Pennsylvania Municipal Retirement System (PMRS) for their pension funding. At the inception, employees were required to contribute 4% of their wages, while the township contributed 4.5%. Currently, employees wish to contribute up to the ceiling of 20%, therefore an ordinance is needed to administer the changes. There would be no change in the township portion. On motion by Gretchen Gannon Pettit and with a second by Sharon Solt, it was voted to approve the adoption of Ordinance 2012-4, amending the PMRS Retirement Plan. (3-0)

After discussion, on motion by Sharon Solt, with a second to the motion by Gretchen Gannon Pettit, a motion was made to approve waivers one (1), two (2), three (3) and four (4), but to deny waiver five (5). Additionally the motion included that a note be placed on the plan that indicates "By Eldred Township's approval of the plan, the township is not creating, nor extinguishing any pre-existing private right-of-way or easements." The vote was unanimous. (3-0)

#### Recommendation to reject the Subdivision of the Vernon Frable Minor Subdivision

The Eldred Township Planning Commission made a motion to recommend rejection of the Frable Subdivision plan, unless a time extension was submitted prior to the Supervisors' meeting. Surveyor George Fetch submitted a 91 day extension request the morning of this meeting. On motion by Gretchen Gannon Pettit and with a second by Sharon Solt, it was voted to accept the extension request until August 30, 2012. (3-0)

### <u>Other</u>

Solicitor Kaspszyk stated: 1) the Board of Supervisors held an **executive session** prior to the meeting to discuss pending litigation about the **Mock Park** and equity action against Mr. Wingert for his trash transfer station. 2) Mr. Kaspszyk received correspondence from **Alpine Rose Motorsports** concerning the Commonwealth Court's April 25, 2012 affirmation of the PA DEP granting of the DEP permit. Appeal of the Commonwealth Court's opinion would have had to be submitted within 30 days; it was noted that no appeal appears to have been submitted.

Sharon Solt mentioned 1) there are two **Monroe County 175<sup>th</sup> Anniversary Books** available for \$10 each, purchase of the book will include a copy of the 150<sup>th</sup> Anniversary book for free. Helen Mackes has the books; any interested party may see her. 2) there is a **"Design Matters" workshop** available to any planner or supervisor; Sharon has copies of the application.

Gretchen Gannon Pettit stated that the township received **\$20,000** of the \$40,000 grant from **PA DCNR** toward the building of the **Mock Park** and parking lot. This will be used to begin the construction of the facility. There will be committee meetings scheduled, which will be advertised in the Pocono Record and posted on the bulletin board.

Ernest III and Diana A. Laudenslager Minor Subdivision Plan Extension Request The Eldred Township Planning Commission had not received an extension for the Laudenslager plan in a timely manner and had recommended rejection of the plan based on the 8/14/12 engineer comments, unless an extension was filed before the supervisors board meeting. An extension was filed, therefore on motion by Gretchen Gannon Pettit, with a second to the motion by Sharon Solt, unanimous approval was given to accept the **Ernest III and Diana A. Laudenslager Minor Subdivision Plan** extension until October 31, 2012. (3-0)

### Monroe County Industrial Development Authority Tax Increment Finance (TIF) Program

Michele Bisbing, Director of Marketing at the Monroe County Industrial Development Authority, gave a presentation explaining the **TIF program**, which **Alpine Motorsports LLC** has shown an interest in procuring. Basically, once a loan would be secured trough the TIF program, the taxes paid to the township would remain at the current rate, while the increased tax would be paid back to repay the loan. The township would have to adopt a resolution regarding this matter. The Alpine project is estimated to be \$38 million, however only a portion would be involved in the TIF program. The maximum length of time for repayment would be 20 years, and the rate would be a government rate. There was much discussion regarding how the program works, the repayment process, the committee process, and the estimate of increased tax both from the Alpine project and the tax revenue generated by others (non-Alpine holdings).

Sharon Solt made a motion to have Clair Borger serve on the committee, however he declined the motion. He said he would be more comfortable if the plan was approved and signed before we move forward; Gretchen Gannon Pettit agreed. Michele Bisbing stated that an approved plan is not a requirement to move forward to forming the committee. Ms. Bisbing, referring to a document entitled Alpine Motorsports LLC Project Information and Narrative, dated June 30, 2012, said in the first year the township, school and county taxes are estimated to be \$90,000 and the fifth year total tax is estimated to be \$109,000. She added that revenues generated by others are estimated to be \$8,218,000 in the first year and \$12,651,400 by year five. Additionally state tax is estimated to be \$853,000 the first year and \$1,131,400 the fifth year.

Gretchen Gannon Pettit made a motion to table until the school reacts to the idea, or until we get approached by the applicant (Alpine Motorsports LLC) with updated development agreement plans or bond. Sharon Solt made a second to the motion, which was approved. (3-0) Solicitor Kaspszyk asked if the township could have a copy of the Project Information and Narrative and some information on insurance in case the project would default; Ms. Bisbing stated she will obtain that information.

**2013 PMRS Minimum Municipal Obligation** Sharon Solt reported that every year the township prepares a Minimum Municipal Obligation for the following year's Pension Plan. This is the amount that the township pays for their share of the employee's pension plan. Mrs. Solt prepared the obligation, and it must be approved at this board meeting. On motion by Gretchen Gannon Pettit, seconded by Sharon Solt, it was voted to approve the 2013 MMO and forward same to PMRS.

### **Other**

<u>Electronic Recycling Information</u> On motion by Sharon Solt, with a second to the motion by Gretchen Gannon Pettit, unanimous approval was made to secure an electronic recycling container for the month of October from Supreme ASSET Management & Recovery, at a rate of \$.02 per pound for electronics. (3-0)

### **Public Comment**

Philip Marano questioned why there are **two yellow lines** painted on the roads instead of one line. Clair Borger explained that the state can withhold liquid fuels tax money to a township that does not utilize the two yellow lines; therefore we have opted to paint the two lines.

Richard Zilmer asked if there was anything new on the **Mock Park**. Solicitor Kaspszyk said that plans aren't ready to be submitted to the planning commission, and that in reference to potential litigation, he has contacted Mr. Zilmer's attorney regarding aspects of the plan. #### Electronic Recycling Program

Helen Mackes gave a synopsis of The Eldred Township Historical Society's efforts to repair and renovate the historic post office. She said the society has already spent \$6,300.00 for testing for asbestos, mold, etc.; adding that removal of the mercantile will cost approximately \$43,000.00, and another \$20,000.00 to close in the back where the mercantile will be removed. Helen Mackes stated that the society is about \$25,000.00 short to accomplish these projects and said they want to install an alarm system once the removal has been completed. Helen also mentioned that Sunday, October 14<sup>th</sup> at 1 pm, they are holding a (filled) Longaberger basket bingo at the Kunkletown Fire House. The public is welcome to attend; the tickets are \$20.00 each.
