General Meeting Report

On February 15, we held our monthly general meeting and had a roundtable discussion about studio policies. We all think about our policies to different degrees, and our individual experiences shape what we include in our policies and how we communicate these to our students and parents. It was clear from this meeting that there are as many different ways to organize our policies as there are teachers, but there were some underlying themes. The first and foremost of these is that our policies reflect what it is that we prioritize as teachers. Do we work with each student from a different perspective, or do we have enough consistency that we type out our policies? If we write our policies out, do we include clauses about practicing expectations or make-up lessons? Or do we trust the students and parents to understand these things?

There are advantages to writing out our policies, which was a second theme from the meeting. If students and parents have read (and perhaps signed) a policies contract, we can return to it when there are questions or confusions about practicing or financial matters. It can be useful to be able to say "please consult the studio policies" rather than to rehash the policies verbally--writing them out also helps with consistency between students. Another advantage to writing out policies, interestingly, is that once they are written and determined, we can be free during lessons to generally not have to worry about these issues. We can instead focus solely on our students' musical educations so that we can avoid the having to switch back and forth between our teacher and businessperson modes.

We discussed other policy details as well, for example how we set up payment: lesson-by-lesson, or monthly, or tuition-style payments. Each has its advantages, but again, putting these things in writing and being consistent across our students seemed to be what many teachers present felt gave them the most security and generally improves student relationships.

Several teachers offered to share their policies as pdfs, so if any of you reading this blurb would like to see these, or would like to contribute your own policy document as a sample (all names and prices can be omitted, of course), feel free to email me at <u>marclombardino@gmail.com</u>. I hope to see many of you at our next meeting on March 8 for a cello master class with Trevor Handy.
