

**OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS
OF EMMONS COUNTY, NORTH DAKOTA
AT IT'S REGULAR MEETING
AUGUST 2, 2022**

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, David Kalberer and Leonard Weichel being present. Also present was States Attorney Joseph M. Hanson.

The Pledge of Allegiance was recited.

The July, 2022 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Weichel motioned to approve the minutes of the July 5, 2022 regular meeting and the July 19, 2022 special meeting. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Hulm motioned to approve the agenda with the addition of weed cutting fees, Langelier's Bay inspection and Bob Bauman by telephone. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Old and Unfinished Business:

GIS Coordinator, Josh Odden, reported that Mary Senger, DEM, purchased a video system through a cost share grant for the county's use during meetings and trainings. Odden contacted other counties that record their commission meetings and found that video recording and uploading to a you tube channel has been successful and is more cost effective than live streaming. There will be a link on the Emmons County's website that will take the public directly to the you tube channel. The cost share of the grant for the video recording equipment was \$750.00 and the laptop computer was \$1,700.00. There is no cost for the you tube channel.

Josh Odden also reported that the county received approval from the State Court Administrator to hold commission meetings in the courtroom. The commissioners will explore meeting in the courtroom starting in September.

Commissioner Eberle motioned to approve the renewal building permit for Thomas and Dericci Reineke to add a 5 X 20 deck onto the residence and an 8 X 30 deck onto the shop on Lot 219 of Beaver Bay Walthers Scenic Properties Lakeview II, Section 23, Township 132, Range 79. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Weichel motioned to approve the building permit for Senger Farms to move in a 14 X 70 mobile home on the NE ¼ NE ¼ of Section 8, Township 131, Range 74. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the building permit for Kayle Grinsteinner to erect a 12 X 16 storage shed on Lot 204 of Beaver Bay Walther Scenic Properties, Section 23, Township 132, Range 79. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the building permit for Wesley Mastel to erect a 67 X 260 hoop livestock building on the SW ¼ of Section 4, Township 129, Range 74. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the building permit for Kayle Grinsteinner to place a 16 X 20 Pergola on Lot 204 of Beaver Bay Walther Scenic Properties on Section 23, Township 132, Range 79. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the building permit for Jonathan Van Boven to move a 30 X 70 manufactured home on the NE ¼ of Section 1, Township 129, Range 76. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the application and issue a liquor license to Cattail Resort for a one-day event on September 3, 2022 on a tract in the SE ¼ of Section 8, Township 130, Range 79. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Weichel motioned to approve the application and issue a liquor license to the Blue Room for a one-day event held on August 14, 2022 on a portion of the SW ¼ of Section 36, Township 131, Range 76. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Hulm motioned to approve the plat for Gadler LLC, parcel 401, part of Beaver Bay Walther Scenic Properties-Lakeview IV, which is part of Lot 47, Beaver Bay Subdivision, Section 23, Township 132, Range 79. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Hulm motioned to approve the building permit for Joe and Janelle M. Schlosser to move in a 26.8 X 60 mobile home and add a 26 X 26 garage on Lot 1-18, Block 5, Templeton, Section 5, Township 133, Range 76, contingent that the setback is a minimum of 40 feet from the center of the road. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the application for abatement or refund of taxes for parcel #52-0001-00004-000 for tax year 2021. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the application for classification as inundated agricultural land and to approve the application for abatement or refund of taxes for tax year 2022 for parcel #39-0000-01595. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Weichel motioned to approve the application for classification as inundated agricultural land and to approve the applications for abatement or refund of taxes for tax year 2022 for parcel #02-0000-07194-000, #11-0000-06155, #11-0000-06157-000 and #11-0000-06158-000. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Weichel motioned to approve the application for classification as inundated agricultural land and to approve the applications for abatement or refund of taxes for tax year 2022 for parcel #34-0000-02683-000 and 34-0000-02675-000. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Brent Ekstrom, Executive Director for Lewis and Clark Regional Development Council, provided an annual update on the organizations loans and programs that support businesses, local governments and individuals for affordable housing. The organization took over property management from Lutheran Social Services in 2020 and are now managing over 500 units throughout the state. Lewis & Clark Development Groups work with our local banks in providing revolving loans for businesses opening or wanting to expand. The interest rates are determined on a project by project basis, but are generally below the market rate. The organization received \$400,000 in federal CARES Act funds to coordinate and assist with community and economic development throughout the region. Commissioner Weichel is currently serving on the Lewis & Clark Regional Development Board of Directors for Emmons County.

Sharon Jangula and Daniel Imdieke representing Linton City and Roger Martin, LAA Board member, appeared to discuss the ten-year project planning and financials for the Linton Municipal Airport. Sharon Jangula presented the preliminary annual budget for 2023 which estimates a 01/01/2023 beginning balance of \$83,936.11, projected 2023 revenues of \$79,160.00, projected expenses \$133,900.00, transfer out \$60,095.00 for capital improvements, Linton City Airport mill levy \$10,240.00, which leaves a cash deficit of \$20,658.89 for the end of 2023. Only the citizens of Linton City pay property taxes on the airport which is currently at the maximum mill levy of four mills. Linton City is asking the county to levy two mills to help the airport cash flow which would generate approximately \$77,391.60 in property tax revenue. According to the North Dakota Century Code, the county commissioners can adopt a resolution to levy up to four mills for airport or airport authority purposes.

Roger Martin provided a capital improvement plan and map for the airports designs and projects for the next ten years. Projects include apron rehabilitation and improving the access road, seal coat and crack seal airside pavements, runway 9-27 extension and widening and design and construct parallel taxiway for a ten-year project approximate costs of \$4,840,000.00. The FAA shares 90% of the costs (\$4,356,000.00) while the state and NDAC share 5% of the costs.

Roger Martin stated that there are currently three spraying companies that use the airport so he feels that the county should pay their fair share because the spraying does not benefit the city as much as the county.

Commissioner Hulm motioned to adopt a Resolution to create a county airport mill levy for up to two mills. Seconded by Commissioner Weichel. Roll Call "YES": Hulm and Weichel. "NO": Eberle, Kalberer and Magrum. Motion failed.

Chairman Magrum stated that he does not disagree with the merits of the levy, but felt that since it's a creation of a mill levy, it should go to a vote of the people. Commissioner Eberle agreed with this statement.

Commissioner Hulm motioned to adopt a Resolution to create a county airport mill levy for up to two mills and to place a measure on the November 8, 2022 general election ballot. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Virgil Hulm, City of Linton, provided photos of the hillside north of the courthouse in front of the city shop. The side hill washed out last year. The City cemented the hill and it washed out again this spring. The City is proposing excavating the whole side hill and cementing it out. The damaged hillside is becoming a safety hazard to the public. Present was Chris Roehrich who presented an estimate in the amount of \$45,500.00 which includes excavating, concrete, material and labor. There will be some additional costs for moving utilities. After discussion, Commissioner Hulm motioned to approve the estimate from Roehrich Construction and to split the costs 50/50 with the City of Linton for a total cost up to \$25,000 for Emmons County and to utilize ARPA funding. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

The Commission approved a request from Sheriff Gary Sanders to allocate the \$200.00 a month salary budgeted for in the 911 general fund to GIS Coordinator, Josh Odden, for maintaining the mapping for 911.

The board reviewed a preliminary budget proposal for the year 2023 prepared by County Auditor/Treasurer, Marlys Ohlhauser, for the general fund and each special revenue fund with a detailed breakdown of estimated revenues and expenditures for the preceding year, current year and ensuing year and the appropriations requested. A public hearing date is set for October 4, 2022 at 5:30 P.M.

Joey Borracci, Relationship Manager for Summit Carbon Solutions, appeared to discuss pipeline casings and to clarify the requirements for conditional use permits. The commission concluded that two separate conditional use permits will be required for both phases of the project. Chairman Magrum stated that in his opinion he feels that steel casings under major roads is the proper way to go, but the commissioners will have to consult with the county's engineer.

Commissioner Weichel questioned whether Summit Carbon Solutions is wasting everyone's time because he hasn't heard from anyone that's in favor of this project and expressed that he will stand behind the people. Commissioner Weichel also expressed that he's received numerous letters from concerned citizens and landowners that really don't have interest in this project, and that the majority of the people don't want to see this project happen, and they have good reasons.

Chairman Magrum stated that his main question is the proper course of action, as he received the same letters from concerned citizens and land owners also, but questions whether the county's in any situation to deny a permit that hasn't been applied for. Chairman Magrum felt that the main concern is eminent domain more than anything, and because there's enough concern with eminent domain, there will need to be more discussion and probably some extra requirements put on this project. Chairman Magrum expressed that "as a county we adopted the Resolution that we oppose eminent domain, and we need to stand by this as well."

Commissioner Hulm stated that the commissioners have to serve the people, and if they are against the project, that doesn't leave the commissioners with much of an option.

Commissioner Eberle asked Joey Borracci what Summit Carbon Solutions intentions are for going around all those people that own land and don't want to be in the project. "How will you get from point A to point B without going between them?" Joey Borracci stated that Summit Carbon Solutions is working with all the landowners to avoid that property or going around the property. Eminent domain is not on the company's radar and they are averaging 200 re-routes every week. Chairman Magrum questioned why Summit Carbon Solutions submitted documentation with the North Dakota Public Service Commission that they are a common carrier if eminent domain is not on their radar?

Commissioner Weichel asked Stephanie Doolittle if anyone from Summit Carbon Solutions has been in contact with them since the last commission meeting regarding re-routing? Stephanie Doolittle stated that their attorney reached out to Summit Carbon Solutions after the last letter they received and they received another letter from their attorney yesterday stating that Summit Carbon Solutions is still requiring those easements.

Kevin Bernhardt stated that they also received a letter on re-routing from Summit Carbon Solutions and they are saying that they will go through their land no matter what. Kevin asked why they have to hire an attorney to protect their land.

Larry Smith, Professional Land Surveyor, asked Joey Borracci if all the casing locations will be surveyed according to laws in ND or as the state land requirements are in ND? Joey Borracci stated that Summit Carbon Solutions will be hiring certified surveying companies and will meet all federal and state regulations.

Greg Johnson, Professional Land Surveyor, suggested that the Commissioners send a letter to the Public Service Commissioner transferring their concerns, particularly eminent domain, as this would be a good tool for them to have.

David Moch asked Joey Borracci if there was a regulation book on how the agricultural land will be put back in the same condition, and Joey Borracci's response was that the contracts verbiage states "like or better condition."

Chairman Magrum suggested to amend the industrial conditional use permit fee because it's too low, and to require that the project have 100% voluntary easements to get an industrial conditional use permit otherwise it's automatically declined, making it difficult to use eminent domain.

After discussion, Commissioner Eberle motioned to amend the industrial conditional use permit to include a requirement to have 100% voluntary easements from the landowners for all projects. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Weichel motioned to amend the industrial conditional use permit application fee to 3% of the total cost of the project. Seconded by Commissioner Hulm. Roll Call "YES": Hulm, Kalberer and Weichel. "NO": Eberle and Magrum. Motion carried.

The board recessed for lunch and reconvened at 1:00 P.M.

Skyler Prellwitz, Road Superintendent, reported on activities for the county road department.

Road Equipment Operator, David Krumm, appeared to set the record straight regarding road work on 98th St. SE. Krumm stated that the road work he's doing on 98th St. SE was nothing more than yearly springtime regimen by pulling curb and gutter that has resulted from years of poor road maintenance. Krumm commented that he was hired by former Road Superintendent, Michael Lawler, to pull curb and gutter, and in his four years of employment with Emmons County, he has pulled 152 miles on the county roads. Krumm requested that the following statement be on record: "I state here and now, under oath, that Commissioner Eberle had absolutely

nothing to do with my decision to pull 98th St. SE.” “As a matter of fact, Commissioner Eberle did not even know that I was even going to do it.”

Francis Krumm was present for discussion regarding the no truck and speed limit signs on 9th Ave SE. Krumm prepared and read the following letter to the Commission: According to the minutes of the April 5, 2022 commissioner meeting posted in the May 12, 2022 issue of the Emmons County Record, “The commissioners agreed to put the no truck signs and speed limit signs back up on 9th Ave SE between 88th & 89th St SE. Mr. Dan Materi requested this closure and was present for this discussion. No reasons were provided to the public, in the meeting minutes, for this decision. The Commissioners have been provided with two annual books, from the road department, for the years of 2020 and 2021, consisting of 626 and 572 pages respectively. These books contain records of any work performed on the roads throughout Emmons County for those two years. If the Commissioners would have reviewed these books or contacted the road department, they would have known that, other than basic grading, there was nothing done to and nothing was wrong with this 1-mile of road. In fact, in 2020, when there were 309 frost boils recorded and documented for FEMA, throughout Emmons County, by the Road Department employees, this 1-mile of road had none despite being used in the spring of 2020 by farmers who were harvesting fall crops, from fields they couldn’t combine in the fall of 2019, and used this road to deliver their crops to the CHS north terminal. In addition, the summer of 2021, was one of the driest on record. Water levels in local lakes dropped by 3’ to 4’ and the winter of 2021-2022 provided very little snowfall to bring water tables up. Since this section of 9th Ave SE was in good condition, other than needing a little gravel, could the commissioners explain the reasons for permanently closing this road to all trucks, loaded or empty? Can they also explain why the local sheriff’s department was not notified about this road closure to trucks, yet was expected to enforce the road closure? I am providing a list of 80 residencies, throughout southern Emmons County, which is probably only half, just as close to a gravel road as Mr. Materi. In theory, these people could all make the same request to have no truck and speed limit signs placed near their residence. By keeping trucks off the 1-mile of blacktop road, on the west side of Strasburg, it would save taxpayers a lot of money by extending the life of this blacktop road. I am providing 2 estimates to improve the 1-mile of 9th Ave SE between 88th & 89th St. SE, as well as, ¾ mile of 88th St. SE going from 9th Ave SE to the CHS terminal. Lastly, I circulated a petition with the assistance of Commissioners Eberle and others. We obtained 57 signatures in favor of the immediate opening of this road. Many of the taxpayers in district #4 and district #5 are unhappy with the decision of the commissioners to close this road and think that it was nothing more than election year politics. According to Mr. Materi’s campaign card slogan, he listed integrity, accountability, transparency & equality as his qualifications for becoming the new district #4 county commissioner. End of letter.

During discussion, Francis Krumm asked the Commissioners if there was a reason why this road was closed? Commissioner Weichel questioned whether the road had water on both sides of the road at one time and that’s why the signs were originally put up. Commissioner Hulm stated that he also thought that with water on both sides of the road, that the road wasn’t good enough to handle the loaded trucks.

Road Superintendent, Skyler Prellwitz, recommended graveling the road and putting up no shoulder or narrow road signs.

The final decision of the Commission was to leave it up to the Road Superintendent to monitor and manage the conditions of the road.

Francis Krumm also brought forward the variance that was granted to Francis and Steve Werlinger at the July 5, 2022 commission meeting. Krumm prepared and read the following letter to the Commission: At the July 5, 2022 commissioner meeting, Mr. Frank Werlinger was granted a variance for approximately 1500’ of section line right-of-way on 90th St. SE, but there were no reasons given in the minutes for this particular variance. I am providing pictures A & B of Mr. Werlinger’s newly constructed fence, going at an angle, across the right-of-way, which is violating and disregarding the terms of the variance. I am also providing pictures C & D of my sprayer moving along the right-of-way, showing that no variance is needed or justified by the commissioners for this right-of-way, as well as, additional pictures E through J, and documentation with measurements. Pictures G & H show that by allowing a variance, travel has been made more difficult by fencing off the best passageway across the right-of-way. Would our commissioners please provide clarification on the reasons for this variance? The public is entitled to 66’ of right-of-way travel, whenever possible. The landowner on either side of the right-of-way is obligated to provide 33’ each for public use. It is not fair to require one landowner to provide 33’ while the other provides little to none. The commissioners are supposed to deal impartially with taxpaying landowners and treat them all fair and equal. Because today’s meeting is being recorded, I would request the commissioners to ask State’s Attorney Hanson to provide specific written and detailed reasons for the variance in the agreement between Emmons County and Mr. Werlinger. If approved, this variance will probably become the basis and standard in Emmons County by which any landowner along a section line right-of-way can request their own variance, including all the landowners along this right-of-way on 90th St. SE. With thousands of miles of right-of-way section lines throughout the county, no doubt in the future, other landowners who want a right-of-way variance can make an argument and will site these same reasons for their own variance to the Emmons County Commissioners. As stated in Mr. Al Meier’s letter to the editor in the July 28, 2022 edition of the Emmons County Record, “The commissioners who are all fair and honest servants of the taxpayers of Emmons County will favorable and impartially address your concerns. The commissioners want to treat all their constituents equally and not give preferential treatment to some and not others.” End of letter.

According to States Attorney Joseph M. Hanson, the variance has not been drafted nor signed by the Commissioners. Further discussion was held later in the meeting where the Commission agreed to hire Wold Engineering, P.C to perform a survey of the right-of-way.

Francis Krumm completed the employee evaluations for the years 2020 & 2021 (Summary A), and compiled a comparison of wages for the years 2017, 2018 and 2019 (Summary B). Pam Binder, HR Consultant

for Emmons County, reviewed both summaries and said they were well-written and she had no revisions. The Commissioners received copies of both summaries as well.

Paul Foertsch was present and asked if the gravel piles have been sprayed. Road Superintendent, Skyler Prellwitz, stated that all but one gravel pile has been sprayed. Foertsch questioned why the county can't put a gravel windrow in the middle of the road and work it out because he feels that the gravel is being put in the grass. Foertsch also commented about a shoulder washing away and a culvert that's not marked on 86th St. SW and 5th Ave SW.

Dave Twardoski appeared to request a road on 93rd St. SW, Section 14, Township 130, Range 79. Skyler Prellwitz stated that this is a large reconstruction project that will require engineering so he will keep evaluating and see what the options are.

The board reviewed an estimate and hydraulic analysis from Wold Engineering, P.C. for replacing an existing 96" corrugated steel pipe and installing a double 16' wide x 10' high reinforced concrete box culvert 4 miles west and 2 miles north of Braddock, Section 13, Township 136, Range 76.

Skyler Prellwitz reported that according to the North Dakota Bridge Inspection Report, the bridge on 4th Ave SE, located 8 miles west and 1 mile north of Hazelton has a bridge health index of 97.72, which means the bridge is in good condition.

Re-discussed the three (3) five-foot culverts that are plugged on 88th St. SE and 16th Ave. SE. The road superintendent will look into renting a pump for pumping the water.

Bob Bauman, participating by telephone, requested that the county rip-rap both sides of the section line on 88th St. SE and 16 Ave. SE because the work that the county previously did on this road washed away. The Commission reminded Bauman of the road use and road maintenance agreement entered into between Emmons County and Florian Bauman whereas the county was concerned that improving or stabilizing the access road at its current elevation, without a sufficient grade raise, will leave the road vulnerable to sustaining reoccurring damage from high water levels and winds, resulting in a total loss of investment. Per the agreement, the county agreed to cost share the proposal presented by Bob Bauman to rip-rap the west side of the access road on the condition that the owner understood that the county will not expend any future funds or resources to build, fix, stabilize, maintain, or otherwise improve or preserve the access road, including the portion located on the section line.

Commissioner Eberle motioned to approve the utility permit for Donovan Silbernagel to bore a 2" conduit for electrical line under 98th St. SE. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer and Weichel. Magrum abstained from voting due to conflict of interest.

Commissioner Weichel motioned to extend the six-month probation period for Road Superintendent, Skyler Prellwitz, until the end of the year 2022 to give him time to fulfill his residency in Emmons County. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Approval was granted to Extension Agent, Acacia Stuckle, to attend the National Association of Extension 4-H Youth Development Professionals in Madison, Wisconsin the week of October 9, 2022.

Commissioner Weichel motioned to adopt the following Resolution:

**RESOLUTION 22-04-01
RESOLUTION TO INCREASE COUNTY ROAD AND BRIDGE
MILL LEVY PURSUANT TO NDCC § 24-05-01(2) AND BALLOT ISSUE**

BE IT RESOLVED by the Emmons County Commission, the governing body of the County of Emmons, North Dakota;

WHEREAS, N.D.C.C. § 24-05-01(1) allows the Board of County Commissioners to levy a tax not exceeding a tax rate of ten mills per dollar of the taxable valuation of property in the county for the improvement of county roads and bridges.

WHEREAS, the Board of County Commissioners currently levies the full amount allowed for roads and bridges.

WHEREAS, N.D.C.C. § 24-05-01(2) allows the Board of County Commissioners to levy an additional tax not exceeding a tax rate of ten mills per dollar of the taxable valuation of property in the county for the improvement of county roads and bridges, when authorized by a majority of the qualified electors voting upon the question at a regular or special election in the county.

WHEREAS, N.D.C.C. § 57-15-06.3 previously allowed the Board of County Commissioners to levy a tax not exceeding a tax rate of five mills per dollar of the taxable valuation of property in the county for the maintenance, repair and upkeep of the farm to market and federal aid roads, but this levy is set to expire in 2024. The Board currently levies the full five mills.

WHEREAS, the Board of County Commissioners seeks to keep the tax revenue currently being generated through the N.D.C.C. § 57-15-06.3 tax levy authorization, by obtaining voter approval to increase the tax levy allowed for County Road and Bridge, pursuant to N.D.C.C. § 24-05-01(2).

WHEREAS, the Emmons County Commission seeks to place the following issue(s) onto the ballot during the 2022 (Primary) (General) Election:

EMMONS COUNTY MEASURE

Emmons County currently levies 5.00 mills for the maintenance, repair and upkeep of their farm to market and federal aid roads, and said 5.00 mill levy will soon be expiring. Emmons County currently levies 10.00 mills for county road and bridge improvements. Should the Emmons County Commissioners have the authority to levy up to an additional 5.00 mills in the county’s road and bridge fund in order to continue for the maintenance, repair and upkeep of the county’s farm to market and federal aid roads?

**UNOFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS
OF EMMONS COUNTY, NORTH DAKOTA
AT IT'S SPECIAL MEETING
JULY 19, 2022**

Chairman Erin Magrum called the meeting to order at 6:00 P.M., with Commissioners Don Eberle, Gary Hulm, David Kalberer and Leonard Weichel being present. Also present was States Attorney Joseph M. Hanson.

The Pledge of Allegiance was recited.

As advertised, at 6:00 P.M., a public hearing was held to receive public comment and direction on a proposed zoning Resolution adopting an ordinance instituting an emergency moratorium on solar energy farms. In attendance were approximately fifteen landowners.

Chairman Magrum opened the public hearing stating that Savion, a renewable energy company, is proposing a solar energy project west of Linton and the concerns of the county commission is that Emmons County's current zoning ordinance is not designed for the development of solar energy farms. "This is the first of our kind and we need to be prepared." "We are going to see a lot of alternative energy projects coming at us in the future, so as a commission we need stay ahead of the game to protect our citizens and landowners."

At the request of several landowners in the county, Chairman Magrum drafted a resolution to adopt a zoning ordinance instituting an emergency moratorium for a period not to exceed twenty-four months on solar energy farms. The first reading of the resolution was adopted at the May 3, 2022 commission meeting.

Landowner Dan Weber, representing himself, explained that he was contacted by the company to see if he would be interested in leasing land for solar energy. At this time, the company said they were acquiring 3,000 acres of land, leased for twenty years, at \$200.00 per acre. Dan Weber told the company that they were not interested. Later on, the Weber's were invited to a landowner meeting where the company (Savion) indicated that the area they were looking at for building the solar energy farm is no longer 3,000 acres, instead it's now 5,000 acres for a long-term lease of up to forty-five years. "This is a significant number of acres taken out of agricultural!"

Dan Weber expressed that he does not believe that this project will go away and will have an impact on people who farm and live here. "I encourage the Commission to adopt the Resolution to be ahead of the game, but I also feel that a two-year moratorium is not long enough."

Chairman Magrum stated that according to some research done, Solar is a very new thing in ND and he does not want Emmons County to be the "guinea pig" and would like to see the project go somewhere else. Chairman Magrum recommended a moratorium for a minimum of ten years.

Several other comments were made by landowners who believe this area was chosen because of the terrain, fewer environmental concerns and no wet lands. In addition, the landowners present felt that this location is being targeted because the project would be located near a major electric transmission line that runs from Stanton to Huron, SD.

David Moch expressed that these companies are coming to North Dakota and targeting small county's because we are not prepared and ready for them.

Stephanie Doolittle expressed that "whatever the commissioners can do to protect us landowners, they need to do it!" "These companies will keep coming and we do not want to sell out our land for tax dollars!"

Chairman Magrum closed the public hearing at 7:00 P.M. and the Commission reconvened the special meeting.

Commissioner Hulm stated that he would be in favor of extending the moratorium for a period of ten years, instead of two years.

Commissioner Eberle agreed that two years does not give the commission enough time to research and recommended a ten-year moratorium. "This project may only benefit a few people, while having negative impacts on a lot of landowners."

Commissioner Weichel motioned to amend the moratorium extending it from 2 years to 15 years and it shall not be overturned or amended without a 75% or greater majority vote by the Emmons County Board of Commissioners. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to adopt the following Resolution with the amended moratorium:

**RESOLUTION ADOPTING A ZONING ORDINANCE INSTITUTING AN EMERGENCY
MORATORIUM ON SOLAR ENERGY FARMS**

WHEREAS, the Emmons County Zoning Ordinance contains no standards for the issuance of a conditional use permit for Solar Energy Farms; and

WHEREAS, a Solar Energy Farm is being defined in (NDCC 49-22-03-5b) meaning. “Generation by any means other than wind energy conversion exceeding 50 megawatts of electricity; and

WHEREAS, the Emmons County Board of Commissioners has never accepted an application related to the creation of Solar Energy Farms and as a result has never received comments from townships, cities, or members of the general public pertaining to Solar Energy Farms; and

WHEREAS, the Emmons County Board of Commissioners need to review the Emmons County Zoning Ordinance with respect to Solar Energy Farms and include necessary ordinances to protect public health, safety, general welfare and property rights for the citizens of Emmons County; and

WHEREAS, the Emmons County Board of Commissioners finds:

1. An emergency zoning ordinance instituting a moratorium prohibiting Solar Energy Farms is necessary in order to hold discussions and hearing to determine where a longer term moratorium zoning ordinance or new zoning ordinances shall be adopted and implemented to protect the public health, safety, and general welfare of the residents of Emmons County.
2. An emergency exists because based on the recent development pressures as well as the comments received from the county citizens, the Emmons County Zoning Ordinance does not afford the protection needed to ensure that the residents of Emmons County are not adversely affected.
3. It is in the interests of public health, safety, and general welfare to impose a moratorium for a period not to exceed 15 years.

NOW THEREFORE BE IT RESOLVED, by the Emmons County Board of Commissioners, that this resolution adopting an emergency zoning ordinance instituting a fifteen-year moratorium on approval and acceptance of applications for Solar Energy Facilities shall become effective immediately upon its passage and publication and shall remain in effect for a period not to exceed 15 years unless reinstated by the Emmons County Board of Commissioners; and it shall not be overturned or amended without a 75% or greater majority vote by the Emmons County Board of Commissioners; and

BE IT FURTHER RESOLVED, that the Emmons County Board of County Commissioners is directed to administratively deny any applications during the period in which this interim ordinance is in effect; and

FINALLY, BE IT FURTHER RESOLVED, that the Emmons County Board of Commissioners shall schedule, publish, and notice public hearings as necessary for the purpose of studying and drafting proposed amendments and changes to the Emmons County Solar Ordinance and that a final hearing on any proposed changes or amendments shall be held within 15 years.

**OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS
OF EMMONS COUNTY, NORTH DAKOTA
AT IT'S REGULAR MEETING
JULY 5, 2022**

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, David Kalberer and Leonard Weichel being present. Also present was States Attorney Joseph M. Hanson.

The Pledge of Allegiance was recited.

The June, 2022 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Weichel motioned to approve the minutes of the June 7, 2022 regular meeting and the June 21, 2022 special meeting. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Kalberer motioned to approve the agenda with the addition of mowing the county lot on the W ½ 245' X 288' in Section 17, Township 132, Range 76, Resolution for fast tracking employee background checks and water concerns on the main road on 88th St. SE. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Representatives from Summit Carbon Solutions appeared and provided an update on the proposed CO2 pipeline in Emmons County. Joey Borracci, Relationship Manager, provided an infographic that showed a total project investment of \$73,753,741 in Emmons County that's expected to generate \$423,197.00 in property tax revenue. Mr. Borracci informed the board that of the 36.43 miles of anticipated pipeline in Emmons County, twelve miles has been acquired, which is 32%. The completion date for the project would be August, 2023.

Mr. Borracci inquired about permitting requirements for the project and was informed by the Commission that in addition to the required utility and approach permits, a conditional use permit is required for the pipeline and also for the pump station in phase two of the project. A haul road agreement would need to be entered into between Summit Carbon Solutions and Emmons County for restoration of the road system.

Brent Niece with Summit Carbon Solutions, stated that the diameter of the pipe will be 24" and intended to be at least 4 to 5 feet deep. Information on pipeline casings was provided with further discussion to be held at the August meeting.

Clerk of Court/Recorder, Anita Ibach, questioned why Summit Carbon Solutions was filing easements without maps? "How is anyone going to know where the easement is at without any maps attached?" The easements will need to be filed with maps, and there will be additional filing fees.

David Moch was present and stated that the earlier easements were not surveyed. "They didn't survey correctly when they surveyed his land and the Recorder could not correctly record the easement, so the surveyor came back and re-surveyed his land because they didn't follow state law the first time."

David Moch inquired about the roads getting repaired following construction. Brent Niece stated that the company will repair all the roads and section lines.

Stephanie Doolittle was present and questioned Summit Carbon Solutions about land acquisition. "We are not in favor of the project and will not jump on board with it, so how will you re-route the project?" Brent Niece stated that the hope is to acquire as much land as possible through easements, but eminent domain practices is a possibility.

Old and Unfinished Business:

Chairman Magrum stated that Don Volk will mow and bale the county property on the W ½ 245' X 288' in Section 17, Township 132, Range 76 without any reimbursement.

Chairman Magrum instructed States Attorney Joseph M. Hanson to create a resolution for fast tracking employee background checks.

Commissioner Eberle motioned to adopt the following Resolution:

RESOLUTION 22-03-01 REGULATING MOBILE HOMES, CONEX BOXES AND OTHER STRUCTURES

BE IT RESOLVED by the Emmons County Commission, the governing body of the County of Emmons, North Dakota;

WHEREAS, the Emmons County Commission acts as the Emmons County Zoning Commission; and

WHEREAS, the Emmons County Commission has previously approved and adopted the Emmons County Zoning Ordinance; and

WHEREAS, the Emmons County Commission seeks to amend the above-described Emmons County Zoning Ordinance, as follows:

[1] The current, applicable provision in Article 1(I.A.) (3), on page 4, reads as follows:

ARTICLE 1, § I.A. (3) – “Single-family dwellings (permanent-type construction) including mobile homes on permanent foundations.”

The Emmons County Commission seeks to amend the above-described Emmons County Zoning Ordinance, to add the following subsections to paragraph 3, to read as follows:

a. In order to comply with this section, mobile homes must meet the following minimum standards:

- 1) An Affidavit of Affixation must be previously filed or must accompany any new building permit, and any provisions on the Affidavit must be followed;
- 2) The mobile home must be set on a permanent foundation, using earth anchors and either piers, footings, or a basement;
- 3) The structure must be actively connected to basic utilities, including power, water and sewer.
- 4) Mobile homes must be skirted.

{2} The above-described regulations on mobile homes shall be applicable to the following zoning districts: RA – Recreation District; A – Agricultural District; and R – Residential District.

{3} The Emmons County Commission further seeks to specifically regulate Conex boxes or similar structures, by adding the following provisions to the Emmons County Zoning Ordinance:

- a. “Conex Box” means any cargo container, shipping container, intermodal or freight container, or similar structure, typically used as a tool or storage shed.
- b. This section shall be applicable in the following Zoning Districts: RA – Recreational District.
- c. A Storage Unit Permit is required for the use or installation of any Conex Box.
- d. Conex Boxes must have a paint color that matches all other structures on the property. If no structures are on the property, the paint color must be beige, and must not include lettering.
- e. There shall be a limit of one Conex Box per Lot.
- f. Conex Boxes are required to comply with any applicable set-back for structures within the district.
- g. The following is a non-exclusive list of storage structures that are not permitted within the RA – Recreation District: Semi Trailers; Reefer Containers or Trailers; Buses; Trailers or other Vehicles used for storage; and any non-licensed or junk vehicles or trailers.

{4} Notice of Violation. The County, or an agent thereof, is hereby authorized and empowered to notify, in writing, the owner of any lot or area within the County or the agent of such owner, to remove or bring into compliance, any Mobile Home, Conex Box, or non-permitted storage structure {(3)(g)}, if the structure is determined to be in violation of this Resolution or any other applicable section of the Emmons County Zoning Ordinance. The notice shall be by registered or certified mail addressed to said owner or agent of said owner at their last known address or by personal service, and shall include the penalty \$100.00 for each violation, including the failure to secure a Storage Unit Permit prior to placement of any Conex Box on any RA – Recreation District lot.

{5} Action Upon Non-Compliance. Upon the failure, neglect, or refusal of any owner or agent to comply with the terms of the above-described notice, after 30 days have elapsed from the date of service of such notice, or after 45 days from the date of mailing said notice, whichever is soonest, the County, or an agent thereof, is hereby authorized and empowered to remove or bring the structure into compliance, or order the removal or repair of the non-compliant structure. If the violation continues after 30 days, a \$100.00 fine shall be issued.

{6} Cost Assessed to Property. When the County has affected the removal or repair of such structure, or has paid for the same, the actual cost thereof, if not paid by said owner prior thereto, including any fines assessed, shall be charged and assessed against the property upon which the structure or violation was located.

{7} Compliance: The Resolution is effective as of the date of its passing, and shall be immediately enforced on new construction. Properties with existing violations shall have until September 1, 2022 to bring their properties into compliance with this Resolution.

Acacia Stuckle, County Extension, provided a quarterly narrative report.

Commissioner Eberle motioned to approve the building permit for David German to erect a 32 X 36 Cabin on Lot 9, Beaver Bay Subdivision, Section 23, Township 132, Range 79. Seconded by Commissioner Kalberer. Roll Call “YES”: Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Kalberer motioned to approve the building permit for Joanne F. Buck to erect a 24 X 40 Farm Shop on Section 7, Township 134, Range 76. Seconded by Commissioner Weichel. Roll Call “YES”: Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Kalberer motioned to approve the building permit for Robert Bornemann to erect a garage onto the mobile home on the SE ½ of Section 26, Township 136, Range 74. Seconded by Commissioner Eberle. Roll Call “YES”: Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Kalberer motioned to approve the building permit for Robert Bornemann to erect a 100 X 120 farm shop on the SW ¼ of Section 25, Township 136, Range 74. Seconded by Commissioner Eberle. Roll Call “YES”: Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the application and issue a liquor license to Cattail Resort for a one-day event held on July 16, 2022 on a tract in the SE ¼ of Section 8, Township 130, Range 79. Seconded by Commissioner Weichel. Roll Call “YES”: Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

VA Officer, Jeff Ohlhauser, appeared and gave a quarterly activity report.

Departmental budgets were presented for calendar year 2023. A budget proposal will be reviewed at the August 2, 2022 meeting.

The board recessed for lunch and reconvened at 1:00 P.M.

Paul Foertsch was present and expressed his concerns about a rock that the road department moved off to the side of the road and is now hiding in the tall grass on 67th St SE. Mr. Foertsch also inquired about gravel on 67th St SE.

Another concern addressed by Mr. Foertsch was the culvert on the main Braddock road that is running clean now; but if we get more rain, the water will run over the road.

Mr. Foertsch also expressed concerns on how one of the motor grader operators was blading the roads.

Road Superintendent, Skyler Prellwitz, will check into all these matters.

Francis Werlinger and Steve Werlinger appeared in regards to the barbed wire fence near 22nd Avenue SE and 90th St. SE, adjacent to the NW ¼ of Section 2, Township 130, Range 74. The county sent a letter to the Werlinger’s instructing them to remove the fence off the section line right-of-way. Steve Werlinger asked the Commission to grant a variance because it’s impossible to move the fence the 33 feet without running into the creek. After discussion, the Commission agreed that the Werlinger’s move the fence off the right of way for the first 1,150 feet, and the county grant a variance for the remainder feet of the fence (where the section line curves). Joseph M. Hanson will draft a variance for the August 2, 2022 meeting.

Scott Kelsch appeared to discuss the following:

- Requested a culvert one mile south on 19th Ave SE, west on 82nd St SE. There’s currently a huge sink hole in the road.
- Requested to move his current cattle loading area to the section line right of way on 88th St. SW. The section line is not traveled on by the public due to a bridge that’s not operational. Also discussed the option to install an approach with a culvert on 3rd Ave SW near the existing cattle holding pen.
- Replacing the damaged culvert on 18th Ave SE to allow access to the section line.

Skyler Prellwitz, Road Superintendent, reported on activities for the county road department. Skyler reported that in addition to blading, the department is graveling the roads. Skyler is waiting on quotes for chip sealing and he also reported on the trailer house that the road department moved out of the trailer court in Linton.

Brought to the table were comments made by some citizens about building up the road on 98th St. SE. Commissioner Eberle stated that the road is used by several landowners and has always been maintained by the county. The road is not being built up; instead David Krumm is pulling up the shoulders as he does on other roads and is just doing regular maintenance.

Also mentioned was that the culvert on the road on 7th Ave SE near Duane Ternes's should be marked.

Brief discussion was held on blading private roads.

On the agenda was a resignation letter from Francis Krumm. Chairman Magrum will visit with Francis and report back to the board.

Commissioner Weichel reported that the road located on 88th St. SE and 16th Ave SE is 3.75 feet higher on the north side compared to the south side. The three (3) five-foot culverts are plugged. Skyler Prellwitz will check into a Jetter truck.

John Ibach was present to discuss road department budgets for 2023.

Danielle Stoppler was present and voiced concerns with the commissioners about lack of accountability in the board. She stated that at the March meeting, the commission decided to put up signs on her road and Commissioner Hulm said he would talk to Al Hulm about maintaining the quarter mile on 14th Ave SE. Danielle called and talked to four of the commissioners about her concerns and nothing was done.

Commissioner Hulm stated that he would like to see the county maintain the quarter mile by Danielle's road and will talk to Al Hulm about the maintenance and to also place a sign on the north side of the road.

Also discussed was recording and live streaming county commission meetings. Chairman Magrum will contact another county and work with Josh Odden on video equipment.

Michael Schneider, Jr. appeared to request approval of a building permit for adding an addition onto his home and to request a setback variance allowing the home to be three feet from the property line. After discussion, Commissioner Hulm motioned to approve the building permit for Michael Schneider to add a 16 X 22 addition onto the home located on Lot 17 and part of Lot 18, Beaver Bay Subdivision, Section 23, Township 132, Range 79 with the condition that there's a signed agreement in place between Michael Schneider, Jr. and John Nagel. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Hulm motioned to proceed with upgrading the County Shop in Hazelton, not to exceed \$30,000.00, utilizing ARPA funds. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to adopt the following Resolution and Ballot Language:

PROPOSED 9-1-1 FEE RESOLUTION AND BALLOT LANGUAGE

WHEREAS, emergency 9-1-1 services are critical to public safety in Emmons County; and

WHEREAS, the County imposed a local \$1.00 fee per month per "assessed communications service" (telephone access line, wireless access line, voice over internet protocol service) for the operation and maintenance of the 9-1-1 emergency services communications system; and

WHEREAS, the monthly 9-1-1 fee on assessed communications service imposed by the County pursuant to NDCC 57-40.6 is essential to implementing, maintaining, and operating the 9-1-1 emergency services communication system in this County; and

WHEREAS, the current fee, limited to \$1.00 per month per assessed communications service, was initially authorized on November 8, 1994 by the voters of Emmons, and

WHEREAS, the 57th Legislative Assembly amended NDCC 57-04.6 to permit the extension of existing 9-1-1 fees to wireless communications service by a governing board resolution which was accomplished by a Wireless 911 Fee Resolution signed by the Emmons County Board of Commissioners on August 10, 2001, and

WHEREAS, the current local fee of \$1.00 per month per assessed communications service is inadequate to appropriately fund the operations and maintenance of emergency 9-1-1 services in Emmons County, and

WHEREAS, the NDCC 57-40.6-02 provides a process of imposing 9-1-1 fees by governing board resolution and approval of the voters.

THEREFORE, BE IT RESOLVED that the Emmons County Board of Commissioners proposes an increase of the existing, local 9-1-1 fee from \$1.00 to \$1.50 to continue to maintain and operate the 9-1-1 emergency services communication system in Emmons County and directs the following measure to be placed on the County ballot for the County General Election scheduled for November 8, 2022.

Emmons County Measure

Should the current local emergency services communication (9-1-1) fee of \$1.00 per month per assessed communications service be increased to a maximum local collection of \$1.50 per month per assessed communications service for the purpose of continued maintenance and operations of 9-1-1 for this County?

Chairman Erin Magrum called the meeting to order at 10:00 A.M., with Commissioners Don Eberle, Gary Hulm, David Kalberer and Leonard Weichel being present. Also present was States Attorney Joseph M. Hanson.

The Pledge of Allegiance was recited.

Discussion was held on putting a fence around the Camp Knoll, LLC gravel pit. Commissioner Eberle will contact Paul Foertsch for an estimate.

The Commission amended Resolution 22-03-01, regulating mobile homes, Conex boxes and other structures as follows:

Mobile Homes:

1. An Affidavit of Affixation must be previously filed or must accompany any new building permit, and any provisions on the Affidavit must be followed.
2. The mobile home must be set on a permanent foundation, using earth anchors and either piers, footings, or a basement.
3. The structure must be actively connected to basic utilities, including power, water and sewer.
4. Mobile homes must be skirted.

Conex boxes or similar structures:

- a. "Conex Box" means any cargo container, shipping container, intermodal or freight container, or similar structure, typically used as a tool or storage shed.
- b. This section shall be applicable in the following Zoning Districts: RA – Recreation District.
- c. A Storage Unit Permit is required for the use or installation of any Conex Box.
- d. Conex Boxes must have a paint color that matches all other structures on the property. If no structures are on the property, the paint color must be beige, and must not include lettering.
- e. There shall be a limit of one Conex Box per Lot.
- f. Conex Boxes are required to comply with any applicable set-back for structures within the district.
- g. The following is a non-exclusive list of storage structures that are not permitted within the RA – Recreation District: Semi Trailers; Reefer Containers or Trailers; Buses, Trailers or other Vehicles used for storage; and any non-licensed or junk vehicles or trailers.

Notice of Violation – The County, or an agent thereof, is hereby authorized and empowered to notify, in writing, the owner of any lot or area within the County or the agent of such owner, to remove or bring into compliance, any Mobile Home, Conex Box, or non-permitted storage structure {(3)}, if the structure is determined to be in violation of this Resolution or any other applicable section of the Emmons County Zoning Ordinance. The notice shall be by registered or certified mail addressed to said owner or agent of said owner at their last known address, or by personal service, and shall include the penalty of \$100.00 for each violation, including the failure to secure a Storage Unit Permit prior to placement of any Conex Box on any RA – Recreation District lot.

Properties with existing violations shall have until September 1, 2022 to bring their properties into compliance with this Resolution.

The Commission will act on the amended Resolution at the July 5, 2022 meeting. Also present for discussion was Joe Vetter, Jr. who expressed that the citizens who attended the public hearing commented that they do not want Conex boxes in recreational districts.

The date for the public hearing to consider the proposed Resolution adopting a zoning ordinance instituting an emergency moratorium on solar energy farms is set for July 19, 2022 at 6:00 P.M. in the courthouse auditorium.

John Ibach presented extended warranty quotes from Butler Machinery for the 2018 140M3 motor graders. No action was taken.

Reviewed job descriptions for the road department. A decision was made to remove that an equipment operator must possess and retain a Class A CDL.

There being no further business before the board, Commissioner Weichel motioned to adjourn. The meeting adjourned at 11:15 A.M.

AT IT'S REGULAR MEETING
JUNE 7, 2022**

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, David Kalberer and Leonard Weichel being present. Gary Hulm was absent until 1:00 P.M. Also present was States Attorney Joseph M. Hanson.

The Pledge of Allegiance was recited.

The May, 2022 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Weichel motioned to approve the minutes of the May 3, 2022 regular meeting. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the agenda with the addition of discussion with Water Resource regarding Schwahn Lake. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Kalberer, Magrum and Weichel. Motion carried.

As per publication, at 9:15 A.M., the County Board convened as a Board of Equalization to take-up matters of Equalization of Assessments. Present for the Equalization meeting was Director of Tax Equalization, Denise Nieuwsma.

Agricultural land values were discussed. Per North Dakota Century Code 57-02-27.2, agricultural values are determined by productivity of the soils versus market value. The 2022 value per acre for Emmons County is \$627.23. The State Board of Equalization has the tolerance set for 2022 between 90 – 100%. At this time, Emmons County is within tolerance for agricultural land at 93%.

Denise Nieuwsma and GIS Coordinator, Josh Oden, provided information on various soil types in Emmons County with the productivity index ratings and total agricultural acres.

Betty McLeish was present and asked if something different will be done with soils this year because her property taxes increased tremendously. Betty also stated that pastureland should be taxed less than crop land.

Reviewed were the 2021 sales for Ag land, commercial, vacant lots, residential and lake/river property.

Total sales ratio of all residential and lakeshore properties sold in 2021 shows a median ratio of 92.8% for 2022. There were 54 residential/lakeshore usable sales. The residential/lakeshore properties are within the accepted tolerance of 90% - 100%.

The sales ratio study for Emmons County shows a median ratio of 91.2% for commercial/vacant lot sales. There were 45 useable commercial/vacant lot sales. The commercial/vacant lot properties are within the accepted tolerance of 90% - 100%.

Commissioner Weichel motioned to approve the agricultural, residential and commercial true and full values and to equalize the assessments for 2022. Seconded by Commissioner Eberle. Roll Call "YES: Eberle, Kalberer, Magrum and Weichel. Motion carried.

Old and Unfinished Business:

Commissioner Eberle motioned to approve the building permit for Stuart Alderin to erect a 28 X 38 cabin and a 36 X 54 detached shop with the condition that applicant pays the penalty for beginning work prior to applying for a building permit. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Kalberer, Magrum and Weichel. Motion carried.

There was brief discussion relative to Resolution 22-03-01 regulating mobile homes, conex boxes and other structures. Commissioner Weichel motioned to hold a special meeting on June 21, 2022 at 10:00 A.M. to fine-tune the Resolution. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Kalberer, Magrum and Weichel. Motion carried.

New Business:

The Director of Tax Equalization requested a part time employee to perform clerical duties in her office. This position will be proposed in the 2023 budget cycle.

Discussion was held with county officials, department heads and county employees in regards to allocating American Rescue Plan Act funding towards major repairs and renovation projects to the courthouse, county buildings, fire alarm system and other equipment needs that have been delayed or postponed in the past due to lack of funding. The commission agreed to organize a working group of five people consisting of officials, department heads and county employees to itemize a list of projects with cost estimates and bring them forward to the commissioners.

Francis Krumm telephoned into the meeting to discuss the fence on 22nd Avenue SE. The commission agreed that the landowner should be allowed until October 1, 2022 to remove the fence. If the fence is not

removed by October 1, 2022, the county will hire a contractor to remove the fence. The landowner will be liable to the county for all costs involved.

Sheriff Gary Sanders appeared and provided a 911 financial report and an update on the state radio system and service fees. The financial report for Emmons County’s 911 is showing a deficit of \$3,035.10 per month which is a deficit of .90 per line. The county’s general fund has been supporting some of the costs for the county’s operation of the 911 communications system. ND State Radio fees which are currently \$1.36 per line for Emmons County will be increasing for the 2023 – 2025 biennium. The Commission will consider adopting a Resolution to propose an increase of the existing local 911 fee from \$1.00 to \$1.50 for maintaining and operating the 911 emergency services communication system. If adopted, a measure will be placed on the 2022 general election ballot.

The board recessed for lunch and reconvened at 1:00 P.M.

Skyler Prellwitz, Road Superintendent, reported on activities for the county road department.

- Skyler stated that citizens are inquiring about the county doing private work. The Commission agreed that the county will not do any private construction work.
- Skyler requested to hire a fulltime blade operator and temporary seasonal maintenance workers. No action was taken.
- Reported encroaching on 90th St. SE and 10th Ave SE.

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, David Kalberer and Leonard Weichel being present. Also present was States Attorney Joseph M. Hanson.

The Pledge of Allegiance was recited.

The April, 2022 end of month fund balance report and the year to date expenditure report were distributed to the board.

Danielle Stoppler was present and requested that her concerns with the commissioners that were addressed at the last meeting be included in the April 5, 2022 official proceedings.

Commissioner Weichel motioned to approve the minutes of the April 5, 2022 regular meeting with the addition as requested by Danielle Stoppler. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Weichel motioned to approve the agenda with the addition of the Bauman Road discussion. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Old and Unfinished Business:

County Auditor, Marlys Ohlhauser, presented the following county park budget information to the board:

Noted was \$30,000.00 is budgeted for installing a new water line at Langelier's Bay.

Board members read a letter from Ann M. Moch, Kintyre Park, and LeAnn Donley, Hazelton City Park, providing a summary of their park's activities and projects.

There was some discussion about appropriating ARPA funding in the county park fund for distribution to the city parks.

Leonard Weichel motioned to allocate \$2,500.00 to Linton City Park, Hazelton City Park, Braddock City Park, Hague City Park and to the park in Kintyre; and to allocate \$1,250.00 to the Strasburg City Park and \$1,250.00 to the Strasburg Park Expansion. Seconded by Don Eberle. Roll Call "YES": Don Eberle, Gary Hulm, David Kalberer, Erin Magrum, Leonard Weichel, Dean Weis and Andy Reis. Motion carried.

Leonard Weichel motioned to adjourn. The meeting adjourned at 9:40 A.M.

At 9:40 A.M., the Board of County Commissioners reconvened in regular session.

Michelle Masset was present for courthouse hours discussion. The idea was brought forward in order to serve the public earlier in the morning and over lunchtime. Suggestions made were to open the courthouse at 8:00 A.M., rotate lunchbreaks with the offices that have two or more employees working, which would allow the offices to remain open over lunch hour, and close earlier on Fridays. After discussion, Commissioner Hulm motioned that the hours for the courthouse be changed to 8:00 A.M. to Noon, 12:45 P.M. to 5:00 P.M. Monday

**RESOLUTION ADOPTING A ZONING ORDINANCE INSTITUTING AN EMERGENCY MORATORIUM
ON SOLAR ENERGY FARMS**

WHEREAS, the Emmons County zoning Ordinance contains no standards for the issuance of a conditional use permit for Solar Energy Farms; and

WHEREAS, as Solar Energy Farm is being defined in (NDCC 49-22-03-5b) meaning, Generation by any means other than wind energy conversion exceeding 50 megawatts of electricity; and

WHEREAS, the Emmons County Board of Commissioners has never accepted an application related to the creation of Solar Energy Farms and as a result has never received comments from townships, cities, or members of the general public pertaining to Solar Energy Farms; and

WHEREAS, the Emmons County Board of Commissioners need to review the Emmons County Zoning Ordinance with respect to Solar Energy Farms and include necessary ordinances to protect public health, safety, general welfare and property rights for the citizens of Emmons County; and

WHEREAS, the Emmons County Board of Commissioners finds:

1. An emergency zoning ordinance instituting a moratorium prohibiting Solar Energy Farms is necessary in order to hold discussions and hearings to determine where a longer-term moratorium zoning ordinance or new zoning ordinances shall be adopted and implemented to protect the public health, safety, and general welfare of the residents of Emmons County.
2. An emergency exists because based on the recent development pressures as well as the comments received from the county citizens, the Emmons County Zoning Ordinance does not afford the protection needed to ensure that the residents of Emmons County are not adversely affected.
3. It is in the interests of public health, safety, and general welfare to impose a moratorium for a period not to exceed twenty-four months.

NOW THEREFORE BE IT RESOLVED, by the Emmons County Board of Commissioners, that this resolution adopting an emergency zoning ordinance instituting a twenty-four-month moratorium on approval and acceptance of applications for Solar Energy Facilities shall become effective immediately upon its passage and publication and shall remain in effect for a period not to exceed twenty-four months unless reinstated by the Emmons County Board of Commissioners; and

BE IT FURTHER RESOLVED, that the Emmons County Board of County Commissioners is directed to administratively deny any applications during the period in which this interim ordinance is in effect; and

FINALLY, BE IT FURTHER RESOLVED, that the Emmons County Board of Commissioners shall schedule, publish, and notice public hearings as necessary for the purpose of studying and drafting proposed amendments and changes to the Emmons County Solar Ordinance and that a final hearing on any proposed changes or amendments shall be held within twenty-four months.

Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

VA Officer, Jeff Ohlhauser, was present to discuss some advertising for his office.

The board recessed for lunch and reconvened at 1:00 P.M.

Michael R. Rivinius, PE, Wold Engineering, P.C., appeared and provided a bid summary and cost breakdown for road project SC-SVD-1500(050), Chip Seal 10.385 miles on CMC 1510, 1523 and 1529.

Commissioner Hulm motioned to adopt the following Resolution:

RESOLUTION

WHEREAS, the bid in the amount of \$564,976.42 from Morris Sealcoat & Trucking, Inc. received in the bid opening of April 8, 2022 for project SC-CVD-1500(050) was the low bid received.

WHEREAS, this bid is considered reasonable.

NOW, THEREFORE, be it resolved by the Board of County Commissioners of Emmons County will award to Morris Sealcoat & Trucking, Inc. the contract for Project SC-CVD-1500(050) and hereby authorizes the Chairman of the Board to sign said contract.

It is further understood that the County shall reimburse the North Dakota Department of Transportation for any payments made under this contract, which are not collectible from the Federal Highway Administration.

Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Skyler Prellwitz, Road Superintendent, reported on activities for the county road department.

For safety concerns, a road closed sign will be placed on the road located in-between Sections 35 and 36, Township 129, Range 77.

Out of one hundred seventy-nine entries, six students from Mrs. Pfeifer's class at Linton Public School won the NDLTAP "Save our Signs" poster contest. The road department will provide examples of road safety signs to the class on May 13, 2022.

Dennis Walther telephoned into the meeting with concerns relative to the road that Jon Richter is constructing for Oahe Subdivision. Dennis stated that he does not want truck nor car traffic on his road. Present was Jon Richter who assured that he is accessing his own land right now while building his road per his building permit. Dennis and Jon will communicate and come to a resolution.

Denied a request from Bob Bauman to haul in small rock on the road leading into Florian Bauman's farmstead.

John Ibach was present with a representative from Armor Interactive to discuss an electronic timekeeping program for tracking and reporting hours worked for the road department. There's a one-time fee between \$2,000.00 - \$2,500.00.

Francis and Kelly Krumm presented books prepared by Kelly that detailed road departments hours by job summary and road project costs for the year 2021.

Commissioner Weichel motioned to approve the Utility Permit for KEM Electric to install 3-1/0 260 mil 25kv jacketed cable on 10th Avenue SW and 90th St. SW. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the Utility Permit for KEM Electric to install 1/0 260 mil 25kv jacketed cable on 6th Avenue SW and 83rd St. SW. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Troy Roemmich appeared to voice concerns regarding the competitive personnel system used when interviewing the candidates for the road supervisor position. Troy questioned the systems accuracy and asked if the system was subjective, competitive, and if there was room for bias?

As advertised, at 5:00 P.M., a public hearing was held to receive public comment and direction on the proposed zoning resolution 22-03-01. The resolution would require mobile homes in recreation, residential and agriculture to file an Affidavit of Affixation before being approved for a building permit. It would require mobile homes to be anchored to a permanent foundation, using piers, footings or a basement. It would also require tires, tongues or hitches to be removed. Mobile homes would be required to maintain an active connection to basic utilities, including power, water and sewer. The resolution would also regulate conex boxes, cargo, shipping, intermodal and freight containers and other similar structures typically used as tool or storage

sheds. Those regulations would apply to recreation districts only, and the resolution would require such conex boxes to be painted to match existing structures. If no structures are on the property, the paint color must be white or beige, and must not include lettering. This resolution would require building permits for conex boxes and limit recreational districts to one conex box per lot.

Joe Vetter, Jr. was present and requested that the resolution be amended as follows:

- All outbuildings including garage and cold storage buildings must be on permanent cement foundation. Mobile homes must be on permanent cement foundation using piers, footings or a basement, and must be anchored and skirted.
- Conex box means any cargo container, shipping container, intermodal or freight container, railroad cars, truck vans, converted mobile homes, trailers, recreation vehicles, camper trailers, bus bodies, vehicles, and similar items built for purpose other than storage.
- No on-site conex box shall be permitted in recreational districts. Any pre-existing on-site shipping containers and freight containers in place prior to said effective date shall be permitted non-conforming.

Doug Vannurden was present and stated that they purchased a place on Little Beaver Trail sixteen years ago and have made this their permanent home; but snow bird over the winter months. Doug expressed that conex boxes should not be permanent. They should be temporary for up to two years, until the property owner gets things established. Doug also stated that skirting on mobile homes should be a requirement in the resolution.

Commissioner Weichel expressed that conex boxes have a good use to some people; but how do we enforce the ordinance if they are temporary?

David Vetter was present and stated that the last thing he wants to do is get into a fight with his neighbor. "There's a lot of ordinances that have not been followed!" "Who's going to enforce how the county resolution is being proposed (example – color of conex boxes, etc.)?" David also feels that someone has to watch what's going on at Beaver Bay whether it's about storage containers or decks.

Patrick Vetter was present and stated that he has a nice lot and doesn't want more junk around him. Patrick feels that if the owners want storage, they should pay the property taxes and put up a building.

Dan Carr was present and commented that at Rice Lake there is strict covenants where the structures have to be a certain size with earth tone colors, and trailer houses are not allowed.

Joe Vetter, Jr. expressed that property values have gone up because of inflation and rural water. He wants to keep the valuations up, but feels that a neighborhood that is not kept up will cause values to decrease.

Chairman Magrum stated that in his opinion he doesn't believe the values have been affected. Chairman is not in favor of eliminating conex boxes, but keep a color scheme. "You drive around and a lot of people have nice ones." "Building a garage is better, but not everyone can do this." Chairman stated that he doesn't have a problem with requiring skirting and removing hitches on mobile homes.

Commissioner Eberle stated that buses, old trailer houses and conex boxes that say "China" on them should be gone.

Commissioner Kalberer stated that conex boxes should be eliminated.

Commissioner Weichel stated that "there are existing conex boxes and no more should be allowed." "The county should approach people and give them a three-year tax break if they put up a storage building and remove the conex box".

The public hearing ended at 5:55 P.M.

AT IT'S REGULAR MEETING
APRIL 5, 2022**

Chairman Erin Magrum called the meeting to order at 9:00 A.M. with Commissioners Don Eberle, Gary Hulm, David Kalberer and Leonard Weichel being present. Also present was States Attorney Joseph M. Hanson.

The Pledge of Allegiance was recited.

The March, 2022 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Weichel motioned to approve the minutes of the March 1, 2022 regular meeting. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Weichel motioned to approve the agenda for this meeting. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Old and Unfinished Business:

Commissioner Eberle motioned to approve the Plat for Lot 1 of Auditor's Lot 14A of the NW ¼ NE ¼ of Section 14, Township 132, Range 79. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

New Business:

Maintenance Supervisor, Craig Kitzan, provided an update on the courthouse windows and doors. Craig is waiting for grant approval to replace the exterior doors and will contact a contractor to re-caulk the windows of the courthouse.

Commissioner Hulm motioned granting permission to Denise Nieuwsma to attend the NCRAAO Conference in South Dakota June 26 – 30, 2022. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Denise Nieuwsma's six-month probation period is up on April 18, 2022. The Commissioners stated that Denise is performing at an overall satisfactory level. Commissioner Hulm motioned to increase Denise Nieuwsma's annual salary to \$49,521.95 effective May 1, 2022. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

The Commission asked Sam Renschler to maintain Langelier's Bay Campground and restroom facilities and the facility at Rice Lake for calendar year 2022.

Eric Nagel telephoned into the meeting to discuss the building permits approved in 2020-2021 for the mobile homes placed on lots 118, 119, and 120 at Beaver Bay Scenic Properties. Discussion was held and the previously approved building permits will stand.

As advertised, at 10:15 A.M., a public hearing was held to consider the application for a Conditional Use Permit for constructing new wastewater treatment facility lagoons, new sanitary sewer, force main, lift station modifications, and miscellaneous other work located on Section 25, Township 131, Range 76 filed by the City of Strasburg. The property is located in an agricultural zoned district. There were no appearances or comments from the public. Commissioner Weichel motioned to approve the Conditional Use Permit for constructing the wastewater treatment facility lagoons, sanitary sewer, force main, lift station modifications and miscellaneous work. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Hulm motioned to remove Kayla Hendrickson and add Leann Volk and Lisa Ternes on all bank accounts with BNC National Bank, including the Clerk of Courts checking account. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Hulm motioned to enter into an agreement by and between the City of Linton and Emmons County for the shared use of the Linton Inert Waste Landfill. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

There was some discussion relative to the expiring farm to market mill levy. The 2015 Legislature passed SB2144, the Levy Consolidation bill, which consolidated and repealed certain county mill levies. If a voter-approved levy was authorized before January 14, 2015, it would remain in effect for up to 10 taxable years under the provisions of law in effect at the time it was approved, and would require a majority approval by the voters to continue using the levy. The farm to market mill levy, approved by the voters in Emmons County to levy up to five mills, was repealed with SB2144 and will expire in 2024. The Board of County Commissioners could seek to keep the tax revenue currently being generated through the farm to market levy, by obtaining voter approval to increase the tax levy allowed in the county road and bridge levy pursuant to NDCC 24-05-01. The consensus of the board was to re-discuss this in August to consider placing the measure on the 2022 General Election ballot.

Kevin Evenson appeared for discussion relative to the Notice of Public Nuisance and demand for abatement received from States Attorney Joseph M. Hanson. The Notice directs Kevin Evenson to remove and abate the nuisance existing on his property located on 8080 Highway 83 South, Linton, ND within 30 days of receipt of the Notice, which is April 18, 2022. Kevin asked the Commission for an extension to allow him time to burn as the garbage is currently frozen to the ground, and needs extra time to move stuff. After further discussion, Commissioner Hulm motioned to extend the deadline to May 1, 2022 for Kevin Evenson to bring the property in compliance. If the property is not in compliance by May 1, 2022, the county will move forward to clean up the nuisance and assess the costs against the property. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned authorizing the Chairman and County Auditor to sign the Quit Claim Deeds conveying the county's interest for the right-of ways on Old Highway 83. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

VA Officer, Jeff Ohlhauser, appeared and gave a quarterly activity report.

Commissioner Weichel motioned to approve the building permit for Malvin Wynveen to erect a 20 X 36 addition and remodeling to the residence on 20.18 A Tract in the SE ¼ SE ¼ of Section 26, Township 131, Range 76. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Kalberer motioned to approve the Plat for Auditor Lot A of Gov't Lot 4, Section 2, Township 136, Range 78. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Hulm motioned to grant a raffle permit to the Linton Senior Citizens Club. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the building permit for Brent Boltz to install a 12 X 16 deck onto the mobile home on Lot 9, Coyote Hills Subdivision, Section 23, Township 132, Range 79. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Hulm motioned to approve the building permit for Casey Olheiser/Legendary Homes, Inc., owner Alex Deis, to erect a 47 X 76 home with a 36 X 51 attached garage on the NW ¼ of Section 7, Township 133, Range 76. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the Plat for Lot 1 of Auditor's Lot 14C of the N ½ of Section 14, Township 132, Range 79. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Kalberer motioned to approve the building permit for Chris Scouten to erect a 30 X 50 home with a 50 X 60 attached garage on the SW ¼ of Section 17, Township 135, Range 78. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Weichel motioned to approve the building permit for Kayle Grinsteinner to install a retaining wall 16' from the north property line, adjacent to the existing camper spots, on Lot 204 of Beaver Bay Walther Scenic Properties, Section 23, Township 132, Range 79. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the building permit for Craig Svalen to move a 16 X 80 mobile home on Lot 30, Glenwood Acres, Section 27, Township 132, Range 79. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Kalberer motioned to approve the building permit for Teddy Bossert to add a 26 X 28 addition onto the existing home located in Tract 330 X 170, Section 33, Township 132, Range 79. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Hulm motioned to approve the application for abatement or refund of taxes for parcel #30-8006-143-000 for tax year 2022. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Weichel motioned to table the Raffle Permit for Grayla Foundation, pending further information. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried. Note: the permit application was acted on again later in the meeting.

Commissioner Kalberer motioned to approve the Plat for Auditor's Lot A in the N1/2 of Section 24, Township 134, Range 79 West of the Fifth Principal Meridian. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

The board recessed for lunch and reconvened at 1:00 P.M.

Skyler Prellwitz, Road Superintendent, reported on activities for the county road department.

Cole Reamann appeared to request a culvert on the intersection of 16th Avenue SE and 63rd St. SE. Skyler Prellwitz will consult with Michael Rivinius, Engineer for Wold Engineering, P.C.

Loren VanderVorste was present and provided photos of county roads that need maintenance and repair, including roads that became narrow over the years. Loren also presented photos of a culvert that was placed beside a road years ago, but was never installed. After some discussion, the Commission concluded to consult with Wold Engineering, P.C. to see what size culvert would be needed for the road located in-between Sections 35 and 36, Township 129.

Thomas Schaeftbauer appeared to discuss his building permit application for removing two (2) old grain bins and putting up one (1) new grain bin in the same location on the NE corner of Section 14, Township 130, Range 76. Schaeftbauer's grain bins are setback 75 feet from the road centerline. According to the Emmons County Zoning Ordinance, the minimum setback from the centerline on all minor county and township roads is 100 feet in agricultural zoning district. After discussion, Commissioner Eberle motioned to grant a variance and exception from the minimum setbacks of Article IX (B)(1) of the Emmons County Zoning Ordinance allowing the current location of the grain bin to be constructed in the NE corner of Section 14, Township 130, Range 76, and to approve the building permit for Thomas Schaeftbauer to remove the two (2) old grain bins and put up one (1) new 30 X 30 grain bin at such location. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Kalberer and Magrum. "NO": Hulm and Weichel. Motion carried.

Danielle Stoppler re-appeared for further discussion regarding safety maintenance to the road on 14th Avenue SE, between Sections 4 & 5 and 8 & 9, Township 132, Range 75. No action was taken.

Danielle Stoppler also voiced concerns with the commission violating North Dakota Century Code (44-04-09) and Emmons County Employee policy regarding nepotism. She also voiced concerns in regards to the lack of consistency in pre-employment background checks, the rate at which employees are getting raises, having county meetings recorded or streamed live to ensure accuracy in minutes, and the volume of regular business being handled during special meetings.

Larry J. Smith, SES, Geomatics, and David Moch appeared for surveying land in the county relative to the Summit Carbon Solutions CO2 pipeline being proposed. Larry J. Smith provided copies from Chapter 8 (Surveys) from the Manual of Practice for land surveying in North Dakota and suggested that the landowners request that Summit Carbon Solutions follow the North Dakota Century Code for surveying. Pipeline surveys are a servitude and encumbrance of the use of real property and fall into the requirements of easements outlined in NDCC 47-05-02.1, and must be properly surveyed and described. David Moch requested that the Emmons County Commission support the North Dakota Century Code and Manual of Practice for Surveys in ND as it relates to the Summit Pipeline easements, and all easements will be prepared by a Professional Surveyor register in the State of ND.

Commissioner Hulm motioned to approve the Road Maintenance Agreement between Campbell Township and Emmons County for the following services:

Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Kalberer motioned to approve the Utility Permits for Leo Ohlhauser to install waterlines for cattle pasture in Section 2, Township 134, Range 78, crossing the road to Section 35, Township 135, Range 78 and in Section 4, Township 134, Range 78 crossing the road to Section 3, Township 134, Range 78. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Eberle motioned to approve the Utility Permit for Sea View Farm LLP to install and maintain facilities on the county right-of-way on 89th St. SW and 10th Ave SW. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Commissioner Hulm motioned to approve the Utility Permit for KEM Electric Cooperative, Inc. to install 1/0 260 mil 25kv jacketed cable from the intersection of 19th Ave SE and 90th St. SE travel south 1,350 feet on 19th Ave SE boring from east to west and to install 3-1/0 260 mil 25kv jacketed cable at the intersection of 9th Ave SW and 89th St. SW boring diagonally NW across the intersection. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Emily Leier, County Extension, provided a quarterly narrative report.

Representatives from Wanrack telephoned into the meeting to explain their process for applying for federal and state funding programs.

Michelle Masset appeared on behalf of the Thrift Store. Experienced Works changed their name to National Experienced Workforce Solutions and now requires a full-time person to assist the Experienced Works employee. Michelle asked if the county would consider hiring a supervisor for the Thrift Store. Commissioner Hulm suggested that Michelle communicate with Sharon Jangula, LIDC, to see if any programs would be available.

There was some discussion in regards to adjusting the courthouse hours. Further discussion will be held at the May meeting.

The Commission agreed to put the no truck signs and speed limit signs back up on 9th Avenue SE between 88th St. SE and 89th St. SE. Present for discussion was Dan Materi.

Jay Volk and Joey Borracci, Representatives of Summit Carbon Solutions, appeared to introduce a proposed CO2 pipeline that will route approximately 303.82 miles in North Dakota which includes 36.43 miles of anticipated pipeline in Emmons County. Summit is partnering with over 30 ethanol plants across the states of Iowa, Minnesota, Nebraska, North Dakota and South Dakota to build a carbon capture and storage project. Carbon dioxide from the ethanol plants would be transported through a 2,000-mile pipeline network to North Dakota, where it would be permanently stored in underground rock formations. Summit will be holding a meeting with the landowners in the near future at the Hazelton Community Center.

Commissioner Eberle motioned to enter into a funding agreement for the 2023-2025 biennium to receive reimbursement for providing clerk of district court services. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

At this time the board reached out to Kelsie Burza regarding the Raffle Permit for Grayla Foundation. Kelsie explained that the Grayla Foundation helps the youth up to the age of 18 with health expenses, community events and school supplies. The Foundation also holds a bike raffle at Easter and also purchases Christmas presents for children ages 1-8 in Emmons, Burleigh and Morton counties. Following the phone conversation, Commissioner Hulm motioned to grant a raffle permit to the Grayla Foundation. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer, Magrum and Weichel. Motion carried.

Chairman Erin Magrum called the meeting to order at 9:00 A.M., with Commissioners Don Eberle and Leonard Weichel being present and Commissioners David Kalberer and Gary Hulm via telephone. Also present was States Attorney Joseph M. Hanson.

The Pledge of Allegiance was recited.

Mark Ficker appeared and stated that water is over the road leading to his property at W 363' of W1/2 SW ¼ of Section 28, Township 130, Range 75. The Commission concurred that the county allows landowners to use and improve section lines; but the county is not in the business to build roads. Mark Ficker will have the land surveyed and coordinate with Dan Carr.

Bob Bauman telephoned into the meeting to discuss rip rapping the road/section line on 88th Street SE and 16th Ave SE. According to elevation shots performed by Wold Engineering, P.C., the access road should be raised approximately 4.5 feet in elevation. Also, it was suggested that a 404 permit be obtained prior to any construction.

Previously, Russ Lawler, LLC submitted an estimate for rip rapping the road where the county's share of the project would be \$28,000.00. Road Superintendent, Francis Krumm, presented an estimate of \$13,520.00 for rip rapping the 400' on the west side of the road and graveling 400' of the section line for an additional cost of \$5,675.00 if the road department does the work.


Commissioner Hulm motioned to hire Russ Lawler, LLC to rip rap the road for a county cost of \$28,000.00. Seconded by Commissioner Weichel. Further discussion was held including a 404 study, clean rock versus dirty rock, having an engineer monitor the project, and releasing the county from future repairs to the road. After discussion, a roll call vote was taken as follows: "YES": Kalberer. "NO": Eberle, Hulm, Weichel and Magrum. Motion failed.

Commissioner Hulm motioned to have the county road department rip rap 400' on the west side of the road, apply 2 inches of gravel, obtain the proper permits, and include an amendment releasing the county from future repairs on both the east side of the road and the section line. Seconded by Commissioner Weichel. Further discussion was held with Commissioner Eberle motioning to amend the previous motion to include that a road use and road maintenance agreement, releasing liability to the county for any future repairs to the road on 88th Street SE and 16th Ave SE, by and between Emmons County and Florian Bauman be executed. Seconded by Commissioner Weichel. Roll Call "YES": Eberle, Hulm, Kalberer, Weichel and Magrum. Motion carried. A roll call vote was taken for the previous motion to include the amendment as follows: "YES": Eberle, Hulm, Kalberer and Weichel. "NO": Magrum. Motion carried.

The Commission reviewed a Permitted Encroachment Policy presented by Chairman Erin Magrum. Further discussion will be held at the next meeting.

There being no further business before the board, Commissioner Eberle motioned to adjourn. The meeting adjourned at 10:30 A.M.

The Pledge of Allegiance was recited.

The February, 2022 end of month fund balance report and the year to date expenditure report were distributed to the board.

Commissioner Eberle motioned to approve the minutes of the February 1, 2022 regular meeting and the February 9, 2022 and February 22, 2022 special meetings. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

Commissioner Kalberer motioned to approve the agenda for this meeting. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

Old and Unfinished Business:

Commissioner Eberle motioned to approve the building permit for Clint Saylor to erect a 24 X 25 steel building on Lot 13, Coyote Hills, Section 23, Township 132, Range 79. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

New Business:

Commissioner Hulm motioned to table the Plat of Lot 1 of Auditor's Lot 14A of the NW ¼ NE ¼ of Section 14, Township 132, Range 79. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

Commissioner Hulm motioned to grant a raffle permit to the Emmons County 4-H Council. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

Commissioner Hulm motioned to approve the Plat of the NW ¼ NE ¼ of Section 34, Township 133, Range 74 of the 5th Principal Meridian. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

Commissioner Hulm motioned to approve the building permit for the City of Strasburg to construct a new wastewater treatment, new sanitary sewer, force main, lift station modifications, aggregate road and miscellaneous other work. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

Commissioner Hulm motioned to approve the Plat of Lot 1 of Tract G of the NW ¼ of Section 17, Township 132, Range 76. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

Commissioner Eberle motioned to approve the building permit for Daniel Vetter to erect a 30 X 50 Ag Shop on Section 14, Township 132, Range 74. Seconded by Commissioner Hulm. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

Commissioner Eberle motioned to approve the building permit for Ryan Frank to erect a 30 X 48 post frame building on Beaver Bay Walther Scenic Properties Lakeview IV, Section 23, Township 132, Range 79. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

Commissioner Hulm motioned to approve the building permit for Jack McCrory to concrete a 26 X 56 basement to move on a home and attached garage on Section 2, Township 132, Range 78. Seconded by Commissioner Eberle. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

Commissioner Eberle motioned authorizing Chairman Magrum to execute the Langelier's Bay Annual Management Program, Statement of Receipts and Expenditures for calendar year 2021 and the Annual Management Program and budget for 2022. Seconded by Commissioner Kalberer. Roll Call "YES": Eberle, Hulm, Kalberer and Magrum. Motion carried.

The board reviewed Resolution 22-03-01, regulating mobile homes, Conex boxes and other structures. Also present for discussion was Joe Vetter Jr. and Ken Bitz.

The Resolution amends Article I (I.A.) (3) of the zoning ordinance – single-family dwellings (permanent-type construction) including mobile homes on permanent foundations. An Affidavit of Affixation must be filed within 30 days of affixation on all mobile homes. Mobile homes must be anchored to a permanent foundation, using piers, footings or a basement; any tires, tongues, or hitch must be removed and the structure must be actively connected to basic utilities, including power, water and sewer.

The Resolution also specifically regulates Conex boxes or similar structure by adding provisions to the zoning ordinance to include that “Conex Box” means any cargo container, shipping container, intermodal or freight container, or similar structure, typically used as a tool or storage shed. This section shall be applicable in the Recreation District. Building permits are required for the use or installation of Conex Boxes. Cones Boxes must have a paint color that matches all other structures on the property. If no structures are on the property, the paint color must be white or beige, and must not include lettering. There shall be a limit of one Conex Box per Lot.

Commissioner Eberle motioned to pass the first reading of Resolution 22-03-01 regulating mobile homes, Conex boxes and other structures and schedule a public zoning hearing. Seconded by Commissioner Hulm. Roll Call “YES”: Eberle, Hulm, Kalberer and Magrum. Motion carried.

AJ Tuck, Moore Engineering, Inc. presented preliminary drawings for the road leading to the new Lagoon site in Strasburg.

Clerk of Court/Recorder, Anita Ibach, introduced Kathleen Dosch, newly hired Deputy Recorder, to the Commission.

Pat Feiock, U.S Army Corps of Engineers Natural Resource Specialist, appeared to discuss boating access issues on Lake Oahe due to low water levels. Also present was Sam Renschler and Ken Moser. Pat Feiock stated that given current water levels and projected runoff based on mountain snowpack, it’s likely that Lake Oahe will be five to ten feet lower than the lake elevations experienced in 2021. At these forecasted elevations, boating access at many boat ramps, including the ramp at Langelier’s Bay, will become problematic. The U.S. Army Corp of Engineers identified potential boat ramp sites that will be impacted by lower water levels in 2022, including the site at Langelier’s Bay, and applied for funding to install low water boat ramps. If funding is approved, the low water boat ramp will be located just west of the current ramp at Langelier’s Bay.

The board reviewed the report of recommendations from State Fire and Tornado following an on onsite property survey on December 13, 2021. Commissioner Hulm motioned to increase the valuations on the properties as suggested by State Fire and Tornado and insure the fuel and tanks located in both the Linton and Strasburg county shops. Seconded by Commissioner Kalberer. Roll Call “YES”: Eberle, Hulm, Kalberer and Magrum. Motion carried.

Denise Nieuwsma, Director of Tax Equalization, presented three (3) separate tax parcels that contained errors on Homestead Credit and Veterans Credit applications from previous years. The following motions were made to correct the errors per recommendations by Denise Nieuwsma:

Commissioner Hulm motioned to not do an omitted tax process for parcel #42-000-02095-000. Seconded by Commissioner Eberle. Roll Call “YES”: Eberle, Hulm, Kalberer and Magrum. Motion carried.

Commissioner Eberle motioned to approve the applications for abatement of taxes for parcel #34-0000-02644-000 for tax years 2020 and 2021 and to approve the applications for abatement of taxes for parcel #10-0000-06460-000 for tax years 2020 and 2021. Seconded by Commissioner Kalberer. Roll Call “YES”: Eberle, Hulm, Kalberer and Magrum. Motion carried.

GIS Coordinator, Josh Odden, presented maps for Old Highway 83 Right of Way discussion. States Attorney Joseph M. Hanson will present the deeds at the April meeting.

The board recessed for lunch and reconvened at 1:00 P.M.

Skyler Prellwitz, Road Superintendent, reported on activities for the county road department.

Danielle Stoppler appeared to request maintenance to the road on 14th Avenue SE, between Sections 4 & 5 and 8 & 9, Township 132, Range 75.

Tom Schaeffbauer appeared to inquire about a culvert on the corner of 10th Avenue SE and 93rd St. SE, Township 130, Range 76.

The Commission requested that Joseph M. Hanson send a notice of public nuisance to the owner of the property located on Section 17, Township 132, Range 76, 8080 Highway 83 South, Linton, ND.



These covenants shall run with the land, and the cost of the upkeep and repair referred to above shall be a charge on the land and whatsoever hands it shall be at the time of such improvements.

The Commission concluded that the coyote hill road or smelt lane is a private road and the county has no obligation to maintain or repair the road. States Attorney Joseph M. Hanson will draft a notice and send it to the landowners.


There was some discussion with regards to road encroachment policies.
