PROGRAM: Fly Fishing for Tiger Muskie

Muskies are called "the fish of 10,000 casts." The Tiger Muskie is a hybrid of Northern Pike and Muskie. It is a aggressive predator, that has a long snout filled with sharp teeth, dark tiger stripes on a light body and may grow to 30 pounds or more. Their minimum size limit is 36 inches and the state record is currently 28-1/4 pounds.

Mike Sturza, of Lost Creek Fly Shop, Onalaska, WA is one of a few guides in the area that offers a unique experience of fly fishing Mayfield Lake for Tiger Muskie. Since most Tiger Muskie are caught during the warmer months, Mike Offers guided trips starting around June through late October.

We continue to search for alternative meeting venue locations following a visit to Red Lion for January Board meeting. Pending information from Kenagy next up will be Longview Country Club. Goal for the effort is discovery of a more attractive meeting venue, one that might appeal to a broader audience.

A vote on proposed by-law change has been unanimously passed by the Board. The Board vote is to bring a change in age requirement qualifying for membership in LCFF to the club for discussion and vote. By-Laws require a vote by membership to be taken with 2/3rds yea in order to adopt.

The change is in direct response to the challenge we've been discussing regarding revitalizing LCFF and ensure it lives beyond us. Widening age requirement for membership allows for a larger pool of members, and ability to welcome youth is likely to bring parents as well as seed the future generation. The proposed language change is Article III Membership, Section 1 Qualification; current language reads as follows;

"Any person over 21 years of age, who is a fly-fisher, or desires to become one, is eligible for membership. Before being eligible for membership, the candidate must attend one meeting and pay in advance their annual dues. "

Proposed is to change the language thusly;

"Any person who is interested in fly fishing is eligible for membership. Any prospective member under 18 years of age, needs to be accompanied by a responsible adult. Before being eligible for membership, the candidate must attend one meeting and pay in advance their annual dues. "


Other Board discussions.....

Brian Davern brought the following topics targeting re-invigorating LCFF and attracting new members for Board discussion;

- 1. Offer prizes for participating in club challenges such as first to identify the monthly newsletter "mystery water".
- 2. Publishing member "bios" in the newsletter, feature one member each month.
- 3. Create an LCFF "Facebook" group
- 4. Approach past/prospective member candidates who left the club or chose not to join about repatriating.
- 5. Re-establish a more formal meeting agenda template and hold to it.
- 6. Designate a summer general meeting to be outdoors, establish expectation everyone bring a guest.

Congrats to Buchman, first of several folks who recognized last month's mystery water as Munn Lake. Munn Lake is open year-round, small at 32 acres, and located south of Olympia, just east of the Olympia airport. Managed as a quality water (bait and internal combustion motors are prohibited), Munn lake has catch and release regulations for all species. And there are many species to choose from. Rainbows are featured but a few Browns and several spiny rays, Largemouth Bass, Perch, Bluegill, and Crappie, can be found. In the photos you see there is a boat ramp. Chironomids are a safe bet, smaller wooly buggers catch fish everywhere and standard lake dry patterns can be fun if you time it right.

We stay in the general region this month with a river featuring multiple anadramous species.
