**Town Board Meeting**  
**April 25, 2018**

Present: Schwab, Winkler, Yetter, Luecht and Zimmerman.  
Chairperson Schwab called meeting to order at 6:05pm.

**Minutes:**

- **Motion: (Winkler, Yetter) Move to accept Monthly Board Meeting minutes from March 14, 2018 as written. Unanimous Ayes. Carried.**

**Roads/Equipment/Garage:**

- Chairperson provided revised copy of letter to Portage County Highway Committee and Highway Commissioner Nathan Check regarding work on CTH F (Hwy 54-CTH W), re: approaches onto unsurfaced roads and other items.
- The Board indicated that letter would be sent to Highway Commissioner Nathan Check along with members on the Highway Committee.
- Plow Truck #21 repair estimates: V & H Inc.-Body Work-\$4,193.62; Monroe Truck Eq.-side plow-\$6,227.00; Mid-State Truck Service, Inc.-frame work-\$3,263.97. Appraiser indicated that frame on front of truck is bent and would like to have it checked out how bad.
- ATV/UTV Ordinance amended April 11, 2018 was signed with changes from April 11<sup>th</sup> meeting.
- 2018 Road Work: Chairperson Schwab provided a priority list as of February 27<sup>th</sup>, 2018 Roads Meeting minutes, with estimates of cost.
- Supervisor Winkler: Board Members pick out top 5 roads, make list of roads for joint/crack sealing, and look also at hard-surfaced roads.
- Schwab would like to look at PASER rating of 6 and above for joint/crack-sealing priorities.
- Winkler-Juniper Lane stub cleared out need to add gravel to finish, Evergreen Ave. culvert crossing grade, asphalt overlay to complete job from last year.
- Winkler talking to Wood County Commissioner to design Grove (CTH U-300LF), will bring back later with more information.
- Yetter, Winkler- Elm (90<sup>th</sup>-100<sup>th</sup>) agree to add hard rock gravel versus asphalt overlay.
- Winkler- 100<sup>th</sup> St. (Mill-Quarry) do asphalt jobs all together, hope for better prices.
- Buena Vista (CTH F-110<sup>th</sup>) 3 rod road, work with landowners on Buena Vista to remove trees.
- Supervisor Yetter suggested to see if Portage County would ditch out Buena Vista when working on CTH F.
- Synagro, Matt Mielke indicated they will provide \$500.00 worth of gravel for road damage from 2017.
- Yetter questioned if the Town would have 2-3 days of Highway work per month for Jerry Reinwand. Winkler said he could take care of lawn damage from snowplowing now, but couldn't guarantee every month.
