## **Village Clerk Report - Heather Sherman**

- La Salle County board minutes are available to board members who request them.
- Water bills went out last week.
- The minutes of May's meeting were presented and approved. A motion was made by Todd Anderson and 2<sup>nd</sup> by Mike Supan Jr.

## **Treasurer Report - Jessica Bonnell**

- Monthly bills were presented and approved. A motion was made by Mark Zimmer and 2<sup>nd</sup> by Dave Wiesbrock.

## **Police Report - Dave Woolford**

### **Monthly Report**

- 3 stop sign citations and 9 verbal warnings for equipment violations.
- A new radar needs to be purchased.
- There are currently 31 golf carts and side by sides registered in town.
- All ordinance violations have been sent letters or verbally addressed. Follow-ups will be made this week.

## **Water & Sewer/Streets & Alley Report – Jake Summers**

- Flushed dead end water lines.
- Painted street sign polls.
- Another portion of the sidewalk collapsed by the Old Cemetery.
- A motion was made by Mark Zimmer and 2<sup>nd</sup> by Mike Supan Jr. to make an ordinance to move no parking signs from Pontiac St to Wauponis St.
- Summer help (Gage Hoover) is doing good.

- A motion was made by Mark Zimmer and 2<sup>nd</sup> by Dave Wiesbrock to accept Jeff Bumgarner as an employee of the Public Works Dept. He will be starting June 28<sup>th</sup> and have a 90 day probation period.
- Street lights still not fixed on La Salle St. Town & Country have been called several times. Gonna call Ficek Electric to fix them.

### **Engineer's Report - Jack Kusek**

- Equipment for water filter project should be arriving the 1<sup>st</sup> to 2<sup>nd</sup> week of July. A motion was made by Todd Anderson and 2<sup>nd</sup> by Dave Wiesbrock to authorize a payment in the amount of \$12,868.20 to pay for bond, insurance and water meters for the project.
- Two bids were reviewed for the street work around town. A motion was made by Bob Folty and 2<sup>nd</sup> by Mike Supan Jr. to accept the lowest bid from Universal Asphalt & Excavating in the amount of \$60,174.07.
- A couple of the board members will be meeting with the water tower painting company to discuss what can be done to fix the water towers appearance.

- A motion to pass Ordinance #643 Appropriations Ordinance was made by Bob Folty and 2<sup>nd</sup> by Mark Zimmer. A copy is available at the village hall.
