THE TITLE THIS EARTH, IS CHREATED TO USE IS GOG, GOLD OVER GOODNESS. I AM THE CHRIST WHO MUST RETURN (CHRISTMAS). I AM HERE AND LEADING MY EARTHS. I HAVE BEEN LEADING THIS EARTH SINCE JANUARY 1, 2017.

All Uppers and above, Rankings, Peoples, Colored, and other Spectres in this Earth and these Earths, are all Natural Real Flesh and blood. The HIGHEST GOG and The Chreator of this Earth and these Earths, Paulett Angella Hemmings EARTH, is the same Natural Real Flesh and blood and cannot be a spirit. The Devels are spirits and cannot be seen, or touched, so they wear plastic, rubber, tremoline, strings, cables, ectromagnetics, mechanicals, and other forms of coverup effigies (statues) that looks real and natural. ## BANKS, CREDIT CARDS, CREDIT UNIONS, AND OTHER FINANCIAL ORGANIZATIONS

This 16<sup>th</sup> Level Decry can never be disobeyed. If you do, you lose everything immediately and sentence to HELL with many varieties of punishments.

ALL BANKS, CREDIT CARDS, CREDIT UNIONS, AND FINANCIAL ORGANIZATIONS HAVE DISOBEYED COMMANDS IN MY ARTICLES SINCE JANUARY 2017, AND THE DECRYMIUMMIUMMIUM DATED JUNE 12, 2017, SO YOU ARE ALL IN DEFAULT. You are all dried up, and you have no money, you will never, never, never, never, get anymore money because of your default. You will not see any more of my money to be used for your purpose or for any other purpose. You will not be able to get any money from the Treasury. You will not be able to get any more money from my accounts or use any of my money from my accounts ever again. You will not be able to see any more of your production or success in this lifetime. You will not be able to do anymore transactions ever again. You will not be able to offer any more loans to anyone ever again. You will not be able to borrow from anyone or any organizations ever again. You will not be able to walk in your own clothes or shoes ever again. You will never, never, never, see any of your children and family again, because they are all now destitute and penniless. You will not be able to do anymore of your normal responsibilities and chores ever again. You will not be able to see the light of the days or the sun because you are all blind.

- 1. All Banks and financial organizations I have designed, created, and put in this Earth and these Earths can never and must never have Federal, State, City, Town, County, District, Municipal, Republic or government connection or name.
- 2. All Credit Unions can never and must never have Federal, State, City, Town, County, District, Municipal, Republic or government connections or name.
- 3. All Federal, State, City, Town, County, District, Municipal, Republic or government affiliations or name connected to banks and all financial corporations, organizations, firms are mal rule/illegal in this Earth, these Earths, all my Chreations, and all under my Authority.
- 4. All banks, Credit Unions, Credit Cards, and other financial organizations in this Earth are independent of all governments, republics, and states and municipals and all city, towns and all similar organizations. They are not under any guidance, leadership, laws, or understanding with the devel governments, or state, city, town, community, districts, and others similar organizations.
- 5. In the past, the federal governments have taken over the banks, destroyed the banks, put them into insolvency, and causing them not to function under federal laws and mandates.

The federal steals the banks moneys, use the banks moneys, and stopped the banks from making their own moneys in the manner that I designed them to do. The federal then limits the banks by using numbers on the currency, prevents them from replenishing the money stolen, and they caused the banks to charge exorbitant rising fees to customers that are illegal. All mal practice/illegal procedures will put the financial and accounting, decision makers right into the deep of the hell.

- 6. The Federal Deposit of Insurance (FDIC) is illegal. They say they insure a certain amount of money just in case the banks fail. No bank is to fail. All banks are to make money from the frank and mint machines to pay their employees, to pay their expenses, to replenish stolen or lost currency, and to have money on hand for those who want to withdraw when they need to.
- 7. The federal Sylvan man and many other silver ones are the money heist and thieves.
