### RESOLUTION 26-11 CHIPS MONEY WILL BE USED TO REPAIR HARDY ROAD. PURSUANT TO THE PROVISIONS OF SECTION 284 OF THE HIGHWAY LAW, WE AGREE THAT THE MONEYS LEVIED AND COLLECTED FOR THE REPAIR AND IMPROVEMENT OF HIGHWAYS, AND RECEIVED FROM THE STATE FOR THE REPAIR AND IMPROVEMENT OF HIGHWAYS, SHALL BE EXPENDED AS FOLLOWS:

<u>GENERAL REPAIRS</u>. The sum of \$133,875. may be expended for general repairs upon 18.18 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.

<u>IMPROVEMENTS.</u> The following sums will be set aside to be expended for the improvement of town highways.

- On the road commencing at Springfield Road and leading to Hardy Road, a distance of 1.5 miles, there shall be expended not over the sum of \$30,000
- Type- Blacktop Width of travel surface 22' Thickness 1 ½ inches sub-base Blacktop
