**15<sup>th</sup> Annual NH State USBC Championship Tournament**  
**Rules and Regulations**

1. USBC Rules and Regulations will govern this tournament. The Tournament Manager and the Tournament Committee reserves the right to accept or reject all entries and decides all questions and disputes arising in the tournament, except where an appeal is made to USBC for final consideration.
  2. The tournament consists of an Open and Women's Divisions. The team playing strength is four (4) players.
  3. Reserved entries must be received by 3/7 or postmarked by the next post office business day to best guarantee requested date and time. **Re-entries and Walk-ins CASH ONLY subject to lane availability.**
  3. No team or individual will be entitled to a refund after the entry form and fees have been received and dates/times have been assigned. The team captain is responsible for ensuring that all information supplied is correct. NO CONFIRMATION LETTERS will be mailed. **Lineup will be as shown on entry form.**
  4. To be eligible to compete in this tournament you must hold a current USBC membership for a New Hampshire State USBC league. No memberships will be sold during the tournament. All bowlers participating must present a valid 2021-2022 USBC Membership Card or proof there-of upon check-in. **Substitutions must be made prior to scheduled bowling time. Changes in lineup must be made one (1) hour prior to scheduled bowling time.**
  5. Entering Averages: Entrants will use their highest USBC certified league average from the previous 2019-2020 winter/summer seasons based on twenty-one (21) games or their 2020-2021 winter/summer seasons book average, USBC Rule 319a. If neither applies, they will use their current average of 21 games or more as of February 7, 2020. Composite averages equivalent to twenty-one (21) games will be accepted. **Entrants that have no established average will bowl SCRATCH.**
- It is the entrant's responsibility to provide average verification to the Tournament Manager prior to competition. If an entrant's current average based on twenty-one (21) games or more as of February 7, 2022 is ten (10) pins higher than the 2019/2020 or the 2020/2021 winter/summer seasons averages, the entrant will use their current average.
6. It is the bowler's responsibility to verify the accuracy of their average. A bowler shall adjust entering average and submit the adjusted average to the Tournament Manager in accordance with USBC Rule 319e. Failure to use proper average in accordance with USBC Rule 319a shall be cause for disqualification if the submitted average is lower than actual average. If the submitted average is higher, prize winnings will be based on the higher average.
  7. USBC Rule 319c (Re-Rating) will be waived.
  8. This is a Handicap and Scratch Tournament with an optional All Events in the Open and Women's Division Events. Handicap will be 100% of 220.
  9. Re-Entries will be allowed in the **Team and Doubles Events Only, Cash Only**. No more than two (2) bowlers from one (1) team may bowl on another team. Bowlers may enter doubles more than once with different partner. The bowler's first team and double event series will count towards the individuals All Events score.
  10. The prize fund will be returned 100% in each event, 50% Handicap and 50% Scratch. Any entrant qualifying for scratch and handicap awards will be awarded the prize of greater value. **Scratch will prevail.** Prize ratio will be at least one (1) in five (5) entries for Team, at least one (1) in ten (10) for Doubles and Singles and at least one (1) in twenty (20) in All Events in accordance with USBC Rule 306 and 308. High Series All Events inner from the Open/Winner's will receive partial entry fee to the Masters or Queens Tournament.
  11. Entries close March 7, 2022 to best guarantee requested date and time, entry must be postmarked by the next post office business day. **Re-entries and Walk-ins close 30 minutes prior to squad time and are CASH ONLY**, subject to lane availability. No Competitors under the age of 18 are allowed
