Continued Growth and Partnerships

Throughout the past year, we've had a pretty stable and consistent client population in our homes and programs. The Early Childhood Intervention program continues to grow the numbers of little kids accessing those services. As a result, we continue to see the positive benefits of working with children with developmental disabilities or a delay in their development once they transition to the school program. Nearly 75% of them no longer need additional services.

Our adult programs continue to see nearly full capacity in our group homes and during the year we were able to find community employment for a few. We will see this continue to grow a bit over the next few years, especially with the ongoing push at the state level to drastically change the employment opportunities we provide to our clients in our work program.

We were honored to have a large number of volunteers from the Nuclear Waste Partnership come out several times to help us assemble new greenhouse tables. The ones we have been using were at least 30 years old and made of wood and wire mesh. These new aluminum tables should last us just as long and be more durable. We are so grateful for NWP and their employees for helping us with this project.

We also held our first spaghetti dinner fundraiser in the dining hall to raise funds to begin upgrading the cabinets and equipment. With new regulatory requirements we have found it necessary to change out the old wood cabinets and counters with appropriate stainless steel. This is an ongoing project because these new items are much more costly than the wood cabinets. You will begin to see some of these changes over the next year.

We are grateful for all of our donors and supporters who have so generously helped us over the last year and with costs for staffing our clients and programs continuing to grow, we will need ever increasing funds to be able to provide for our clients in the manner you have come to expect at CARC. Thank you for supporting us.



Organizational Highlights

Services Provided

- Case Management Provided to 105 adult individuals through Intermediate Care Placements and State General Fund Placements.
- Provided 24 hour residential services through our Intermediate Care Facilities/Individuals with Intellectual Disabilities (ICF/IID) to 78 individuals throughout the fiscal year.
- Provided Independent living supports to 8 adult individuals throughout the fiscal year.
- Provided Day Support opportunities for 19 adult individuals not served through ICF/IID or Independent Living.

Supported Employment

The Supported Employment program is designed to provide employment services, training, and supports needed to enable individuals to secure, retain, and/or upgrade employment in the community. This includes services through contracted jobs, job carving, and individual placements. At the end of the fiscal year, 23 individuals were receiving employment supports through our Supported Employment program in a variety of settings including individual employment settings, group employment settings and contracted services.

Adult Habilitation

The Adult Habilitation program provides individuals with various enriching activities including volunteer work, recreational activities, community integration and enhancement of natural supports for individuals who are unable to work or no longer choose to work. At the end of the fiscal year, 27 individuals were receiving supports through various options in Adult Habilitation.

Work Services

CARC's Work Services program continues to provide employment opportunities and training in a structured work environment to aid in the development of various vocational skills. Without this program, many of the individuals we serve may not have the opportunity to learn vocational skills in a setting that meets their unique needs.

Grounds and Janitorial

Seventeen individuals were working in the Grounds and Janitorial department at the end of the fiscal year. These individuals learn skills related to general housekeeping and lawn care through maintenance of CARC grounds and facilities.

Dining Hall

The CARC Dining Hall was employing six individuals at the close of the fiscal year. These individuals assist in the preparation of lunch for the various CARC worksites, serving, and clean-up duties as related to meal service.

• Document Destruction Services

Local businesses and residents are able to access our document shredding services run by the individuals we serve. At the end of the fiscal year, eight individuals were employed at Document Destruction.

Country Store and Greenhouses

The Country Store and Greenhouse offered a wide variety of plants for the public to purchase in addition to providing CARC maintained flowerbed/planter contracts to several locations throughout town. 29 individuals were learning various horticulture skills through employment at the Potting Barn, Country Store and Plant Rentals as of the end of the fiscal year.

• Pecos Valley Pecans

12 individuals were employed in the pecan processing plant at the end of the fiscal year. Pecans are harvested from our orchards by our grounds crew. They are well known for their premium quality.

Child Development Services

• Child Development Center

The Child Development Center is a community childcare center that provides services to children between six week and 36 months of age. This fiscal year there were a total of 37 children that accessed childcare services through the center. We are excited to announce that we are pursuing options to expand our services to additional children in the coming fiscal year.

• Early Intervention Program

The Early Intervention Program is designed to increase skills in early age in order to decrease the need for accommodations as the child gets older. Services are provided to children birth to age three who have developmental delays, established conditions or are identified as at risk medically or environmentally. This fiscal year 561 children were assessed for developmental milestones and 438 qualified for ongoing services through our program. We continue to see this program grow as we expand our outreach throughout Eddy County.

CARC Outcomes

CARC continues to look at ways to provide quality service delivery and work toward continual improvement. We use various methods to collect data that measures the effectiveness of our services, including satisfaction questionnaires, objective tracking, input from various stakeholders and regulatory surveys. This information is used to help us improve services, expand service areas, and become a preferred agency in our field. Results of feedback received and services delivery reflect

- 99% of stakeholders are satisfied with services provided by CARC (results include feedback from parents/guardians of children and adults served, participants, and consumers of services provided through Work Services and Supported Employment programs)
- 99% of parents/guardians and community consumers report their willingness to recommend services provided by CARC.
- 97 community contracts were provided through the Work Services Program to provide individuals served with employment opportunities. These included Plant Rental Contracts and Document Destruction Contracts.
- 98% feel that their individual progress plan is helping them move toward their personal vision.
- 88% of individuals in Work Services feel that they are learning skills that will help them get a job in a Supported Employment setting.
- 100% of individuals in the Residential program reported that staff are teaching them what they want to learn to become more independent.
- 100% of individuals in the Supported Employment program stated that they are doing the type of work they want to do.
- 100% of individuals in the Adult Habilitation programs are satisfied with the variety of services and activities offered in the program.
- Individuals served earned \$490,071.69 in wages over the course of the fiscal year through our Work Service employment sites and contract work.
- 82% of children who are transitioning from our Early Intervention to preschool will not need IEPs when entering the school system.
- Early Intervention staff provided 17,804 hours of direct service to children and their families.
- 73% of the children served this fiscal year maintained or decreased their developmental delays based on developmental assessments and evaluations based on developmental skills for their age.
- 26% of all age eligible children in Eddy County received assessments for services through our Early Intervention program and of those 78% received ongoing supports.

Improvements

This year we were able to make several improvements as part of our accessibility and strategic planning process. These projects included:

- Upgrade to the shower rooms at Pritchett Pool—which is accessed by our individuals as well as the public.
- Fresh exterior paint for the healthcare office, administrative office, dining hall and training building on the CARC campus.
- New greenhouse tables that are more durable than the cinderblock tables used in our greenhouses.
- New asphalt drive for entrances to Washington Ranch.
- Replacement of several aged computers and additional computer for expansion of programs
- Replacement of several aged appliances throughout CARC with new energy star options
- Purchase of four new push mowers for the CARC Grounds crew
- Fresh paint, new windows, and several other upgrades/remodels to the CARC Dining Hall.
- Installation of ADA blue button doors at the Country Store and Greenhouse.
- Installation of a sidewalk from the CARC Mini Park restrooms to the drive to aid in better accessibility.
- Purchase of a vehicle for Washington Ranch Camp
- Purchase of a new passenger van for client use.

CARC Farmhouse Bargain Store

The CARC Farmhouse Bargain Store is a thrift store that supports the needs of the individuals served through CARC services. Proceeds from the Bargain Store allowed CARC to purchase a passenger van for client use this fiscal year. We are truly blessed to have such dedicated volunteers to run the store and such a supporting community to provide us with merchandise to resell.

Washington Ranch

Washington Ranch consists of 4000+ acres centrally located near the Carlsbad Caverns and Guadalupe Mountains National Parks. Washington Ranch is a true "Oasis in the Desert." Washington Ranch is open to the public and can be reserved for weddings, family reunions, company retreats, camping and a variety of other get-a-ways. It is the perfect place to relax away from the stress of the city and absorb all that nature has to offer.
